Appling County Street and Drainage Improvements	\$1,000,000	Appling County proposes to use \$1,000,000 in CDBG funds for street and drainage improvements on Manning Williams Road, David Williams Road, Coot Jones Drive, and Gibbs Street. The project will benefit 70 persons, of whom 67 (95.71%) are low –to-moderate persons. The total project cost is \$1,535,887 with \$535.887 in match and leverage.
Arlington, City of Water Improvements	\$901,335	The City of Arlington proposes to use \$901,335 in CDBG funds for citywide water system improvements. The project will benefit 1,105 persons, of whom 890 (80%) are low-to-moderate income persons. The total project cost is \$964,335 with \$63,000 in match and leverage.
Baldwin County Multi-Activity	\$1,250,000	Baldwin County proposes to use \$1,250,000 in CDBG funding to address failing sewer infrastructure in the Marion Street Target Area. The proposed sewer improvements will serve 85 persons, of whom 72 (84%) are low-to-moderate income persons. Additionally, the project will consist of rehabilitating three (3) owner-occupied housing units, which will benefit six (6) persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,642,319 with \$392,319 in leverage.
Barnesville, City of Sewer Improvements	\$1,000,000	The City of Barnesville is requesting \$1,000,000in CDBG funding for water improvements in in the Richardson Street Target Area. The project will benefit 134 residents, of whom 132 (98%) are low-to-moderate income persons. The total project cost is \$1,539,775 with \$539,775 in match and leverage.
Boston, City of Street and Drainage Improvements	\$1,000,000	The City of Boston proposes to use \$1,000,000 in CDBG funds for street and storm drainage improvements on Johnson Street, Garnett Street, and Ruby Street. The project will benefit 37 persons of whom 35 (94.59%) are low-to-moderate income persons. The total project cost is \$1,078,000 with \$78,000 in match and leverage.
Burke County Building Improvements— Recreational Facilities	\$1,000,000	Burke County's proposes to use \$1,000,000 in CDBG funds for renovating and expanding the Burke County Citizens Park Recreation gymnasium. The proposed renovations will benefit 330 members of whom 247 (75%) are low-to-moderate income persons. The total project cost is \$2,084,000 with \$1,084,000 in match and leverage.

Camilla, City of Sewer Improvements	\$1,000,000	The City of Camilla proposes to use \$1,000,000 in CDBG funds for sewer improvements in the Beacon Street area. The project will benefit 201 persons, of whom 187 (93.03%) are low-to-moderate-income persons. The total project cost is \$1,122,362 with \$122,362 in match, leverage, and in-kind services.
Cochran, City of Neighborhood Revitalization	\$930,185	The City of Cochran proposes to use \$930,185 in CDBG funds to address substandard housing conditions throughout the North Cochran Phase 2 CDBG Target Area. The project will consist of the rehabilitation of eight (8) deteriorated owner-occupied housing units and the reconstruction of four (4) dilapidated owner-occupied housing units. This project will benefit 30 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,052,048 with \$121,863 in match and leverage.
Coffee County Street and Drainage Improvements	\$1,000,000	Coffee County proposes to use \$1,000,000 in CDBG funds to address street and drainage improvements located in First and Second Avenue South. The project will benefit 135 persons, of whom 130 (96.3%) are low-to-moderate income persons. The total project cost is \$2,244,690 with \$1,244,690 in match and leverage.
Colquitt County Street and Drainage Improvements	\$1,000,000	Colquitt County proposes to use \$1,000,000 in CDBG funds for street and drainage improvements on Brandi Drive, Saturday Road, and Tompkins Road target areas. The project will benefit 89 persons, of whom 79 (88.7%) are low-to-moderate income persons. The total project cost is \$1,348,658 with \$348,658 in match and leverage.
Colquitt, City of Sewer Improvements	\$1,000,000	The City of Colquitt proposes to use \$1,000,000 in CDBG funds for sewer improvements on First, Sexton, Wilkin, Bush, Carr, and Peter Streets. The project will benefit 71 persons, of which 51 (71.83%) are low-to-moderate income persons. The total project is \$1,088,000 with \$88,000 in cash match and leverage.
Cornelia, City of & Habersham County Water Improvements	\$1,000,000	The City of Cornelia (lead applicant) and Habersham County (coapplicant) propose to use \$1,000,000 in CDBG funds for water improvements in the East Walnut Target Area. This project will benefit 61 persons, of whom 44 (72.13%) are low-to-moderate income persons. The total project cost is \$1,740,000 with \$740,000 in match and leverage.
Damascus, City of Water Improvements	\$300,000	The City of Damascus proposes to use \$300,000 in CDBG funds for city-wide water improvements. The project will benefit 210 persons, of whom 196 (93.33%) are low-to-moderate income persons. The total project cost is \$300,000 with \$13,000 of in-kind leverage.
Decatur County Street and Drainage Improvements	\$982,403	The Decatur County proposes to use \$982,403 in CDBG funds for street and drainage improvements in the Kelly Crossing Subdivision. The project will benefit 65 persons, of whom 62 (95.4%) are low-to-moderate income persons. The total project cost is \$1,082,403 with \$100,000 is match and leverage.

Desoto, City of Water Improvements	\$952,039	The City of DeSoto proposes to use \$952,039 in CDBG funds for water improvements on Bagley Street, Beatty Street, Blacksmith Street, Luke Street, Mill Street, Ferguson Street, Railroad Street, Tarver Street, Vance Street, and Pugh Street. The project will benefit 103 persons, of whom 94 (91.26%) are low-to-moderate income persons. The total project cost is \$1,009,539 with \$57,500 in match and leverage.
Douglas, City of Neighborhood Revitalization	\$877,225	The City of Douglas proposes to use \$877,225 in CDBG funds to address substandard housing conditions in the Pine Street target area. This project will consist of the rehabilitation of six (6) substandard owner-occupied housing units and will benefit 9 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$894,554 with \$17,329 in match and leverage.
Dublin, City of Street and Drainage Improvements	\$939,537	The City of Dublin proposes to use \$939,537 in CDBG funds for street, flood, drainage and sidewalk improvements on West Mary Street. The project will benefit 425 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,092,839 with 153,302 in match and leverage.
Evans County Street and Drainage Improvements	\$1,000,000	Evans County proposes to use \$1,000,000 in CDBG funds for street and drainage improvements in three (3) target areas: Corey Drive, Grovetown Plantation Drive, and Cedar Creek Road. This project will benefit 69 persons, of whom 66 (95.65%) are low-to-moderate income persons. The total project cost is \$1,000,000 with \$181,9971 in match and leverage.
Fargo, City of Water Improvements	\$873,889	The City of Fargo proposes to use \$873,889 in CDBG funds for citywide water system improvements. The project will benefit 254 persons, of whom 195 (76.77%) are low-to-moderate income persons. The total project cost is \$1,610,289 with \$736,400 in cash and leverage.
Folkston, City of Streets and Drainage Improvements	\$590,376	The City of Folkston proposes to use \$590,376 in CDBG funds for street and drainage improvements in the Ed Brown Street target area. This project will benefit 30 persons, of whom 26 (86.6%) are low-to-moderate income persons. The total project cost is \$660,376 with \$70,000 in match and leverage.
Grady County Building Improvements— Community Resource Center	\$1,000,000	Grady County proposes to use \$1,000,000 in CDBG funds for the construction of the Grady County HELP Agency facility. This project will benefit 2,108 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,238,309 with \$238,309 in match and leverage.
Graham, City of Street and Drainage Improvements	\$580,995	The City of Graham proposes to use \$580,995 in CDBG funds for street and drainage improvements on Lake Mayer's Road. This project will benefit a total of 36 individuals, all of whom 100% are low-to-moderate income persons (LMI). The total project cost is \$606,045 with \$25,050 in match and leverage.

Griffin, City of Water Improvements	\$1,000,000	The City of Griffin proposes to use \$1,000,000in CDBG funds for water improvements on Pleasant Avenue, Winona Avenue, Melrose Avenue, Labron Avenue, North 19th Street. The project will benefit 164 persons, of whom 161 (98%) are low-to-moderate income persons. The total project cost is \$1,618,945 with \$618,945 in match and leverage.
Guyton, City of Drainage Improvements	\$1,000.000	The City of Guyton proposes to use \$1,000,000 in CDBG funds for drainage improvements on a portion of 7th Ave, Central Ave, Maple Circle, Anderson Street, Dilmus Jackson Street, Hines Ave., and Samuel Smalls Sr. Ave. The project will benefit 41 persons, of whom 38 (92.7%) are low-to-moderate income persons. The total project cost is \$1,165,601 with \$165,601, in match, leverage and in-kind services.
Hogansville, City of Multi-Infrastructure Improvements	1,000,000	The City of Hogansville proposes to use \$1,000,000 in CDBG funding for sewer and storm drainage improvements in two (2) target areas: Carden Street Area and Green Avenue. The project will benefit 182 residents, of whom 156 (86%) are low-to-moderate income persons. The total project cost is \$1,576,000, with \$576,000 in match and leverage.
Irwin County Street and Drainage Improvements	\$962,184	Irwin County proposes to use \$962,184 in CDBG funds for street and drainage improvements on Meadow Hill Lane and Hancock Lane. The project will benefit 70 persons, of whom 59 (84.29%) are low-to-moderate income persons. The total project cost is \$1,262,184 with \$300,000 in match and leverage.
Jefferson County Building Improvements – Health Center	\$1,000,000	Jefferson County proposes to use \$1,000,000 in CDBG funds for building improvements to the Health Department. The project will benefit 1,385 persons, of whom 985 (71.12%) are low-to-moderate income persons. The total project cost is \$1,349,609 with \$349,609 in match and leverage.
Johnson, County Building Improvements – Boys and Girls Club	\$1,000,000	Johnson County proposes to use \$1,000,000 in CDBG funds for building improvements to the Boys and Girls Club. The project will benefit 55 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,061,000 with \$61,000 in match and leverage.
Lakeland, City of Sewer Improvements	\$1,000,000	The City of Lakeland proposes to use \$1,000,000 in CDBG funds for sewer improvements on S. Murray Street, W. Patten Avenue, E. Howell Drive, W. Main Street, W. Bostick Ave, S. Miller Street. The project will benefit 98 persons, of whom 80 (81.6%) are low-to-moderate income persons. The total project cost is \$1,167,170 with \$167,170 in match and leverage.
Marshallville, City of Water Improvements	\$952,291	The City of Marshallville proposes to use \$952,291 in CDBG funds for water improvements on East Main, South, Niles, Cook, Cherry, Belmont, Market, Plum, and New Town streets. The project will benefit 60 persons, of whom 57 (95%) are low-to-moderate income persons. The total project cost is \$1,009,791 with \$57,500 in match and leverage.

Millen, City of Multi-Activity	\$1,121,294	The City of Millen proposes to use \$1,121,294 in CDBG funds for water, sewer, street, and flood and drainage improvements throughout Phase V of the RAS. This project will benefit 16 persons of whom 16 (100%) are low-to-moderate income persons. Additionally, the City proposes to rehabilitate five (5) owner-occupied housing units, benefiting 13 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,205,478, with \$84,184 in match and leverage.
Montezuma. City of Water Improvements	\$1,000,000	The City of Montezuma proposes to use \$1,000,000 in CDBG funds for water improvements on Ross Street, Lavender Street, Oak Grove Court, East Adams Street, Pearl Street, Ivy Street, Henderson Street, and South Dooly Street. The project will benefit 192 persons, of whom 185 (96.35%) are low-to-moderate income persons. The total project cost is \$1,110,000 with \$110,000 in match and leverage.
Montgomery County Street and Drainage Improvements	\$1,000,000	Montgomery County proposes to use \$1,000,000 in CDBG funds for street and drainage improvements on Hardeman Road, Bowtie Circle and North Old River Road. This project will benefit 42 persons, of whom 100% are low-to-moderate income persons. The total project cost is \$1,047,500 with \$47,500 in match and leverage.
Nahunta, City of Water Improvements	\$950,731	The City of Nahunta proposes to use \$950,731 in CDBG funds for water improvements along Dude Circle, Henry Street, Burton Street, Church Street, Bacon Street, Carter Street, Hall Street, Henry Street, Rainge Street, Williams Street, and Florida Avenue. The project will benefit 187 persons, of whom 171 (91.4%) are low-to-moderate income persons. The total project cost is \$1,061,992 with \$111,261 in match and leverage.
Pineview, City of Neighborhood Revitalization	\$979,924	The City of Pineview proposes to use \$979,924 in CDBG funds to address substandard housing conditions on Bay Street, Hill Street and Dennard Street. The project will consist of the acquisition and clearance of two (2) vacant dilapidated units, the rehabilitation of three (3) owner-occupied housing units, and the reconstruction of five (5) owner-occupied housing units. The project will benefit 21 persons of whom 100% are low-to-moderate income persons. The total project cost is \$995,424, with \$15,500 in match and leverage
Rebecca, City of Neighborhood Revitalization	\$769,298	The City of Rebecca proposes to use \$769,298 in CDBG funds to address substandard housing conditions in the Southeastern section of the City. This project will consist of reconstructing five (5) owner-occupied units and will benefit 15 persons, of whom 100 % are low-to-moderate income persons. The total project cost is \$778,398, with \$9,100 in match and leverage.
Reidsville, City of Sewer Improvements	\$1,000,000	The City of Reidsville proposes to use \$1,000,000 in CDBG funds for sewer improvements on Collins Street, Ohoopee Street, St. Martin Street, Industrial Blvd. The project will benefit 137 persons, of whom 106 (77%) are low-to-moderate income persons. The total project cost is \$1,114,799.00 with \$114,799.00 in match, leverage, and in-kind services.

Reynolds, City of Street and Drainage Improvements	\$1,000,000	The City of Reynolds proposes to use \$1,000,000 in CDBG funds for street and drainage improvements in the Morris Street area. The project will benefit 27 persons, of whom 21 (78%) are low-to-moderate income persons. The total project cost is \$1,070,000 with \$70,000, in match and leverage.
Richland, City of Water Improvements	\$1,000,000	The City of Richland proposes to use \$1,000,000 in CDBG funds for city-wide water improvements. The project will benefit 1,610 persons, of whom 1,135 (70.5%) are low-to-moderate income persons. The total project cost is \$1,100,000 with \$100,000 in match and leverage.
Soperton, City Sewer Improvements	\$1,000,000	The City of Soperton proposes to use \$1,000,000 in CDBG funds for sewer improvements on Arch Street, Keene Drive, N. Second Street, N. Third Street, Pineview Drive, and Varnedo Street. The project will benefit 187 persons, of whom 175 (93.5%) are low-to-moderate income persons. The total project cost is \$1,163,000 with \$163,000 in match, leverage, and in-kind services.
Statesboro, City of Street and Drainage Improvements	\$1,000,000	The City of Statesboro proposes to use \$1,000,000 in CDBG funds for street and drainage improvements on Raymond Street. The project will benefit 131 persons, of whom 100 (76.34%) are low-to-moderate income persons. The total project cost is \$1,500,000 with \$500,000 in match and leverage.
Summerville, City of Sewer Improvements	\$1,000,000	The City of Summerville proposes to use \$1,000,000 in CDBG funds for sewer improvements on Highland Avenue. The project will benefit 25 persons of whom 23 (92%) are low-to-moderate income persons. The total project cost is \$1,108,584 with \$108,584 in match and leverage.
Sumner, City of Water Improvements	\$728,000	The City of Sumner proposes to use \$728,000 in CDBG funds for water improvements. The project will benefit 387 persons, of whom 309 (79.84%) are low-to-moderate income persons. The total project cost is \$763,500 with \$35,500 in match and leverage.
Surrency, City of Street and Drainage Improvements	\$299,706	The City of Surrency proposes to use \$299,706 in CDBG funds for street and drainage improvements on Ross Street, Tillman Street, Dukes Street, and Roberson Street. The project will benefit 17 persons, of whom 15 (88.24%) are low-to-moderate income persons. The total project cost is \$310,706 with \$14,500, in in-kind services.
Sylvania, City of Multi Infrastructure Improvements	\$1,000,000	The City of Sylvania proposes to use \$1,000,000 in CDBG funds for water, sewer, and street improvements on Abram Street, Belle Street, Jule Street, Arnett Street, Rhodes Street, Robbins Street. The project will benefit 63 persons, of whom 51 (80.95%) are low-to-moderate income. The total project cost is \$1,216,151 with \$216,151 in match, leverage and in-kind services.
Talbot County Water Improvements	\$1,000,000	Talbot County proposes to use \$1,000,000 in CDBG Funds for water improvements on Box Springs Drive, Box Springs Spur, Old Box Springs Road and Sparks Road. This project will benefit 103 persons, of whom 101 (98.06%) are low-to-moderate income persons. The

Tallapoosa, City of Water Improvements	\$842,500	The City of Tallapoosa proposes to use \$842,500 in CDBG funds to provide water improvements on Dogwood Circle and Hugh Street This project will benefit 103 persons, of whom 100 (80%) are low to-moderate income persons. The total project cost is \$917,80 with \$75,300 in match and leverage.
Terrell County Street and Drainage Improvements	\$1,000,000	Terrell County proposes to use \$1,000,000 in CDBG funds for street and drainage improvements on Jones Drive, Brick Street, Henri Mitchell Drive and Augusta Street. The project will benefit 111 persons, of whom 104 (93.69%) are low-to-moderate income persons. The total project cost is \$1,143,549 with \$143,549 in match and leverage.
