SUBJECT SFY 2019 ESG, HOPWA, and S+C Support Services/Harm Reduction Awards

DATE July 18, 2018

This memo details SFY19 awards under the Emergency Solutions Grants (ESG), Shelter Plus Care (S+C) Support Services/Harm Reduction, and Housing Opportunity for Persons with AIDS (HOPWA) Programs. The broad purpose of these programs is to deliver housing supports and related services to persons strictly defined as either: (1) “homeless” or “at risk of homelessness,” as defined in federal regulations for the ESG program, as (2) eligible “homeless” persons as defined under the S+C program, or as (3) “eligible persons” (lower income persons with HIV/AIDS) as defined for the HOPWA program.

For this fiscal year, we received 226 requests totaling \$15.1 million. Of the requests, \$8.7 million was awarded to 175 programs. Funding for each award comes from either (1) Federal ESG or HOPWA funds made available to DCA or (2) the State Housing Trust Fund for the Homeless (HTF). A summary follows.
