I have received a letter from Mark Beebe, GA DNR, EPD Watershed Protection Branch. Mr. Beebe is requesting a letter from DCA stating the proposed wastewater treatment facility upgrade in the Tanners Bridge Road area is in accordance with the Barrow County approved service delivery agreement. I am including a copy of his letter for your review.

The project is an upgrade on an existing facility. The service area of this plant is in the southern end of the County below Bethlehem (see star on map). 

Mark Beebe – EPD

Mark is concerned about a proposed water project in Barrow County. It is the upgrading of a wastewater treatment facility in South Barrow County from 500,000 gpd to 5,000,000 gpd. While there is not a problem with the Service Delivery Strategy Consistency, Mark believes that this proposed project does not appear in the Barrow County comprehensive plan so that the proposed project is inconsistent with the County's comprehensive plan. In this situation, Mark will not issue the required permit until the comprehensive plan is consistent with the proposed project. Mark would like DCA to confirm that the plan and project are inconsistent and send a letter to Barrow County. He, in turn, would refuse to issue a permit, until, at a minimum, the County began the plan amendment process in order to bring the plan and project into consistency. I suggested that he send the letter himself. He said that he did not want EPD to be the "bad guy". I told him that is the way it would be no matter who sent the letter because DCA did not have any "teeth" to get them to amend the plan. Only he did with the threat of withholding the required permit. He said he thought it would be better if DCA sent a letter. I asked him if he was familiar with DRIs and that it sounded like this project would cross the threshold that would require that it undergo a review by the RDC. He said he was familiar with DRIs but still insisted that County needs to amend their comprehensive plan. I told him that I would confer with others and get back with him. He said that would be okay but the he would be out of the office Thursday and Friday but that he would be back on Monday. He said that I could leave a message or call him back on Monday. I told him that I would.

After consultation with Rick and Mike:

- I feel that I need more information from Mark about the exact nature of the project and just what he is trying to accomplish by demanding that the comprehensive plan be amended.
- If any action is taken, it needs to include the RDC if only that they be included in any correspondence.
- The correspondence should be between DCA and EPD Contact with Barrow County should be by EPD.
- EPD should make a formal request (email) to DCA to check the Barrow County comp plan for consistency.
- EPD should contact the County about DCA's consistency findings and make any
 appropriate demands to the County based on these findings. This could include a
 directive to amend the plan for consistency before EPD will issue the required permit.
