## JOINT BURKE COUNTY SHORT TERM WORK PROGRAM 2013-2018 OVERVIEW AND PLAN DEVELOPMENT PROCESS


Burke County, Georgia and its municipalities have consistently engaged in joint activities to manage the development and use of land within their jurisdictions. In 2007, Burke County and its municipalities completed the *Burke County Comprehensive Plan 2007-2027*, a jointly-produced document that sketched out the vision for the future of the community. Five years later, many of the plan's recommendations have been implemented. Comprehensive plans prepared in Georgia consistent with the Standard have historically included a strategic planning component called the "short-term work program." Each community's five-year short term work program lists measurable priority projects that will be undertaken throughout the applicable communities' geographic areas consistent with their stated comprehensive plan goals for economic development, housing, community facilities, natural and cultural resources, transportation, land use and more.

The previous short-term work program component for Burke County and its municipalities was to expire in October 2013. In anticipation of this date, the communities of Burke County, Keysville, Midville, Sardis, Vidette and Waynesboro created the *Burke County Joint Short Term Work Program Update 2013-2018* – thereby programming measurable projects that will promote community health and development for the foreseeable future.

The *Burke County Joint Short Term Work Program Update 2013-2018* was prepared by the CSRA Regional Commission (RC) in coordination with authorized representatives of all six participating communities. Short term work program meetings with individual communities began in April 2013 and concluded in June. The planning process for all six communities was conducted concurrently, and all participants were kept informed of the proposed projects, programs, or activities that were being programmed by their counterparts. This work included the production of a Report of Accomplishments and a preliminary draft *Burke County Joint Short Term Work Program Update 2013-2018*. After additional consultation with the participating governments, a joint meeting of all the local governments took place on June 17 in Waynesboro. There, the focus was on discussing the numerous collaborative efforts included in the *Plan* and work program. At this meeting, attended by representatives from Burke County and the municipalities of Keysville, Sardis, Vidette and Waynesboro, decisions were made about several projects that involve cooperation between the county and municipalities.

Following the creation of a final draft *Burke County Joint Short Term Work Program Update 2013-2018*, the documents were provided to the local governments in July 2013 and public hearings scheduled for July and August of 2013. While the development of the updated work programs included joint efforts, each local government submitted and adopted the section of the document pertaining to their own community. This document is a compilation of the six short term work program documents adopted independently by Burke County, Keysville, Midville, Sardis, Vidette and Waynesboro between September 2013 and February 2014. As with the planning process employed to produce the document, all communities adopted their individual short term work program components with the understanding that their action was the endorsement of part of a greater whole.

Note: One Burke County municipality, the City of Girard, did not respond to invitations at multiple points to join the process. This joint document, therefore, does not include a section pertaining to Girard.


