A note on the process

In 2007, Girard took part in the development of the Burke County Comprehensive Plan 2007-2027, a jointly-produced document that sketched out the vision for the future of the community. During the following several years, some of the plan's recommendations have been implemented, while new priorities emerged.

Girard began its efforts to update its Short Term Work Program in 2014, with a major focus being upgrades to the town's water system. The process began with informal conversations with the Central Savannah River Area Regional Commission, which was engaged in assisting with the update.

Formal work took place in July 2014 with discussions and correspondence between Regional Commission and town staff. A town council meeting was devoted to the topic, and a public hearing held after a draft was developed. The town transmitted the update for review in July 2014 and adopted it in August 2014.

While the town did not take part in a joint update process that began in 2013, it remains committed to working with Burke County and other Burke municipalities as needed, and has met with other local governments on an informal basis.
