LETTER of AGREEMENT

Ben Hill County and the City of Fitzgerald, in order to maximize the efficient use of public resources through communication, cooperation and collaboration; hereby authorize their respective staffs to exercise their judgment in exchanging goods and services, as required, for mission accomplishment.

The Ben Hill County Manager and the Fitzgerald Community Development Director, with the concurrence of their respective Chief Financial Officers, are designated oversight and approval authority for implementing this program. A ledger will be maintained, containing relevant details of goods and services provided, and will be reconciled at the end of each fiscal year. Status reports will be provided the Ben Hill County Commission and Fitzgerald City Council as requested.

The City of Fitzgerald agrees to allow its City Marshall/Code Enforcement Officer to enforce Ben Hill County Ordinances, as requested, on a case-reimbursement basis, at a per-hour cost to be jointly determined. Cash reimbursement will be made by Ben Hill County upon receipt of invoice from the City of Fitzgerald. City Marshall Leon Johnson is also designated as the Ben Hill County Dog Control Officer for the purposes of implementing the provisions of Georgia's Responsible Dog Ownership Law; with Fitzgerald Animal Control Officer Steve Smith designated as the Alternate Dog Control Officer.


The City of Fitzgerald agrees to provide Animal Control services in the unincorporated areas of Ben Hill County on an annual fee basis. The fee may include a combination of cash, equipment, and vehicles; with the details being jointly resolved.

The Fitzgerald-Ben Hill Humane Society will host Animal Control operations and provide annual dog licensing services for both Ben Hill County and the City of Fitzgerald. The Humane Society will receive financial supplements from both the City and County; as adopted in their respective annual budgets; and is also authorized to retain the dog licensing fees collected as payment for providing these services.

This agreement takes effect upon signature by both parties; and remains in effect until the other party is notified in writing of intent to amend or cancel. In the event of cancellation, a joint reconciliation will be accomplished within 30-days.

LETTER of AGREEMENT

Ben Hill County and the City of Fitzgerald, in order to maximize the efficient use of public resources through communication, cooperation and collaboration; hereby authorize their respective staffs to exercise their judgment in exchanging goods and services, as required, for mission accomplishment.

The Ben Hill Country Manager and the Fitzgerald Community Development Director, with the concurrence of their respective Chief Financial Officers, are designated oversight and approval authority for implementing this program. A ledger will be maintained, containing relevant details of goods and services provided, and will be reconciled at the end of each fiscal year. Status reports will be provided the Ben Hill County Commission and Fitzgerald City Council as requested.

The City of Fitzgerald agrees to allow its City Marshall/Code Enforcement Officer to enforce Ben Hill County Ordinances, as requested, on a case-reimbursement basis, at a per-hour cost to be jointly determined. Cash reimbursement will be made by Ben Hill County upon receipt of invoice from the City of Fitzgerald. City Marshall Leon Johnson is also designated as the Ben Hill County Dog Control Officer for the purposes of implementing the provisions of Georgia's Responsible Dog Ownership Law; with Fitzgerald Animal Control Officer Steve Smith designated as the Alternate Dog Control Officer.


The City of Fitzgerald agrees to provide Animal Control services in the unincorporated areas of Ben Hill County on an annual fee basis. The fee may include a combination of cash, equipment, and vehicles; with the details being jointly resolved.

The Fitzgerald-Ben Hill Humane Society will host Animal Control operations and provide annual dog licensing services for both Ben Hill County and the City of Fitzgerald. The Humane Society will receive financial supplements from both the City and County; as adopted in their respective annual budgets; and is also authorized to retain the dog licensing fees collected as payment for providing these services.

This agreement takes effect upon signature by both parties; and remains in effect until the other party is notified in writing of intent to amend or cancel. In the event of cancellation, a joint reconciliation will be accomplished within 30-days.

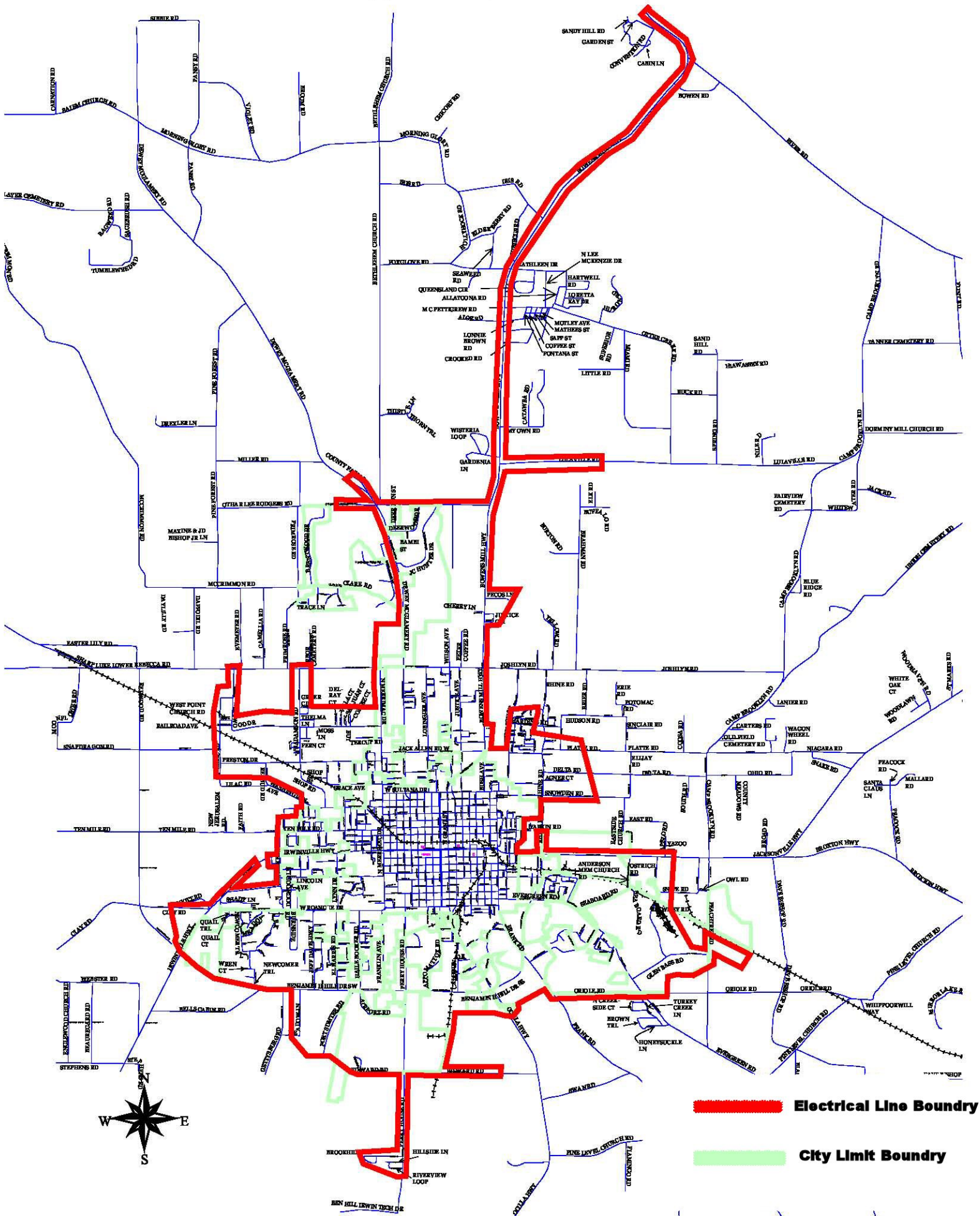

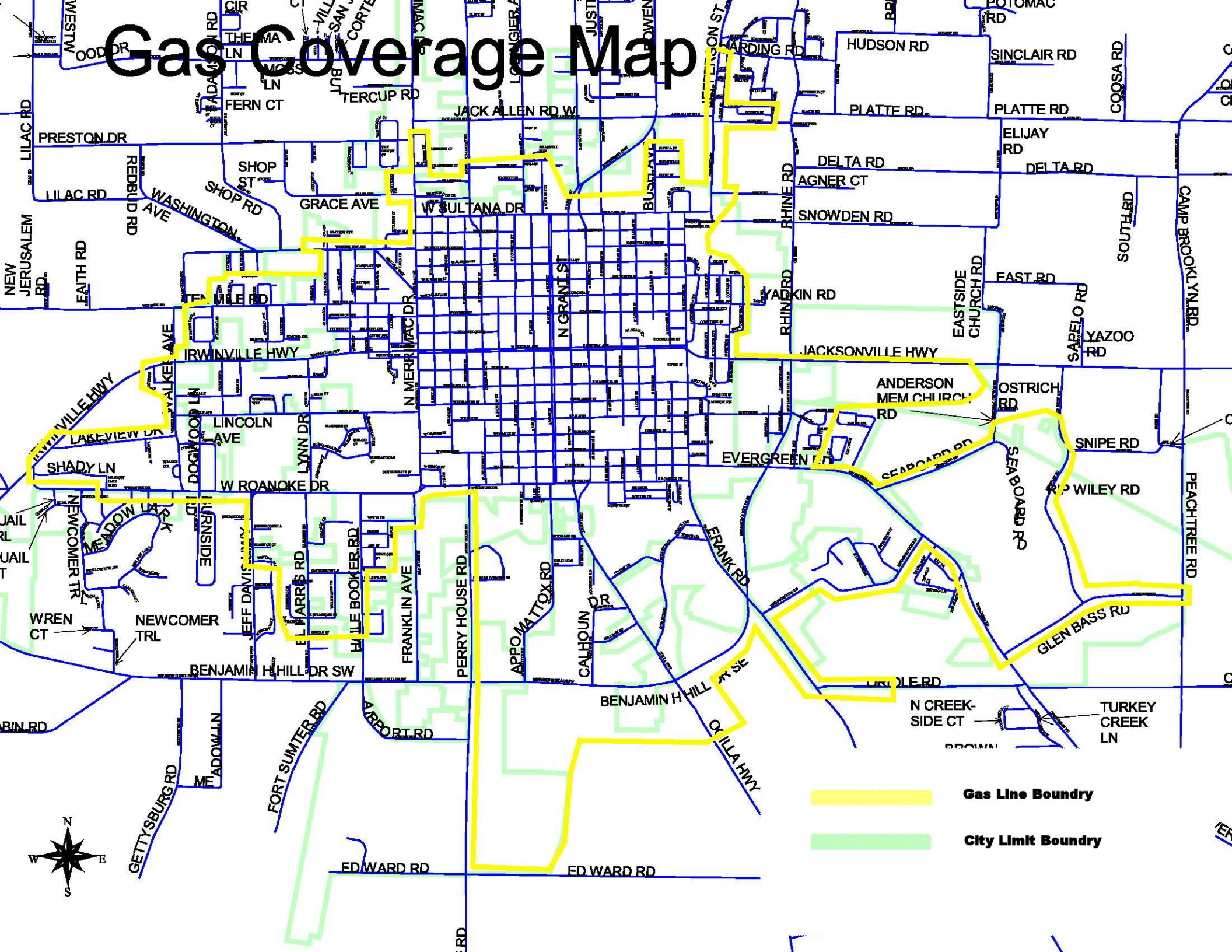

**JAIL CONSTRUCTION AND STAFFING
AGREEMENT**

This agreement, made and entered into this_____, day of _____ 2015, between Ben Hill County, a political subdivision of the State of Georgia (hereinafter referred to as "County"), and the City of Fitzgerald, a municipal corporation chartered under the laws of this state (hereinafter referred to as "Municipality").

WHEREAS, the County and the Municipality desire to enter into an agreement to implement the provisions of the "Jail Construction and Staffing Act" (OCGA 15-21-90, et. seq.).

THEREFORE, BE IT RESOLVED, that in consideration of the mutual benefits flowing from one party to the other, the County and the Municipality agree to the following:

1. Obligations of County.

- a. County shall make its corrections facilities available to the Municipality for the incarceration of its prisoners. For the purpose of this agreement, "Correctional facilities" shall mean the Ben Hill County Jail.
- b. County shall provide normal prisoner maintenance for all prisoners of Municipality incarcerated in the County's correctional facilities. Such normal prisoner maintenance services shall include, but not be limited to, prisoner meals, recreation, medical and dental services while such prisoners are incarcerated in the correctional facilities of County, and such other related incidental prisoner services provided by the correctional facility for prisoners incarcerated in the correctional facilities of County; provided, however, that Municipality agrees to reimburse County, as provided in Paragraph 2 (f) below, for any and all expenses incurred by the County in providing medical or dental services and medication to Municipality's prisoners.
- c. All sums collected and paid over to the governing authority of County, as provided in Paragraph 2 (a), (b), (c) and (d) herein, shall be deposited by County into a special account to be known as the "Ben Hill County Jail Fund."
- d. All moneys collected pursuant to this agreement and placed in the county jail fund shall be expended by the governing authority of County solely and exclusively for constructing, operating, and staffing the jail.

2. Obligations of Municipality.

- a. Municipality agrees that in every case in which courts of the Municipality shall impose a fine, which shall be construed to include costs, for any offense against a criminal or traffic law of this state or any ordinance of Municipality, there shall be imposed as an additional penalty a sum equal to 10 percent of the original fine.
- b. Municipality agrees that at the time of posting bail or bond in any case involving a violation of a criminal or traffic law of this state or any ordinance of Municipality, an additional sum equal to 10 percent of the original amount of bail or bond shall be posted.
- c. Municipality agrees that in every case in which the courts of municipality shall order the forfeiture of bail or bond, the additional sum equal to 10 percent of the original bail or bond shall be paid over to County as provided in Paragraph 2 (d).
- d. Municipality agrees that the sums provided for in Paragraph 2 (a), (b), and (c) shall be assessed and collected by the clerk or court officer of Municipality charged with the duty of collecting moneys from fines and forfeited bonds and shall be paid over to County by the twentieth (20th) day of the following month in which such sums are collected.
- e. Municipality shall deliver its prisoners to designated County correctional facility for booking and/or incarceration. In addition, Municipality agrees to provide all subsequent transportation for Municipality prisoners to and from County's correctional facilities when the attendance of such prisoner is required for any judicial proceeding. In the event the Municipality requests County to provide transportation under this paragraph, the municipality agrees to reimburse County at the rate of \$0.505 per mile and an hourly rate equal to the hourly rate of the lowest paid County correctional facility employee(s) qualified to provide such transportation.
- f. Municipality shall pay an amount such that the sum of the amount provided in paragraph 2 (d) and this amount shall equal \$35 per prisoner per day for its prisoners incarcerated in the correctional facilities of County. In addition to the per diem, Municipality shall reimburse county for any and all expenses incurred by County in providing medical or dental services and medication, or transportation as described in paragraph 2 (e) to Municipality prisoners held by County in its correctional facilities pursuant to the provisions of this agreement. The payment of the sums provided for in this paragraph shall be in addition

to, mutually exclusive of, the sums to be paid by Municipality to County as provided in paragraph 2 (d)

3. Suspension of County's Obligation to Accept Prisoners. County's obligation to accept prisoners of the municipality shall be suspended for such period of time as County is prohibited, pursuant to the order of a court of competent jurisdiction, or from a lack of space for a specific classification of prisoner, or as may be mutually agreed upon by the Sheriff and Police Chief, from accepting prisoners in County's correctional facilities.
4. Termination. Except as provided in paragraph 3, Municipality may terminate this agreement upon County's failure to accept municipality prisoners in accordance with the terms of this agreement. County may terminate this agreement and refuse to accept Municipality prisoners if Municipality fails to remit all moneys due in a timely manner. A party wishing to terminate this agreement pursuant to this paragraph shall give the other party notification in writing, by certified mail, of such termination sixty (60) days prior to such termination. Such written notice shall be mailed; return receipt requested to the Ben Hill County Board of Commissioners, in case of County, and to the Mayor of Fitzgerald, in the case of the Municipality.
5. Time. Time is of the essence in the performance of this agreement.
6. Agreement Period. This contract shall be binding on the parties hereto for the period commencing on the 1st day of January 2016, and ending at midnight on the 31st day of December 2016, except that said contract can automatically be extended for an additional year unless either party cancels and terminates the contract at the end of any contract year; provided notice of such intention to so terminate and cancel shall be given not later than sixty (60) days prior to the end of the contract year. Otherwise, the contract shall remain in full force and effect from year to year.
7. Entire Agreement. This agreement contains all the terms and conditions and represents the entire agreement between the parties and supersedes any preexisting agreements related to the use of the correctional facilities of County by prisoners of Municipality. Any alterations of this agreement shall be invalid unless made by an amendment in writing duly expressed by both parties. There are no understandings, representations, or agreements, written or oral, other than those contained in this agreement.

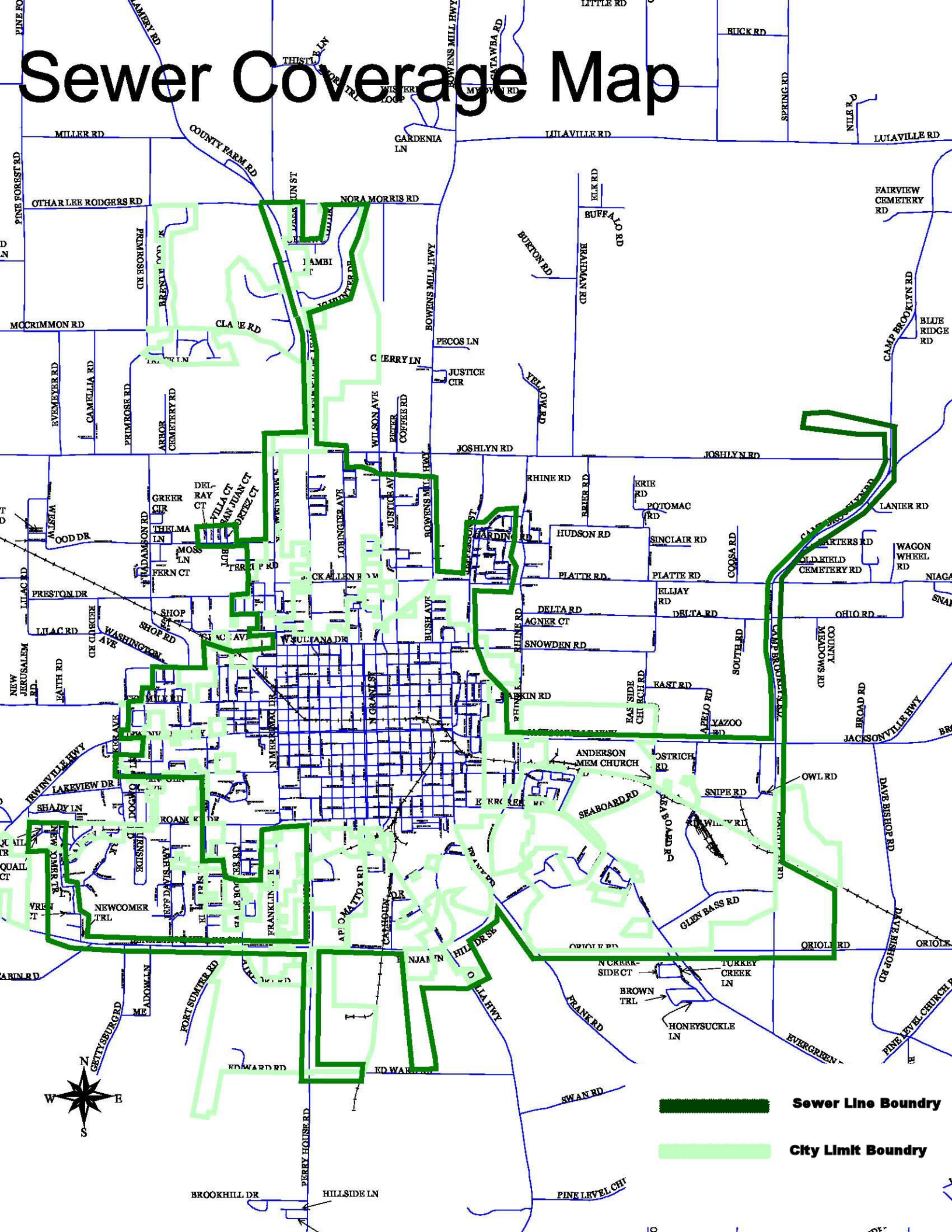

Resolution

BE IT RESOLVED by the Mayor and Council for the City of Fitzgerald, Georgia, acting in meeting duly assembled, that Representative Newt Hudson and Senator Van Streat are hereby requested to introduce legislation in the 1999 Georgia General Assembly, for the creation of a charter commission to prepare, present and sponsor a proposal for the consolidation of the City of Fitzgerald and Ben Hill County, Georgia, with said legislation to include the following provisions:

1. The charter commission shall consists of 27 members, including 10 members to be named by the Mayor and Council of the City of Fitzgerald, 10 members to be named by the Board of Commissioners of Ben Hill County, Georgia, 4 ex-officio members consisting of the Mayor of the City of Fitzgerald, the City Administrator of the City of Fitzgerald, the Chairman of the Board of Commissioners of Ben Hill County, Georgia, and the County Administrator of Ben Hill County, Georgia, and 3 additional members to be selected by the foregoing 24 members.

2. The city attorneys for the City of Fitzgerald and the county attorneys for Ben Hill County, Georgia, shall serve as legal counsel for said charter commission. In addition, the charter commission shall utilize the resources available for any public or private institution or body with respect to the formulation of the charter for the new consolidated government, and with respect to such other services as the charter commission deems appropriate.

3. The local legislation should authorize the charter commission:

a. to prepare a proposed charter for the consolidated governments of Fitzgerald and Ben Hill County, to be submitted upon approval of the governing bodies of the City of Fitzgerald and Ben Hill County, but without further approval of the Georgia General Assembly, to the voters of said city and county.

b. to receive such appropriations as the City of Fitzgerald and Ben Hill County may deem appropriate on a fifty-fifty basis as well as any grants, and to expend said funds for the purposes for which the charter commission is created.

c. on behalf of the City and County, to request and obtain pre-clearance of the proposed consolidation and procedures pertaining to the approval of the same, from the United States Department of Justice and to otherwise comply with the requirements of the voting Rights Act of 1970, as amended.

d. to set the dates of elections in the City of Fitzgerald and in Ben Hill County, Georgia, for the approval or rejection of the proposed consolidation after approval by the City of Fitzgerald and Ben Hill County.

e. to disseminate to the general public information regarding the proposed consolidation, and to engage in such activities as the charter commission deems necessary or appropriate to encourage the adoption of the consolidation proposal.

f. to engage in such other activities as the commission deems necessary or appropriate, in furtherance of the foregoing purposes.

The consolidation, if separately approved by the voters of the City of Fitzgerald and the voters of Ben Hill County, Georgia shall become effective on the first day of January next following such approvals.


