Jones County, City of Gray, Macon Water Authority

City of Macon: The City of Macon was party to the last Service Delivery Strategy within Jones County. In 2014, The City of Macon de-annexed all portions of the former city limits within Jones County. As the City of Macon consolidated with Bibb County, the City of Macon is no longer a service-providing entity within Jones County, as will be indicated in the next SDS update. Under the terms of the legislatively-adopted consolidated charter, "within four years of the effective date of this charter, the restructured government shall adopt a service delivery plan." The City of Macon was not a required signatory on the previous SDS agreement, and will not be a required signatory to the future revised SDS agreement. Therefore, the City of Macon is not included as a signatory to this extension.

2.
