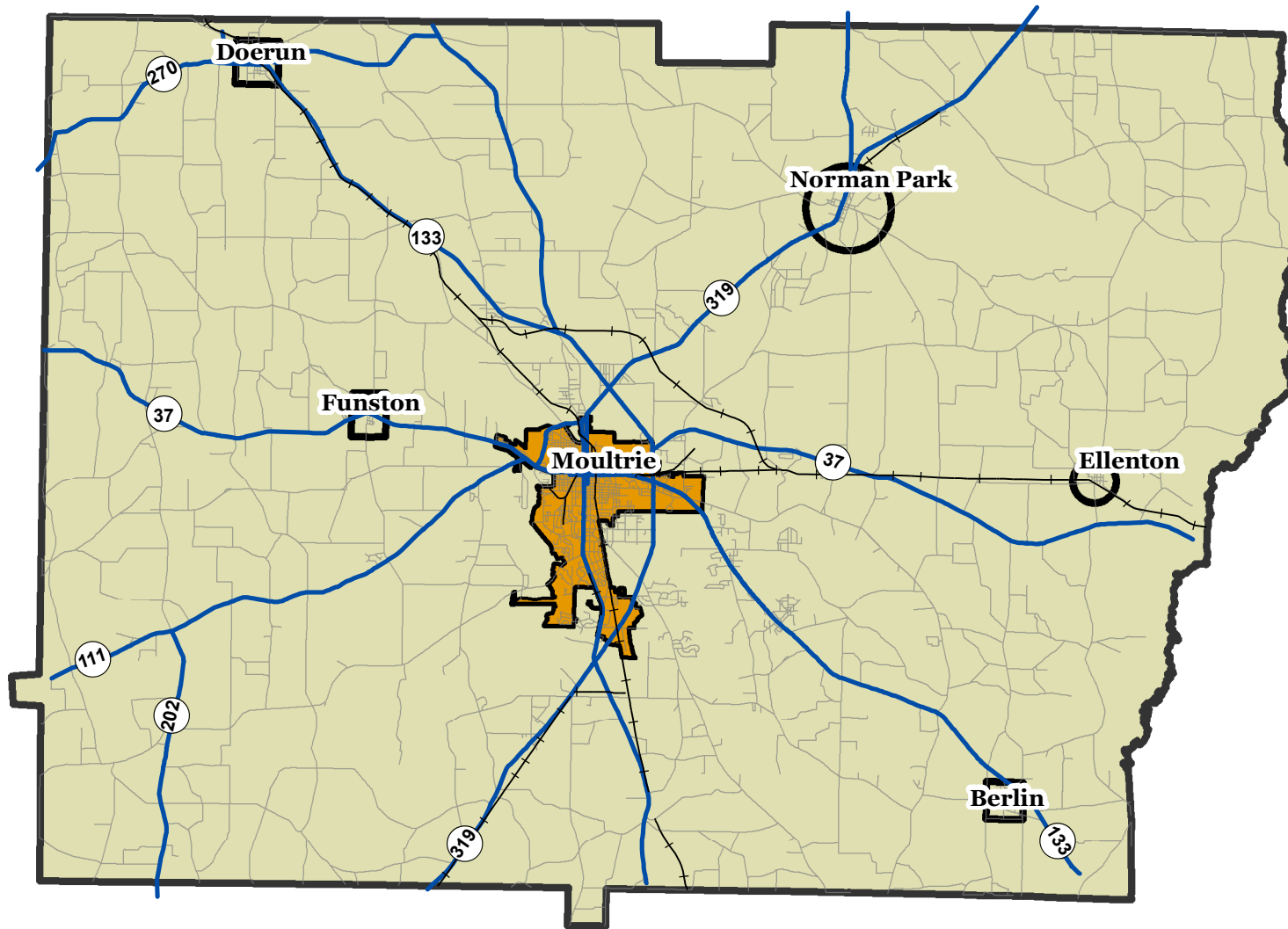



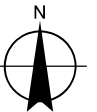
Colquitt County

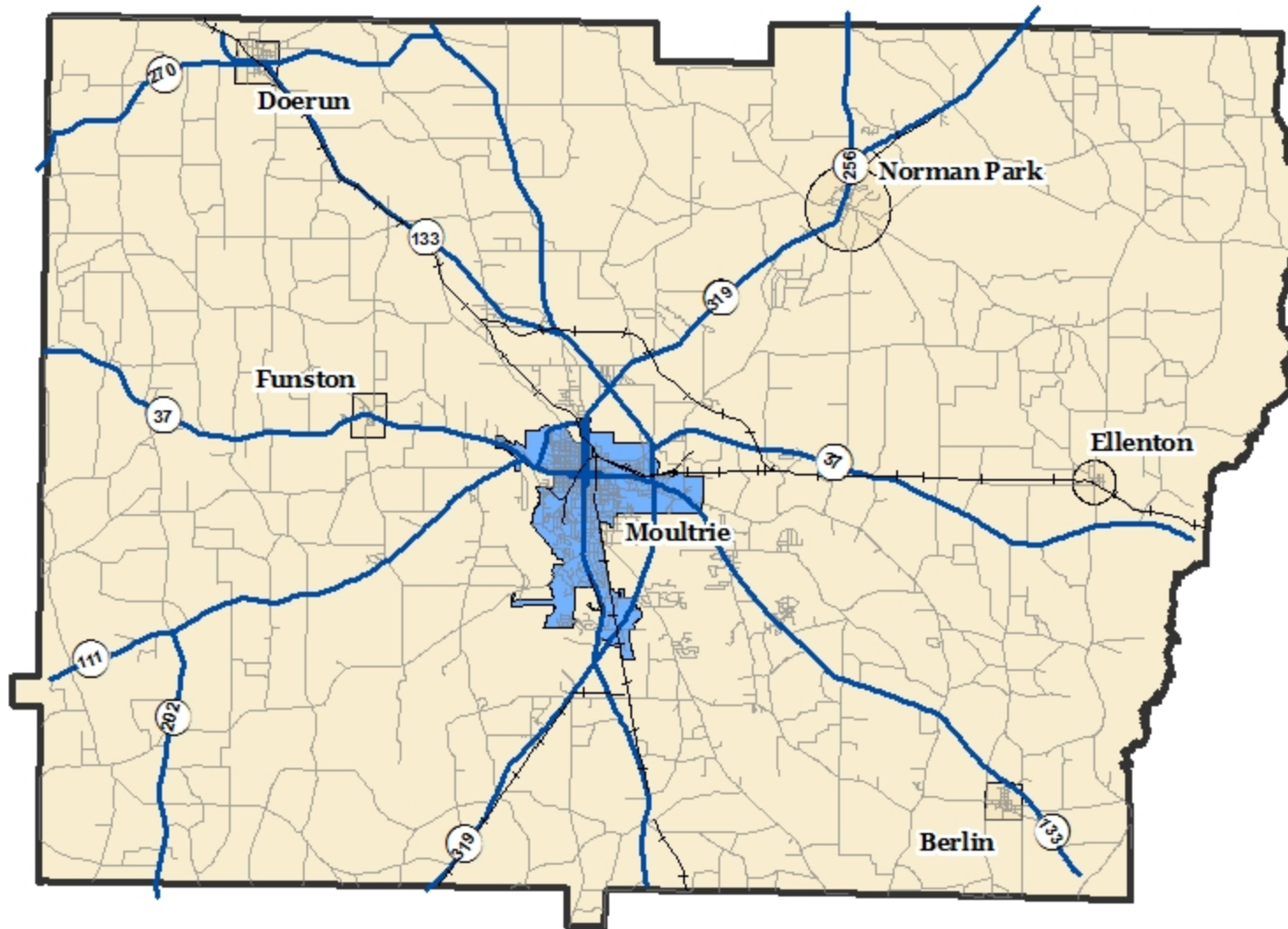

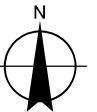

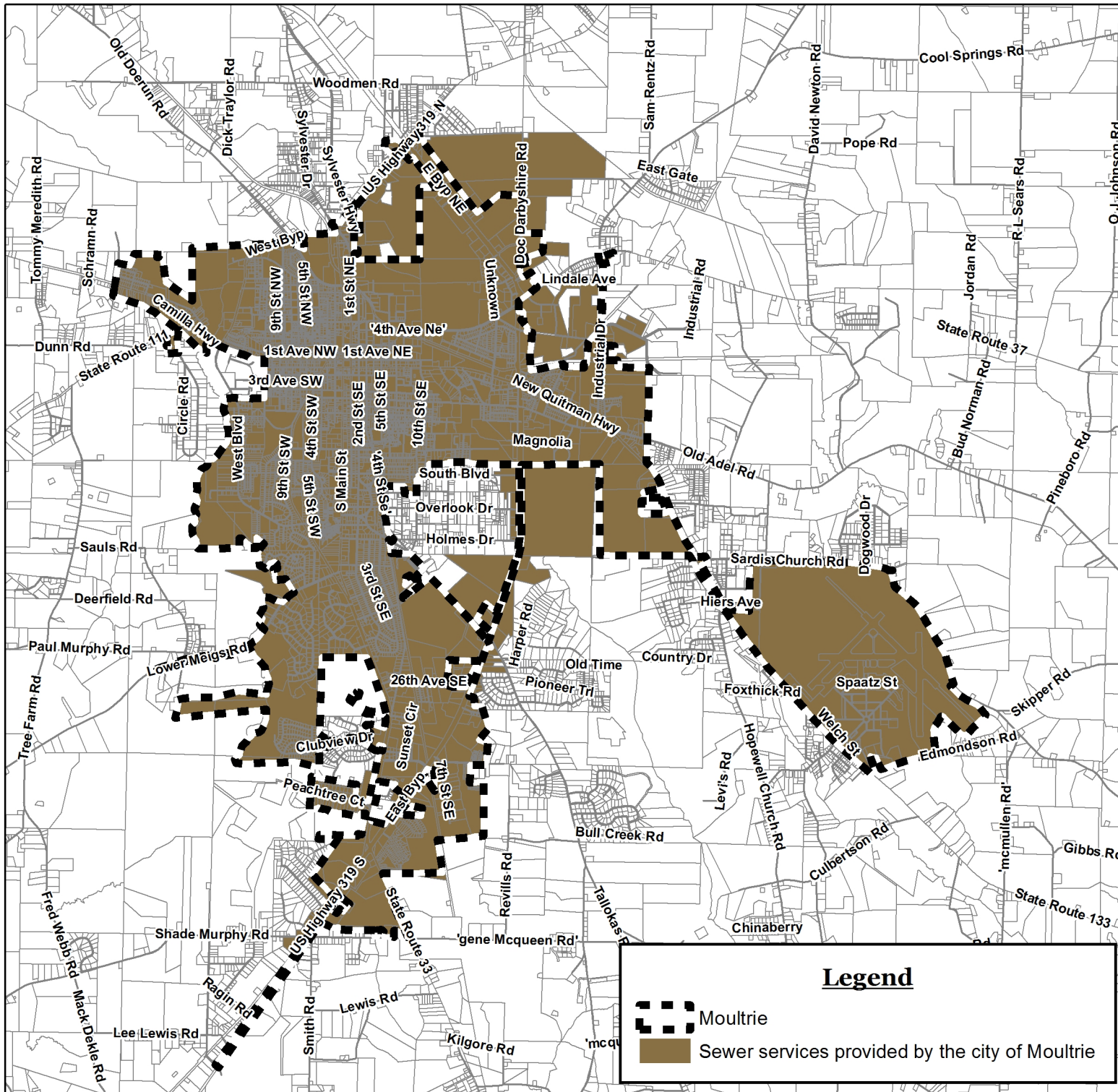

Sewer Service Map





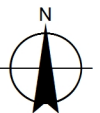

Sewer Service Map



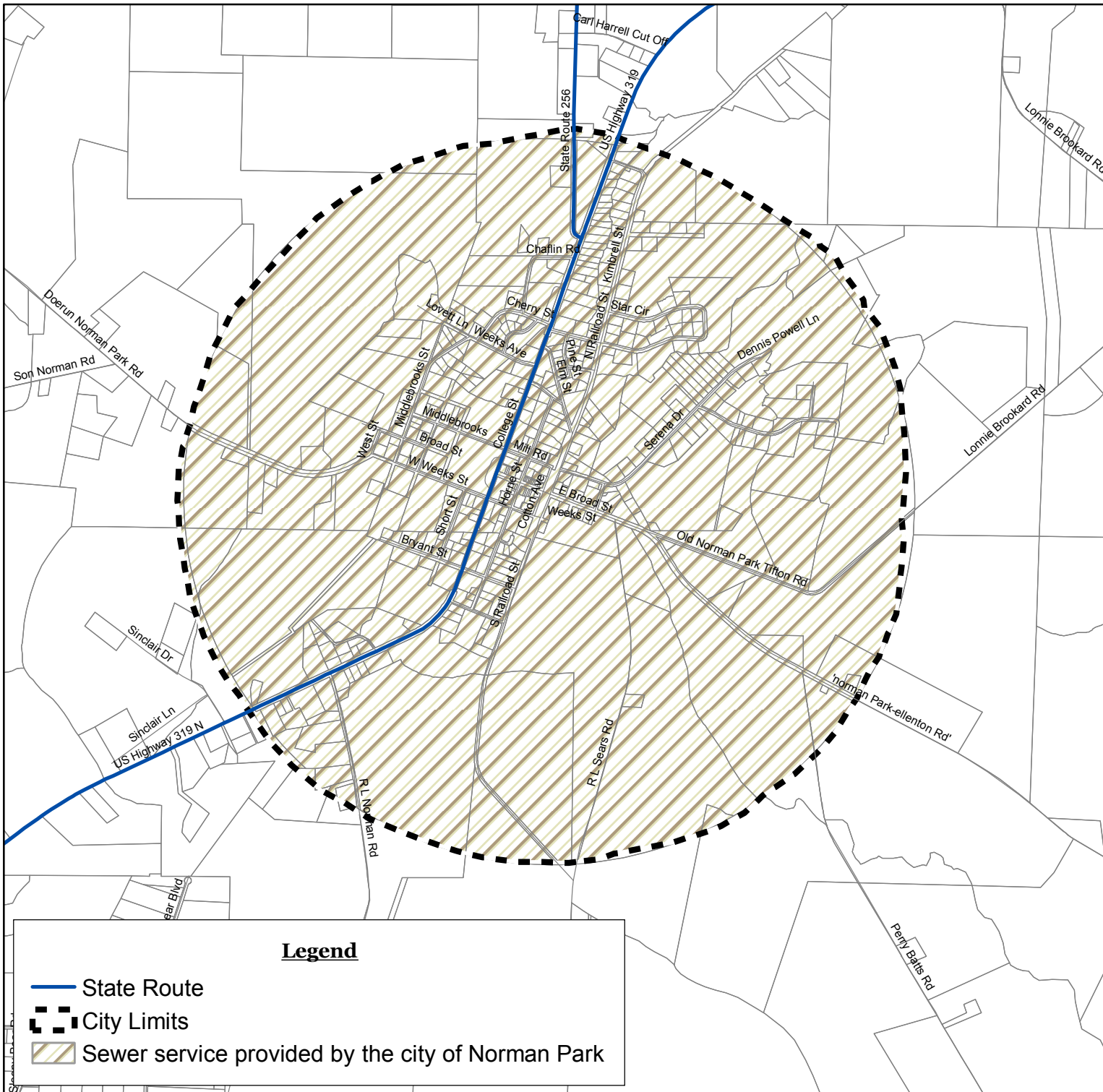

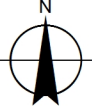

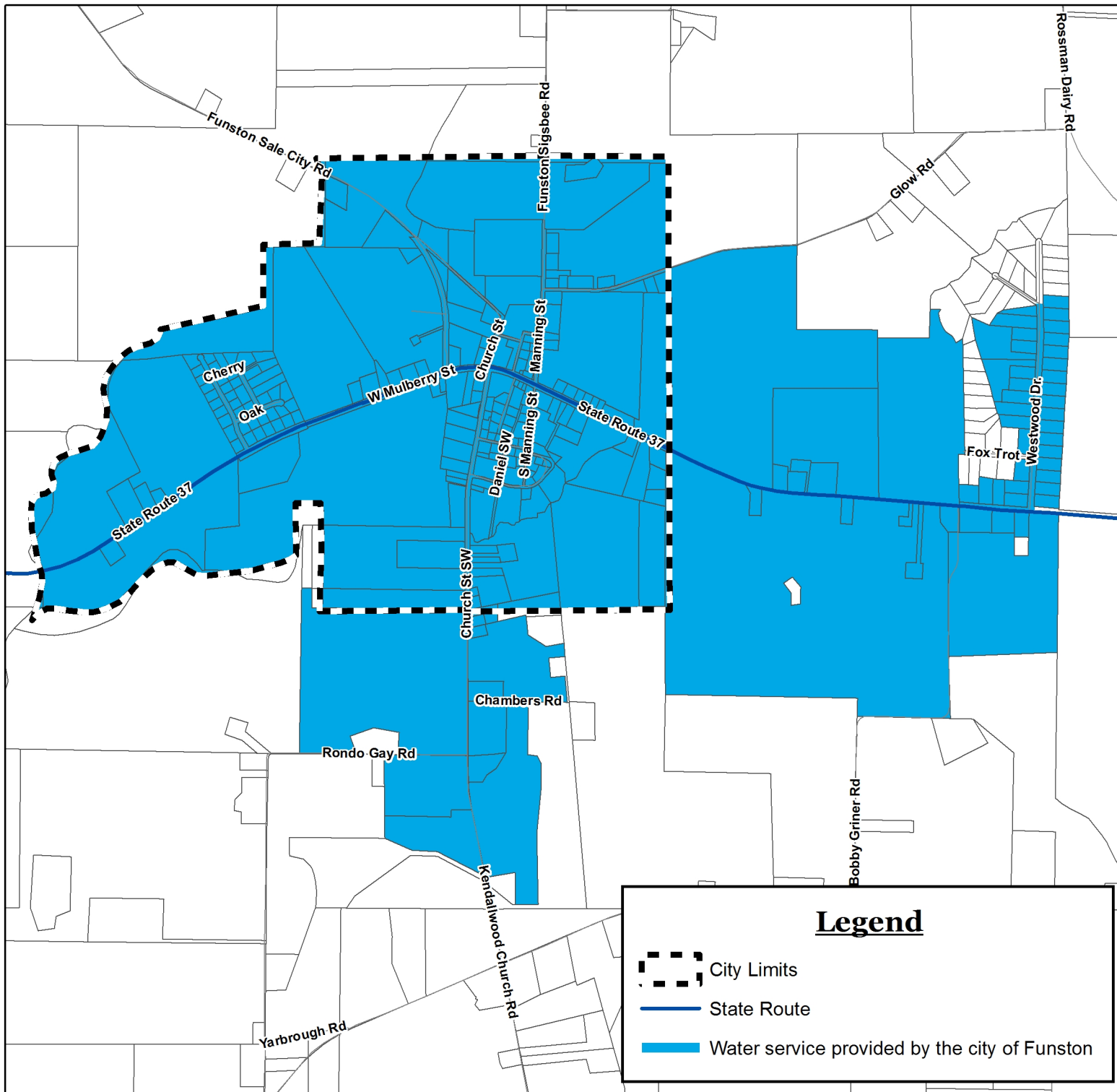

Water Service Map



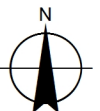
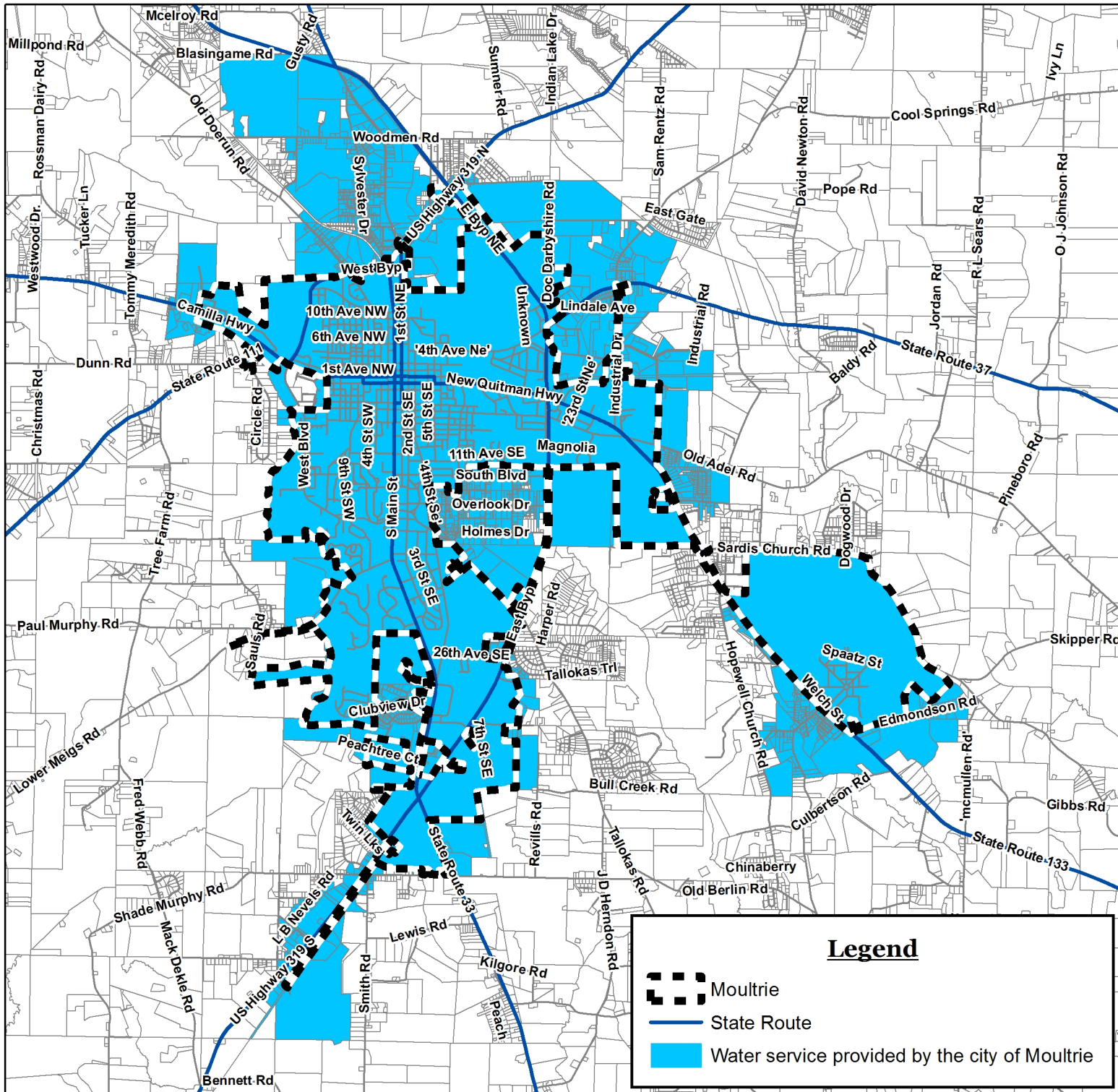

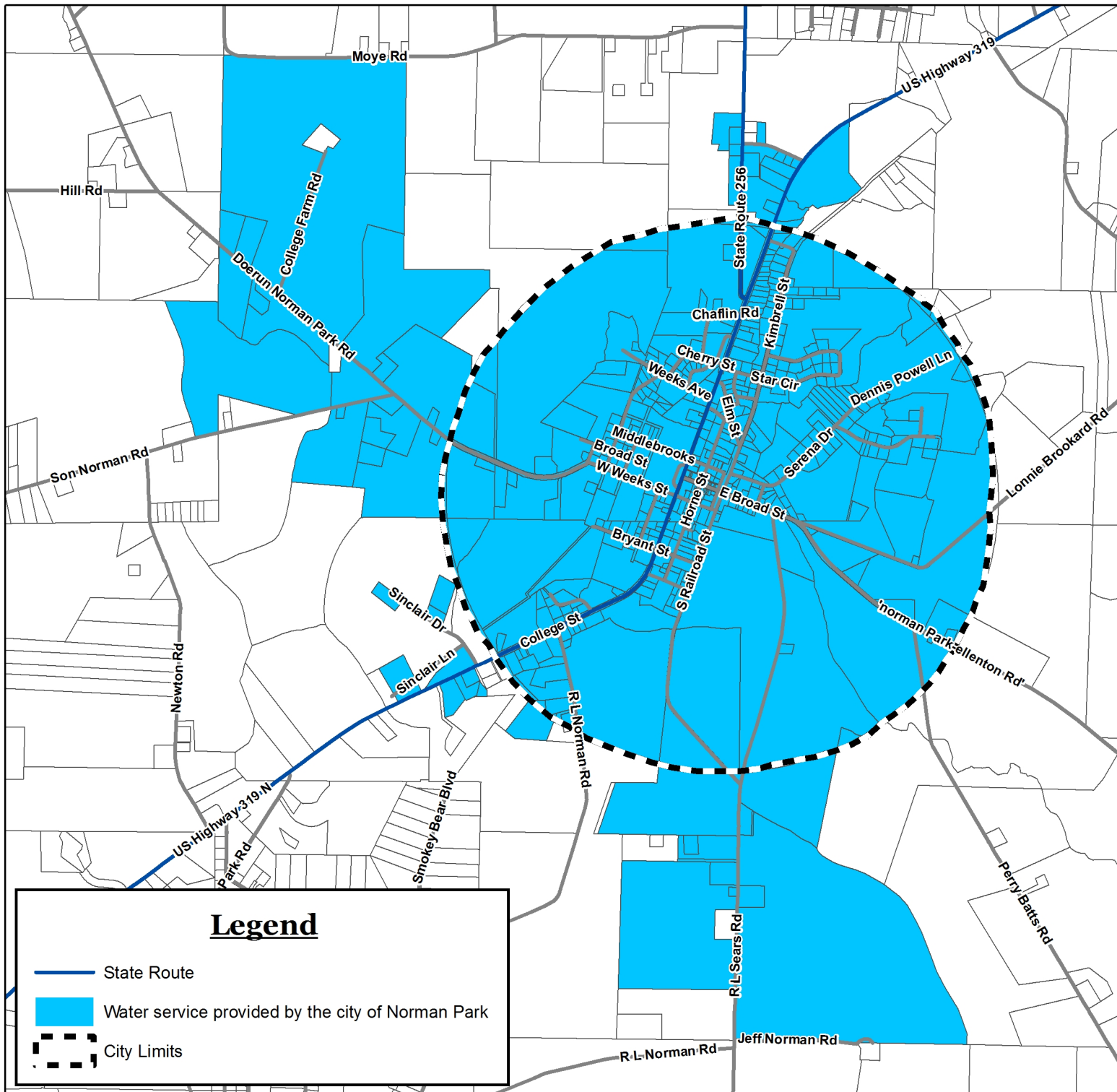

Water Service Map






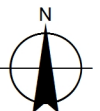

Water Service Map



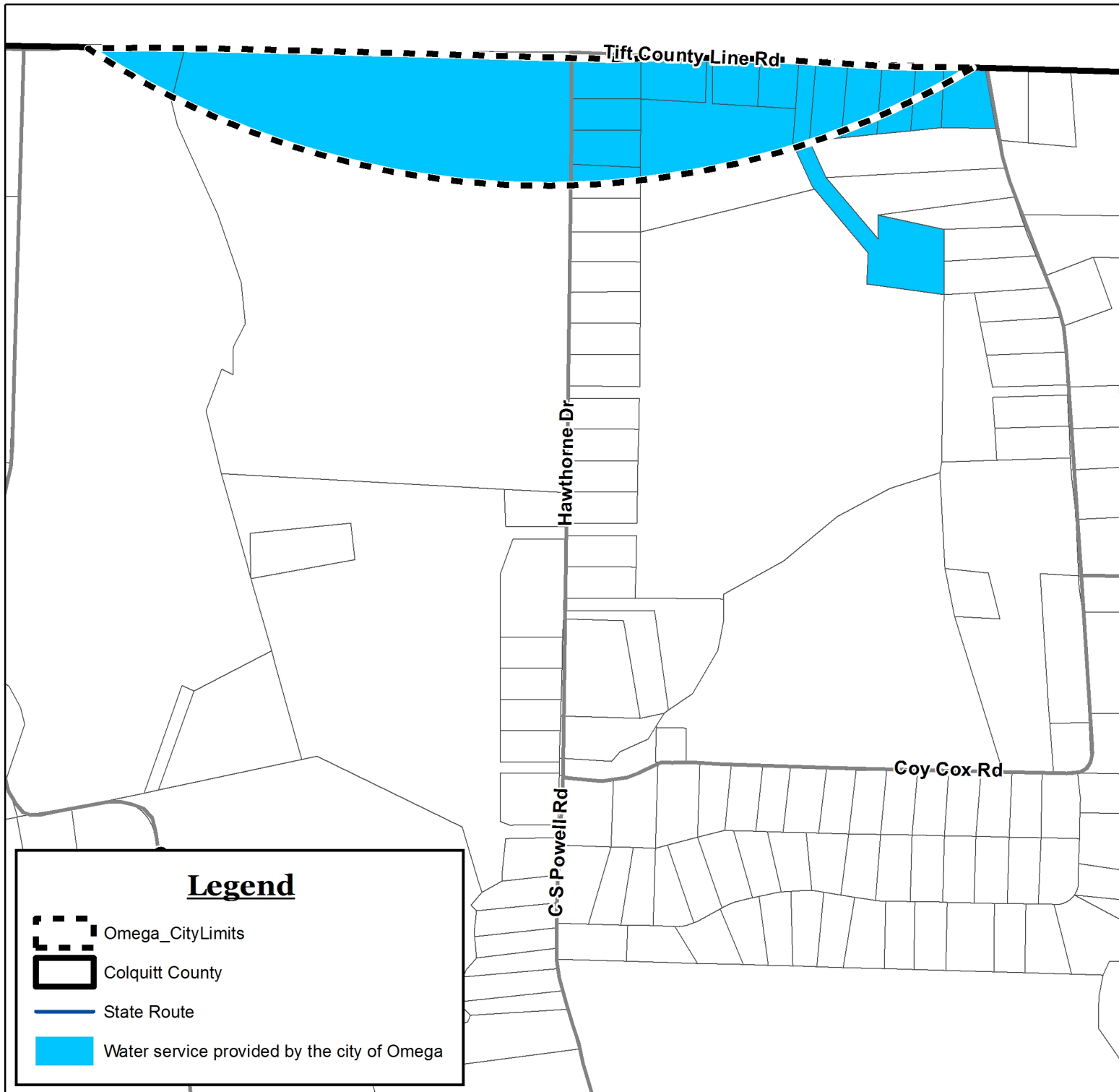

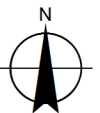


