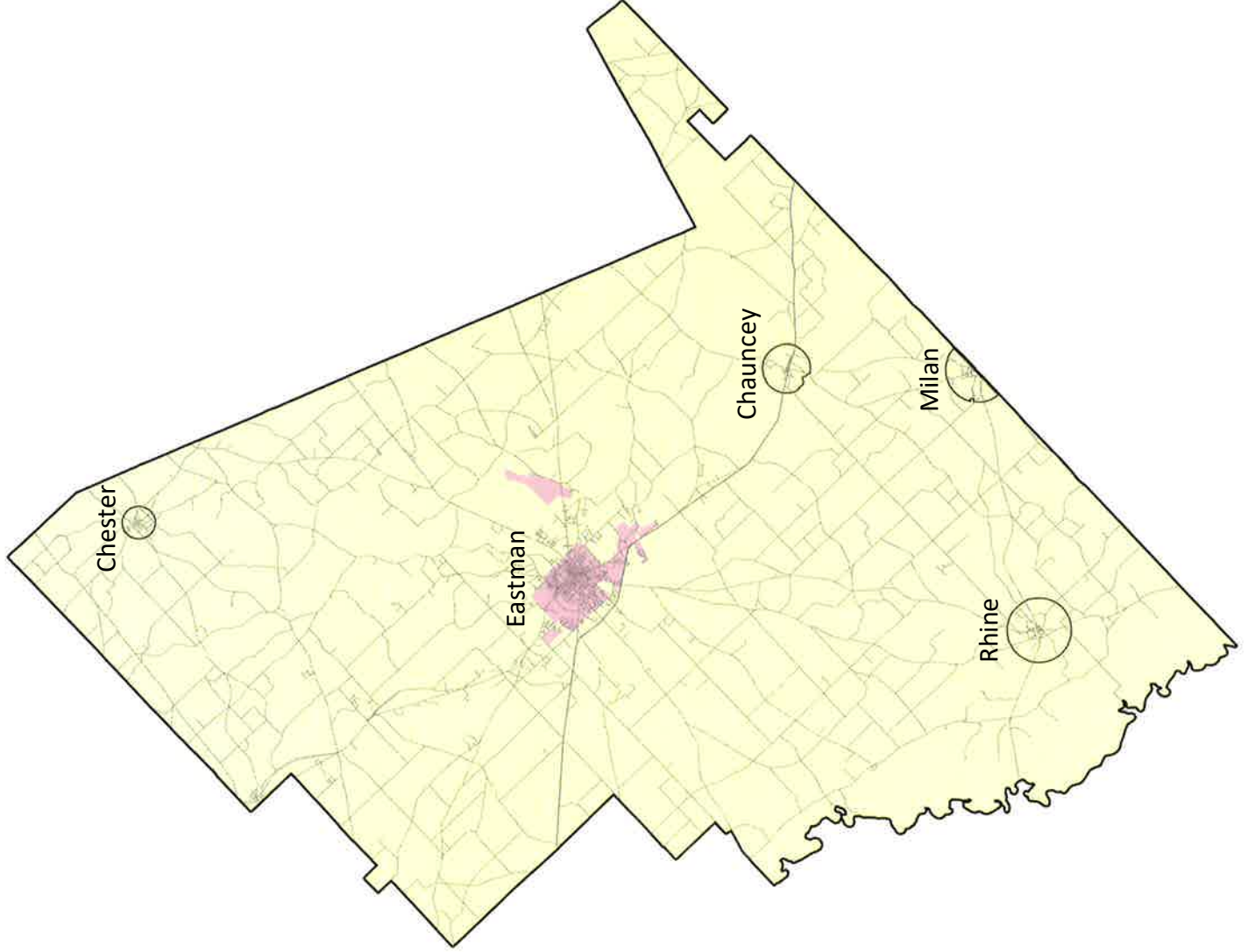

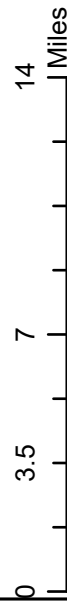
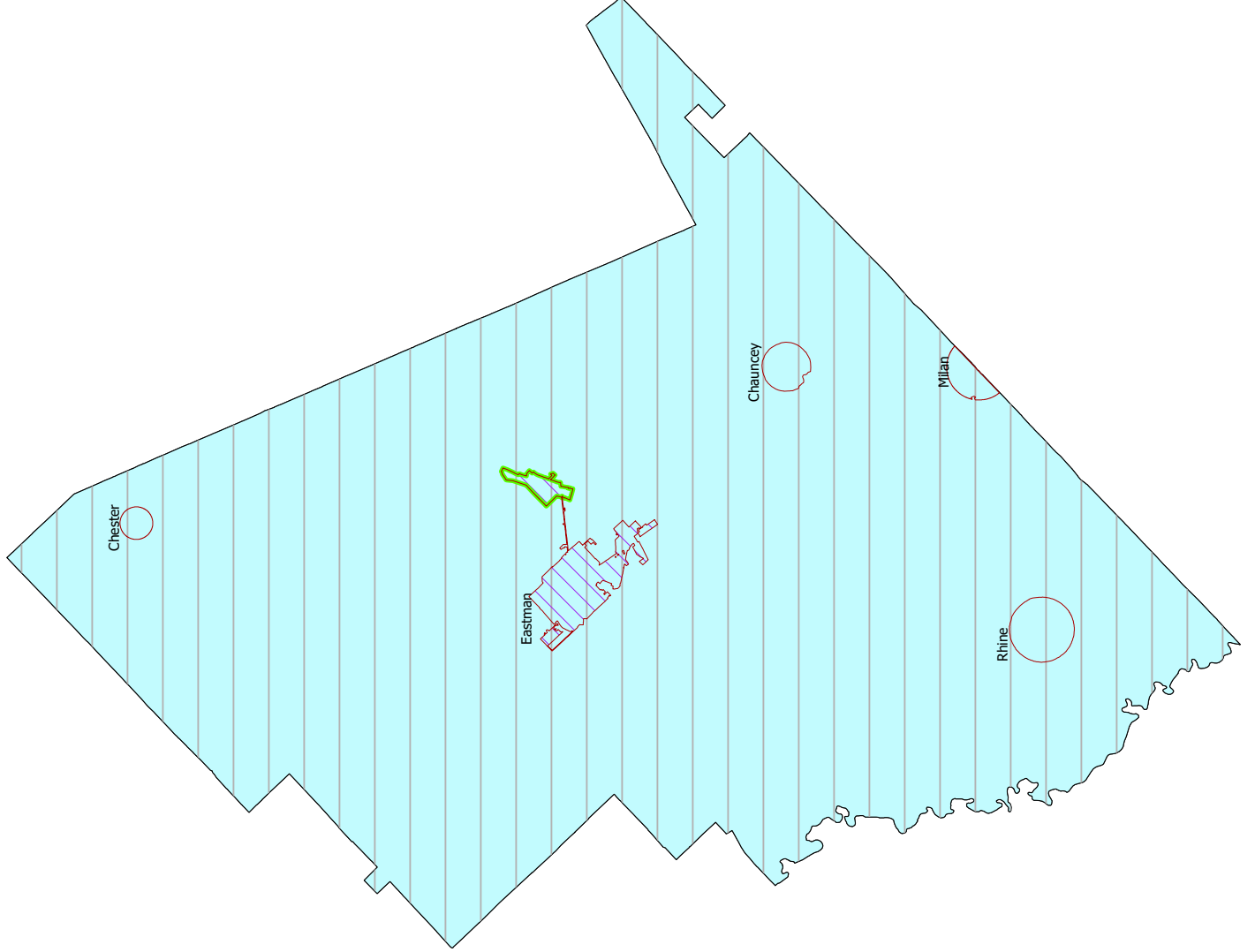

No overlapping service areas/providers were identified due to the services performed are higher levels of economic development service.

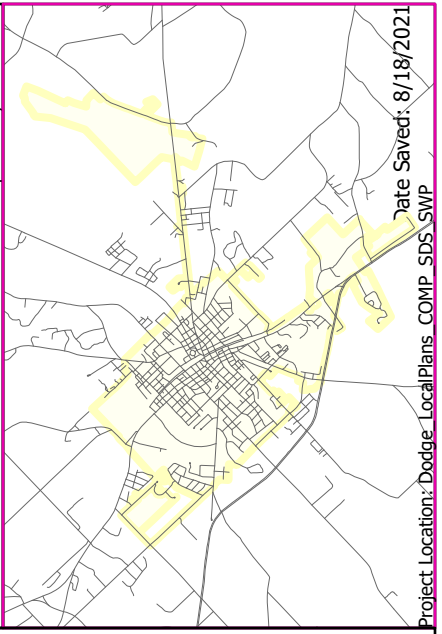

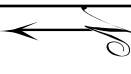

No overlapping service areas/providers were identified due to the service performed by the City of Chauncey is a higher level of recreation service and is not provided by Dodge County.

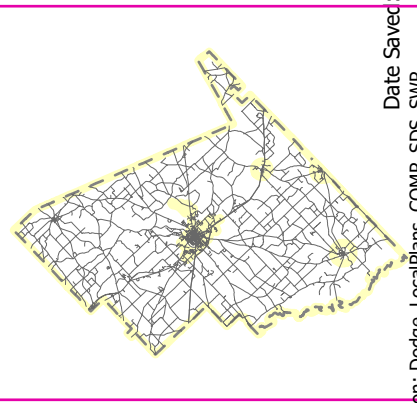

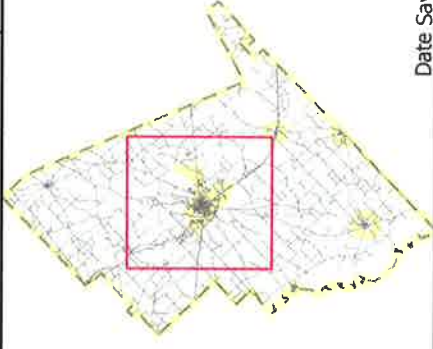


City of Eastman SDS Sewer System Map

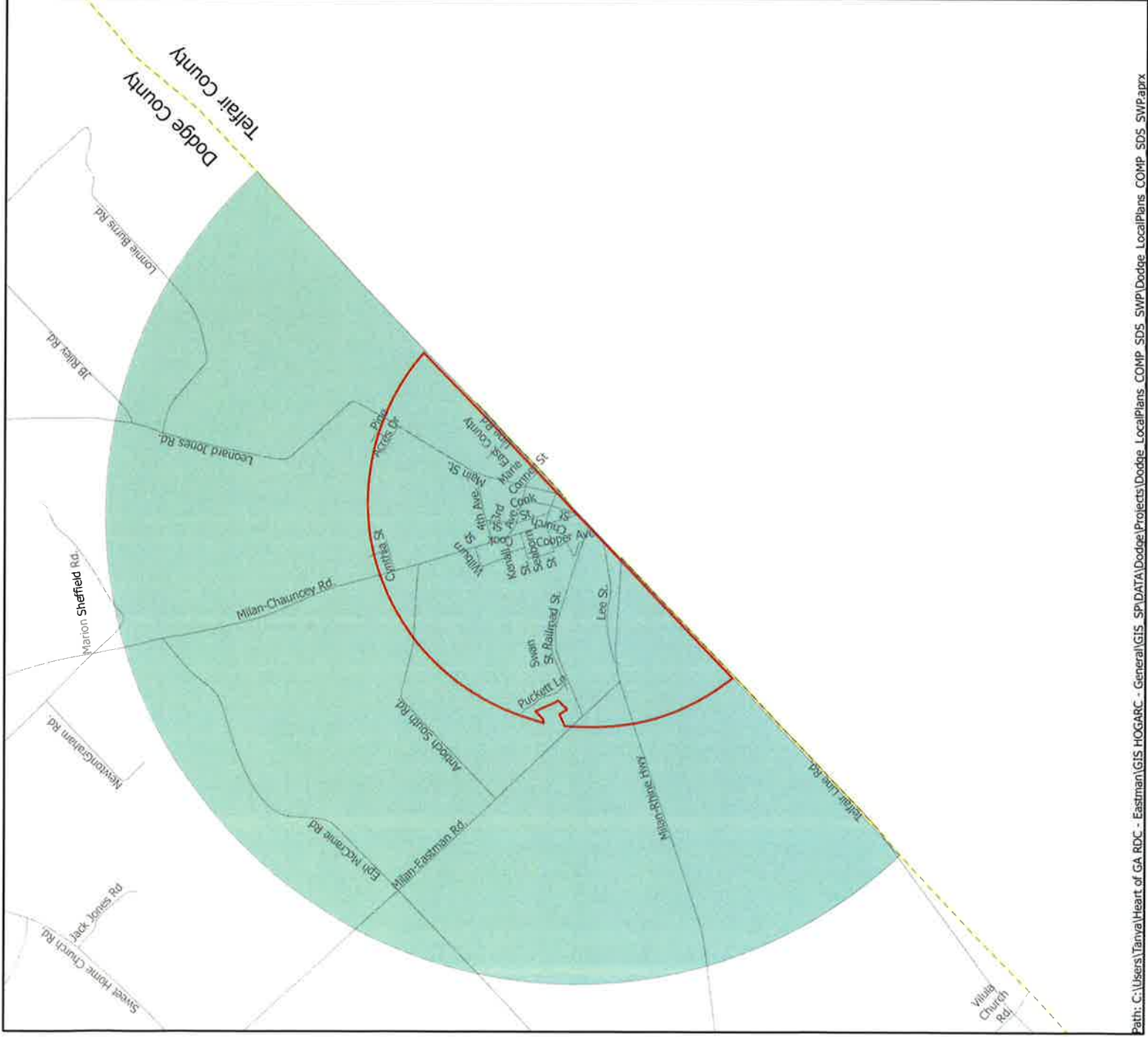

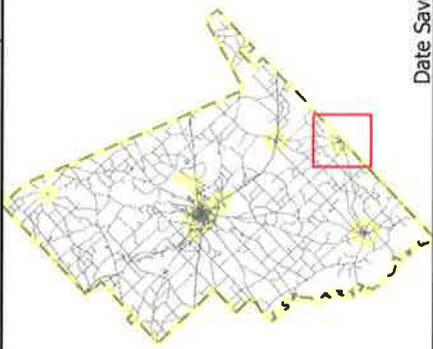


City of Milan SDS Sewer System Map

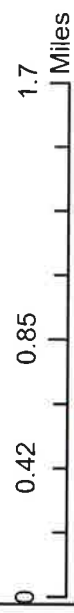

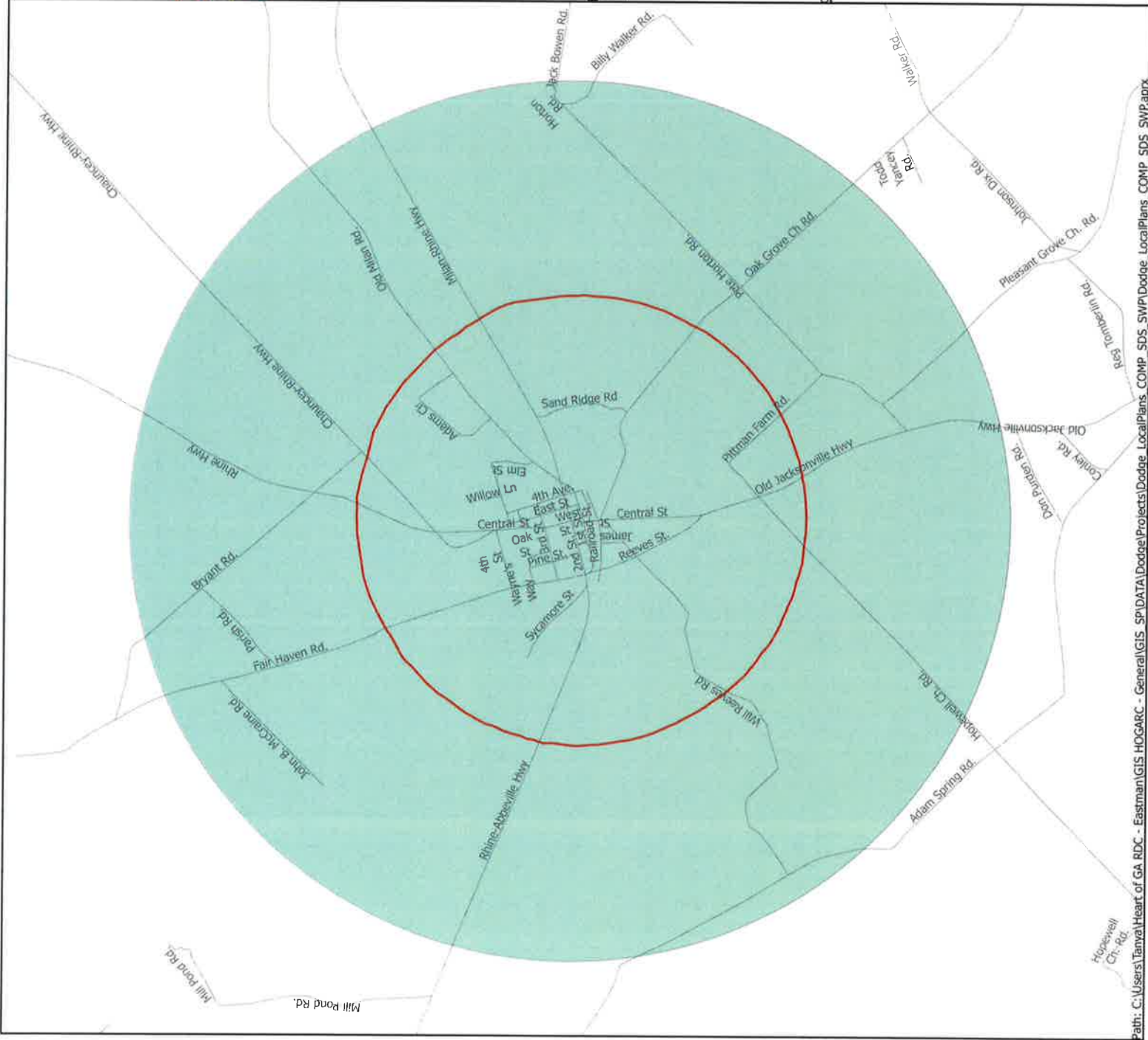
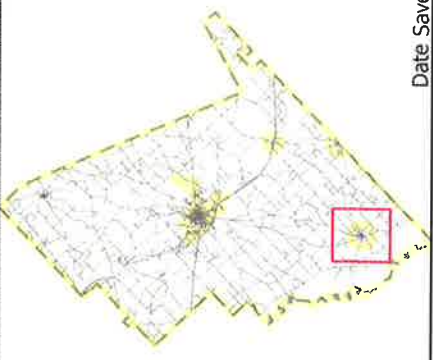


City of Rhine SDS Sewer System Map

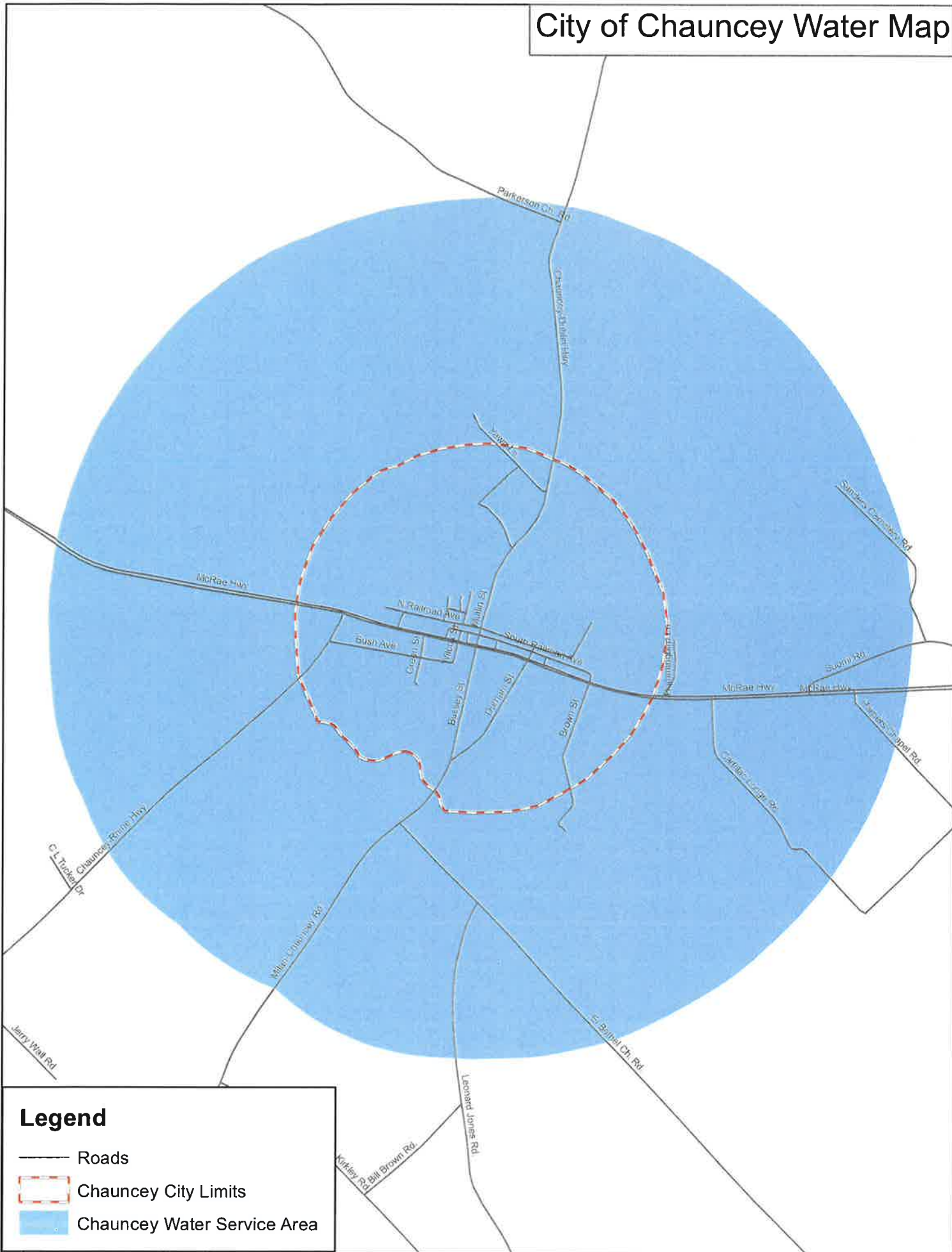

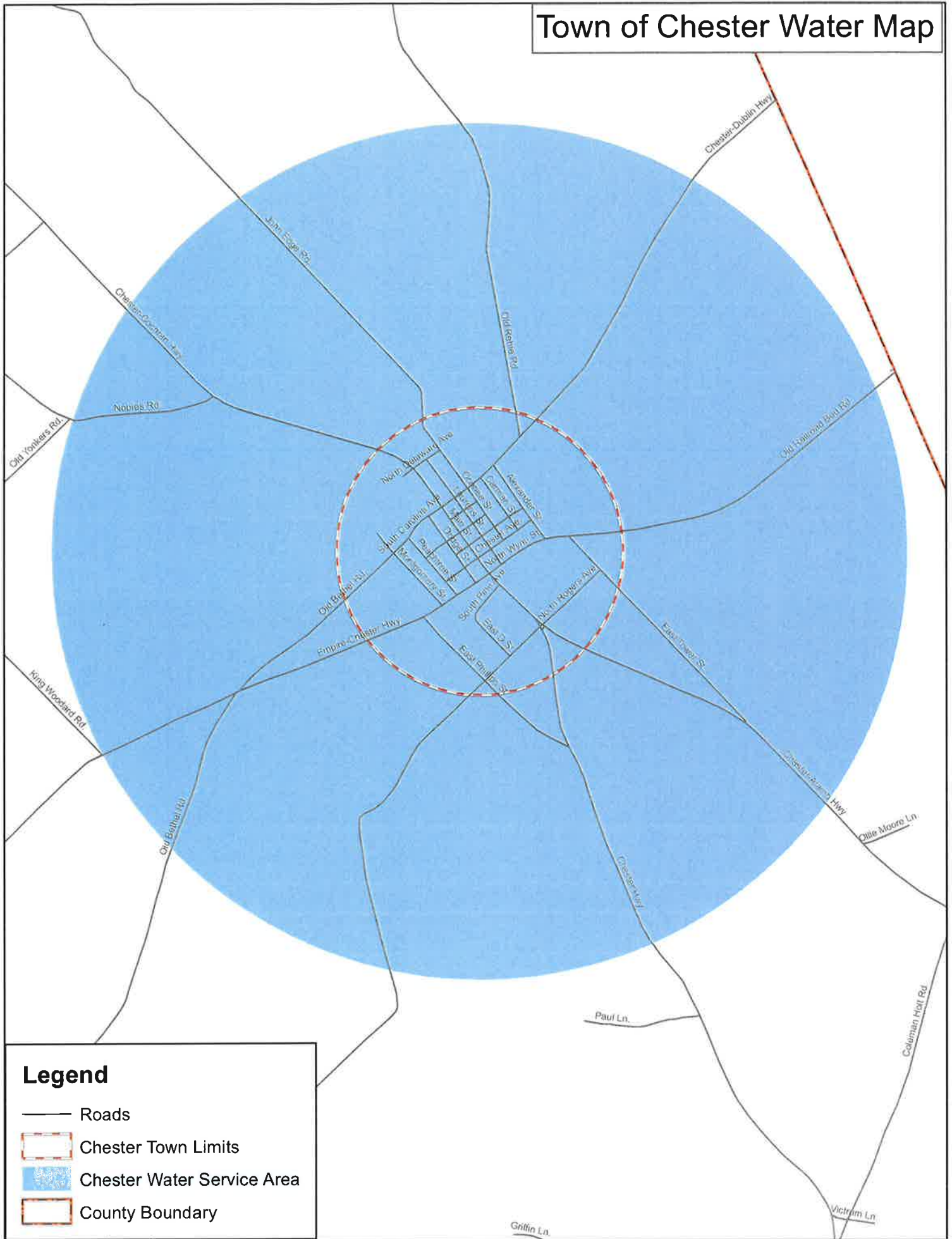
City of Chauncey Water Map



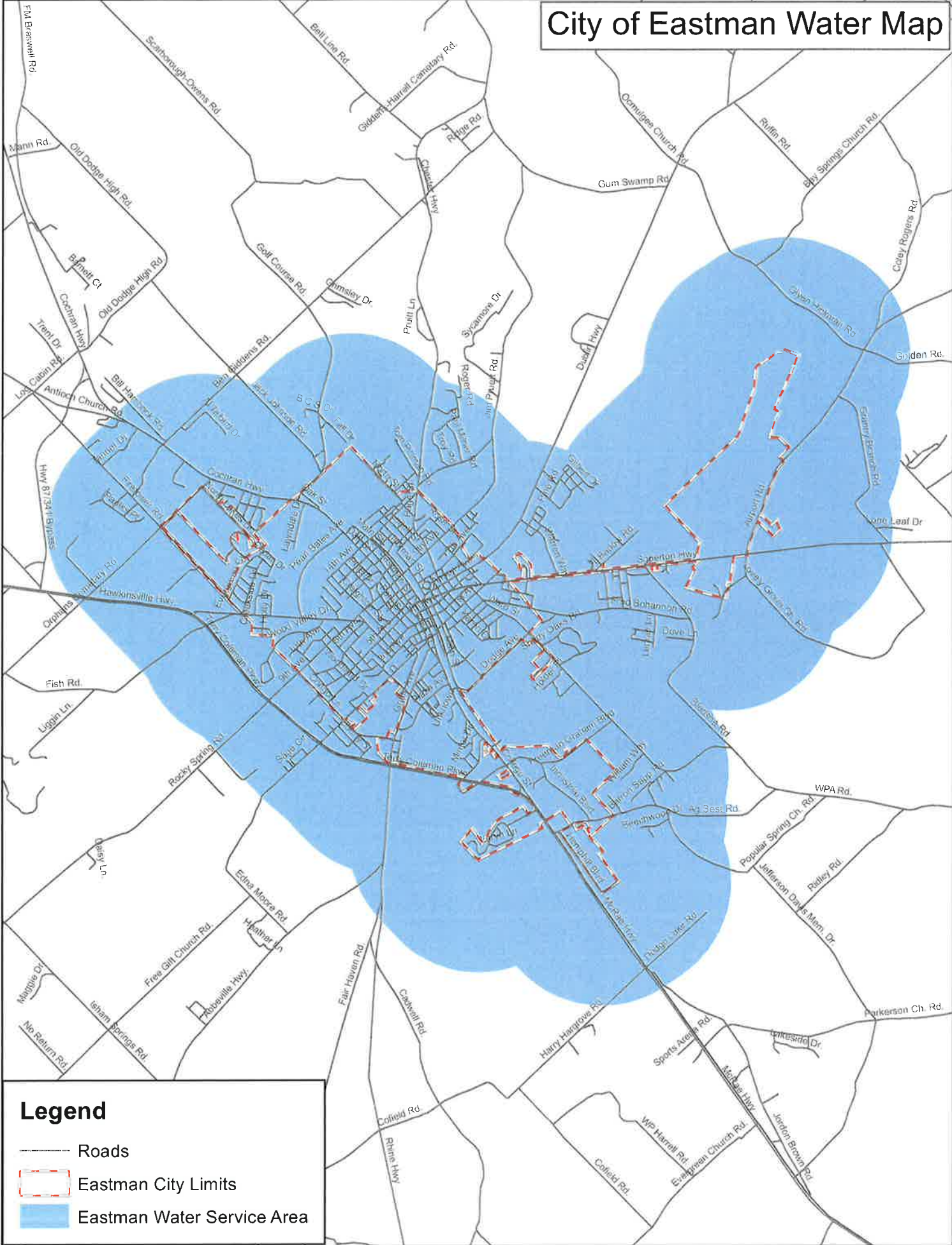

Town of Chester Water Map



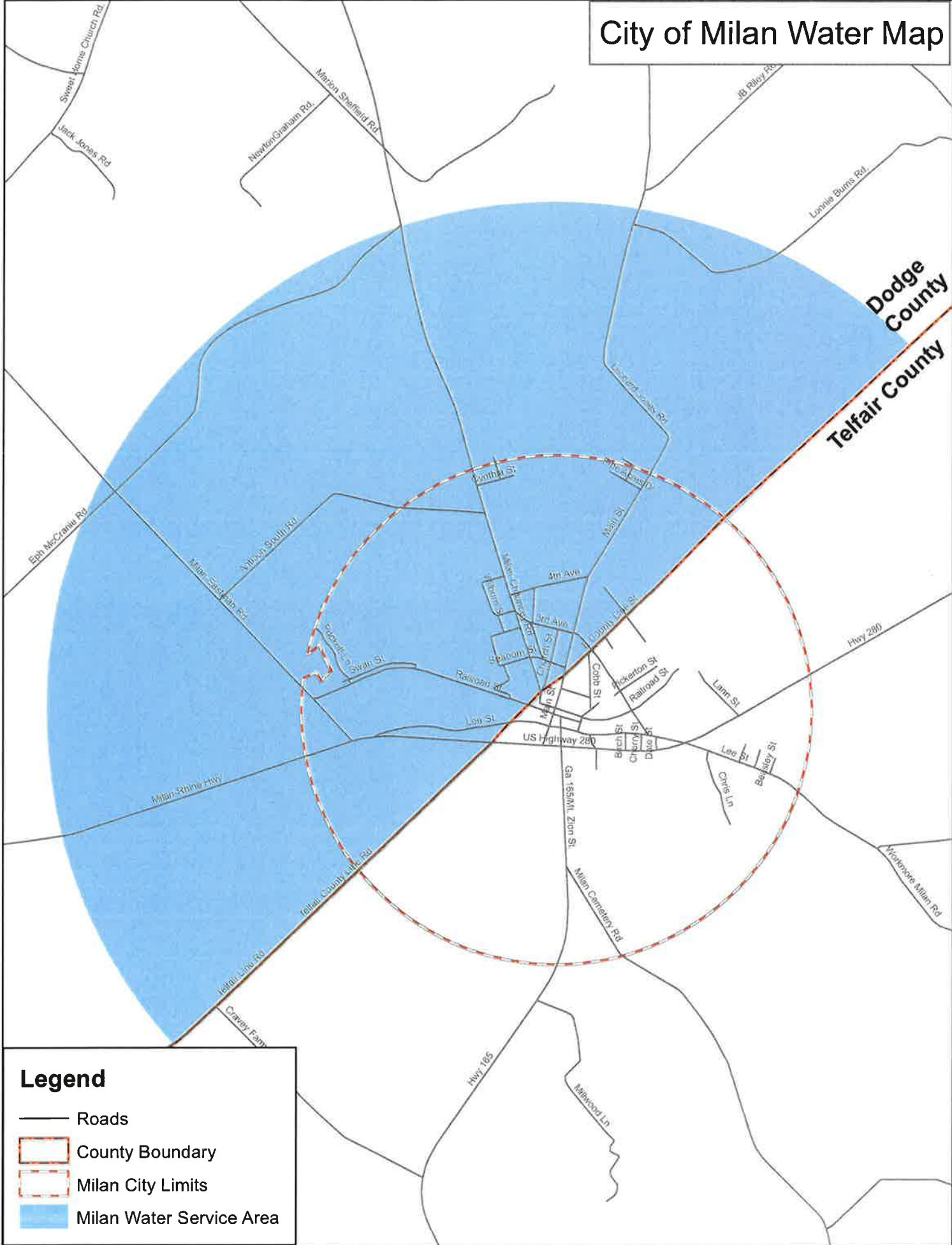
City of Eastman Water Map

- Eastman Water Service Area

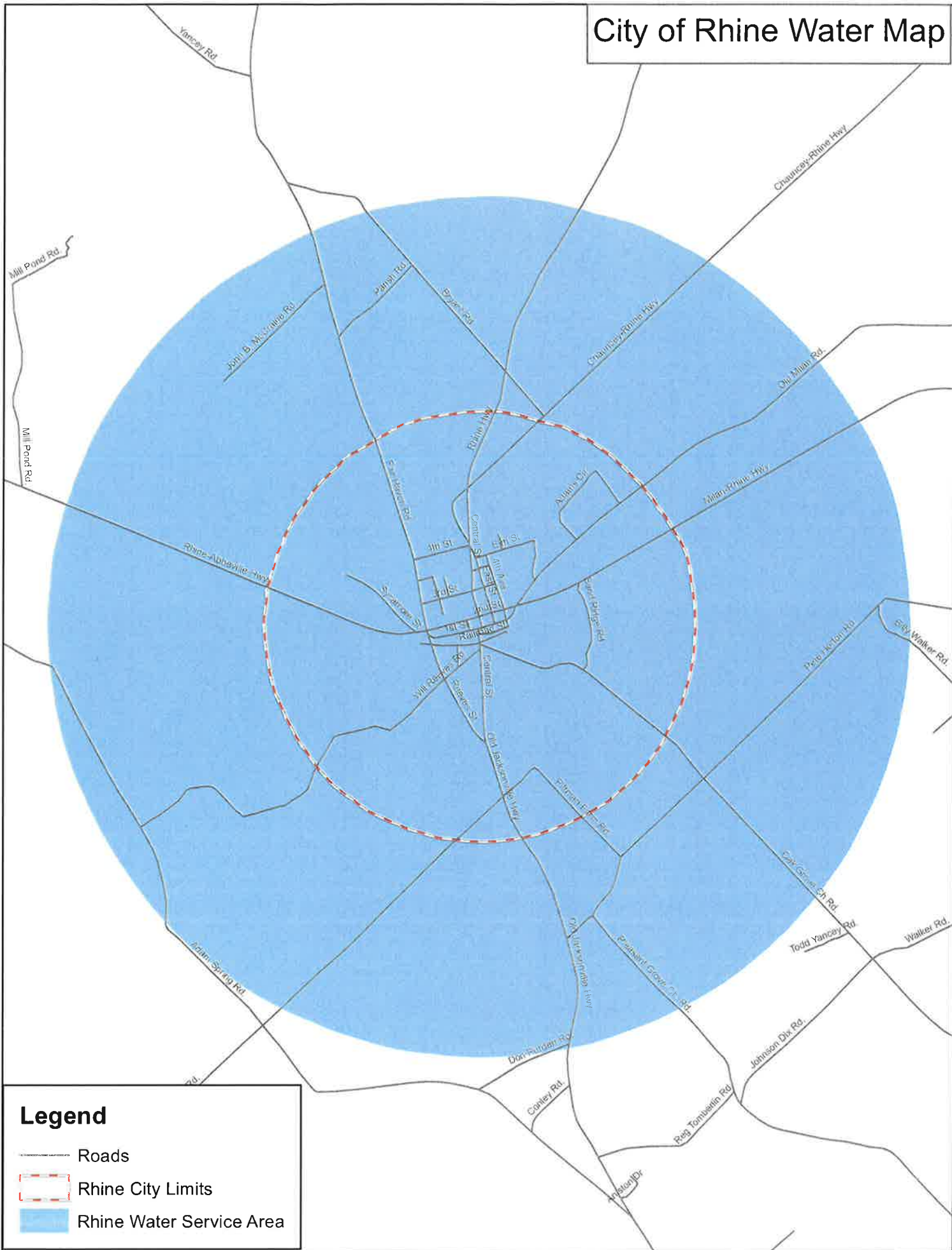
City of Milan Water Map







