### Introduction

The purpose of the Community Participation Program is to insure that the local comprehensive plan reflects the full range of community values and desires by involving a diverse spectrum of stakeholders in development of the Community Agenda. Meaningful participation in developing the Community Agenda will also help insure that it will be implemented, because many in the community are involved in its development and thereby become committed to seeing it through. The Community Participation Program is a required component of the planning process for communities of all planning levels in Georgia. This program is intended to supplement the two public hearings currently required by the Local Planning Requirements.

### **Public Participation Requirements**

The Stone Mountain Community Participation Program is based on input from City leaders, staff and regional and state agencies (ARC and DCA). The program provides definition of a specific process to follow that will achieve City objectives and satisfy Department of Community Affairs requirements for public participation and "visioning" in the Comprehensive Plan Update process.

The DCA Minimum Local Standards for comprehensive plans include requirement for a "Community Vision" to be developed as part of the comprehensive plan update. The Community Vision, or "Vision for the Future of the Community" must

- be based on public input, assessment of current and future needs, and other elements of the plan;
- address Community, Regional and State planning goals;
- include pictures, illustrations, and/or descriptions of development patterns to be encouraged within the jurisdiction, including clear identification of areas to be developed, areas to remain as open space or rural land, and areas where mixed use development and similar development will be encouraged; and
- include both a generalized overall Vision for the community with more specific detailed Visions for sub-areas of the community.

For the City of Stone Mountain, the Community Vision should also address redevelopment opportunities, community character and regional/multi-jurisdictional visions.

### **Public Participation Goals**

The planning process used to develop the City of Stone Mountain Comprehensive Plan 1996 – 2006 met the minimum planning standards for public participation at that time. During the city's recent Village LCI study process the city greatly expanded its community participation efforts and conducted a series of very well attended and successful public meeting that greatly improved the quality of the LCI plan. Moving forward, the City of Stone Mountain is encouraged to build upon its prior commitments to public participation and strives to expand the opportunities for engaging citizens in the planning process. To achieve this, the following goals are established for the public participation in the *Stone Mountain Comprehensive Plan Update 2005 - 2025*.

Goal: Raise the level of awareness and understanding of planning in City of Stone Mountain.

Goal: Provide the citizens of Stone Mountain with meaningful opportunities for involvement in the planning process.

Goal: Involve and maintain close contact with identified key stakeholders throughout the planning process.

Goal: Identify and involve traditionally underserved communities (minority, low-income, elderly, etc.) in the planning process.

### **Identification of Stakeholders**

The City has chosen a large and diverse group of individuals to serve on a Citizen Advisory Panel. In developing this panel the city strove to include a wide variety of local stakeholders including business interests, developers, agencies and institutions, and community activists and leaders. The purpose of this group is to meet on a regular basis following the completion of the draft of the Community Assessment and Participation Program to guide the development of the Community Agenda. A variety of local stakeholders have been invited to serve on this panel. A list of the invited participants and their organizational affiliations or local significance is provided here.

### **Identification of Planning Techniques**

The Stone Mountain Community Participation Plan will offer numerous and various opportunities for public involvement in the planning process. Stone Mountain citizens can consistently stay attuned to city activities through the regular schedule of Council meetings on the second Tuesday of each month. Citizens can discuss issues with City staff and elected officials at these meetings or at any time via mail, telephone or email. City of Stone Mountain information is also available via the Internet at a City-maintained website: <a href="https://www.stonemountaincity.org">www.stonemountaincity.org</a>.

In addition to regular City meetings, special meetings, workshops and open houses will be held during the planning process. The following are types of public involvement opportunities that will be offered as part of the *Stone Mountain Community Participation Program*:

- 3 Comprehensive Plan Steering Committee The Citizen Advisory Panel
- ③ Public Workshops Design Charettes
- 3 Open House Review Meetings
- 3 Public Hearings

Public meetings, including workshops and review meetings, will be held in locations in Stone Mountain that are conducive to encourage meaningful community input. In addition to use of City facilities, local cultural facilities and public schools will be used for public meetings.

#### **Public Information Resources**

The City of Stone Mountain will maintain information dedicated to the *Stone Mountain Community Participation Program and* the Comprehensive Plan Update linked directly to the City of Stone Mountain homepage. The web page will include schedule information, public meeting notices, and means for reviewing draft plan elements. If possible, the web site will also offer an easy way for the public to communicate with City staff and consultants.

A community newsletter and major newspapers will be consistently used for public information dissemination. The City of Stone Mountain publishes the City News newsletter on a periodic basis and distributes the newsletter to all city households. The Champion newspaper is the legal organ for City information and also provides editorial and feature coverage of government activities. The Atlanta Journal/Constitution will also be solicited for articles and notices, especially within the DeKalb County special section and the weekly Horizon section.

### Coordination

Commensurate with Stone Mountain Community Participation Program public involvement efforts will be efforts to ensure that the planning process is highly coordinated at the local and regional level. To ensure coordination throughout the planning process, a Citizen Advisory Panel will be organized. This committee will include representatives from City of Stone Mountain neighborhoods, businesses, non-profit groups and the City staff/elected officials. The members of the Citizen Advisory Panel will be selected through consultation with staff and elected officials.
