## Introduction

This comprehensive plan is a long-range statement of a community's vision for development and redevelopment. By addressing the entire physical environment of the county and city the multitudes of functions, policies and program that comprise their day to day workings, the plan seeks to guide the what, when, where, why and how of future physical changes to the landscape of Miller County and the City of Colquitt.

The development of the Miller County Comprehensive Plan was mandated by the Georgia Planning Act of 1989. The plan represents joint participation in Georgia's coordinated planning process by Miller County and the City of Colquitt. The purpose of the Miller County Comprehensive Plan is to provide the elected and advisory officials of Miller County and the City of Colquitt with a guidance tool with which to manage, guide, and promote community growth and development in an organized fashion.

Georgia's comprehensive planning process requires the development of a short term work program outlining specific strategies by which the communities will strive to meet their needs and goals in the following five years. In addition, the comprehensive plan will serve as the foundation for long term decision making regarding the future land use pattern, economic development strategies, housing improvements, and environmental and historic resource protection.

By meeting Georgia's Minimum Planning Standards and Procedures established as part of the Georgia Planning Act, each participating community will retain their Qualified Local Government status. This status enables Georgia communities to remain eligible for state loans and grants.

### Southwest Georgia Regional Commission Role

The Southwest Georgia Regional Commission's Planning Department facilitated the 2017 Comprehensive Plan update for Miller County. Leading community input sessions and Steering Committee meetings, the SWGRC team gathered feedback and guidance from the public, and used this information to assemble the Comprehensive Plan and made recommendations that are reflective of the community's desires. The elected officials of each local government hold ultimate responsibility and authority to approve and direct the implementation of the Comprehensive Plan documents.

### Miller County: Past and Present

iller County, the state's 117th county, was created by the state legislature in 1856 out of portions of Early and Baker counties. The county was named for attorney Andrew Miller, who served in the state senate and later became president of the Medical College of Georgia in Augusta.

Colquitt was designated as the county seat in the same year as the county's founding. The city

was named after Walter T. Colquitt, a clergyman, attorney, and judge, who served in the U.S. Senate from 1843 to 1848. The county's first courthouse, built in Colquitt, was replaced once and then burned twice before the current structure was completed in 1977. Colquitt is Georgia's first Mural City. Several beautiful murals are visible around the city. One of the most astonishing murals is the one that tribute the American Farmer and is the gateway to the city. It can be seen from miles away.

At the turn of the twenty-first century, cotton, peanuts, and corn for grain were the top crops in Miller County, which today ranks fourth in total peanut production in Georgia.

Miller County is home to Georgia's official folk life play,



Swamp Gravy. The ever-changing play is regularly scheduled at the historic Cotton Hall in Colquitt, which also houses the Museum of Southern Cultures. Storytelling circles are also popular because of the play. The Swamp Gravy Institute, an arts service organization formed as an outgrowth of the play, is a consulting and training unit of the Colquitt-Miller Arts Council. A storytelling festival is held in Colquitt in August, and the May-Haw Festival, honoring the tart South Georgia fruit, is held in April at Spring Creek Park, which also contains ecologically fragile wetlands.

The ongoing Millennium Murals Project, funded by public and private sources, has become a community beautification project. Using walls on area schools and business establishments, project designers pair artists with local middle and high school students, teachers, and community members. The murals depict stories told by locals about community happenings.

According to the 2010 U.S. census, the population of Miller County is 6,125 (69.6 percent white, 28.1 percent black, and 1.5 percent Hispanic).

### **Public Involvement**

On September 26, 2015, the Southwest Georgia Regional Commission and Miller and Colquitt County officials and citizens held a daylong meeting to begin the planning process. The planning team was focused and a lot was accomplished that day. Additional community meetings are planned as the plan moves forward. A community survey was developed and is available online, at the City and County Office, local schools and business. The survey was made available throughout the duration of the comprehensive planning process. Unsuccessful efforts were made through Facebook. Survey Monkey, Constant Contact and Instagram with no results. A copy of the survey is included in the appendix. ### Vision Statement

Miller County and the City of Colquitt will create a small town environment that provides quality of life through the enhancement of economic and social vitality and the integration of a cooperative, creative and innovative spirit.

### **Goals and Policies**

- **1.** Economic Prosperity: Miller County and the City of Colquitt will encourage development, expansion or retention of businesses and industries that are suitable for the community.
  - **a.** We will support programs for retention, expansion and creation of businesses that are a good fit for our community's economy in terms of job skill requirements and linkages to existing businesses.
  - **b.** We will target reinvestment to declining, existing neighborhoods, vacant or underutilized sites or buildings and downtown area.
- 2. Resource Management: Miller County and the City of Colquitt will promote the efficient use of natural resources and identify and protect environmentally sensitive areas of the community.
  - **a.** The protection and conservation or our community's resources will play an important role in the decision-making process when making decisions about future growth and development
  - **b.** We will minimize inefficient land consumption.
- **3. Efficient Land Use:** Miller County and the City of Colquitt will maximize the use of existing infrastructure.
  - **a.** We will encourage the development of downtown as a vibrant center of the community in order to improve overall attractiveness and local quality of life.

- **b.** We support new land uses that contribute to protecting the environment and preserving meaningful open space.
- **4.** Local Preparedness: Miller County and the City of Colquitt will identify and put in place the prerequisites for the type of future the community seeks to achieve.
  - **a.** Our community will seek ways for new growth to pay for itself (in terms of public investment in infrastructure and services to support the development) to the maximum extent possible.
  - **b.** Our community will use planned infrastructure expansion to support development in areas identified (in the comprehensive plan) as suitable for such development.
  - **c.** Our community will make efficient use of existing infrastructure and public facilities in order to minimize the need for costly new/expanded facilities and services.
- **5. Sense of Place:** Miller County and the City of Colquitt will protect and enhance the community's unique qualities.
  - **a.** We will encourage redevelopment in suitable locations in order to protect natural resources, environmentally sensitive areas, or valuable historic, archaeological or cultural resources from encroachment.
  - **b.** We will ensure safe and adequate supplies of water through protection of ground and surface water sources.
- **6.** Regional and Local Cooperation: Miller County and the City of Colquitt will cooperate with neighboring jurisdiction to address shared needs.
  - **a.** We will seek opportunities to share services and facilities with neighboring and local jurisdictions when mutually beneficial.
  - **b.** We will work jointly with neighboring and local jurisdictions on developing solutions for shared regional issues (such as growth management, watershed protection).
  - **c.** We will pursue joint processes for collaborative planning, tourism and decision-making with neighboring and local jurisdictions.
- **7.** Housing Options: Miller County and the City of Colquitt will promote an adequate range of safe, affordable, inclusive, and resource efficient housing in the community.
  - **a.** We will increase opportunities for low-to-moderate income families to move into affordable owner-occupied housing.
  - **b.** We will seek to balance the supply of housing and employment in our community and consider their location in relation to each other.
  - **c.** We will stimulate infill housing development in existing neighborhoods.
- **8. Transportation Options:** Miller County and the City of Colquitt will address the needs, challenges and opportunities of all community residents.

- **a.** We will take into account access to housing and impacts on transportation when considering economic development projects.
- **b.** We will make decisions that encourage walking, biking, car-pooling, and other alternative transportation choices.
- **c.** We will target transportation improvements to support desired development patterns for the community (recognizing that ready availability of transportation creates demand for land development in adjacent areas).
- **9. Educational Opportunities:** Miller County and the City of Colquitt will make educational and training opportunities readily available to enable all community residents to improve their job skills, adapt to technological advances, or pursue life ambitions.
  - **a.** We will work with the local school board to encourage school location decisions that support the community's overall growth and development plans.
  - **b.** We will consider the employment needs and skill levels of our existing population in making decisions on proposed economic development projects.
- **10. Community Health:** Miller County and the City of Colquitt will ensure that all community residents, regardless of age, ability or income, have access to goods and services, safe and clean neighborhoods, and good work opportunities.
  - **a.** We are committed to providing pleasant, accessible public gathering places and parks throughout the community.
  - **b.** We will invest in parks and open space to enhance the quality of life for our citizens.
  - **c.** We are committed to provide access to affordable healthcare and other goods and services.



### **ECONOMIC DEVELOPMENT**

The Comprehensive Economic Development Strategy (CEDS) as developed by the Southwest Georgia Regional Commission under a grant from the US Department of Commerce Economic Development Administration is hereby incorporated by reference into this Comprehensive Plan to serve as the Economic Development Element for Miller County and the City of Colquitt.

The Southwest Georgia Regional Commission's (SWGRC) Comprehensive Economic Development Strategy (CEDS) was designed to bring together the public and private sectors in the creation of an economic roadmap to diversify and strengthen the regional economy. The SWGRC CEDS analyzed the regional economy and serves as a guide for establishing regional goals and objectives, a regional plan of action, and the investment priorities and funding sources.

Policies, issues and opportunities, and Community Work Program implementation strategies located in the current Comprehensive Plans for each of our 14 county regions were used extensively to develop the CEDS Goals and Objectives, Vital Projects and Problems and Opportunities. Portions of the CEDS are included in this plan element and are listed below.

Colquitt, Georgia is the county seat of Miller County and home to Swamp Gravy, Georgia's official folk life play and annual Mayhaw Festival that attracts nearly 20,000 visitors. Since 1992, Swamp Gravy has toured all over the United States and South America. It has a permanent home in a cotton warehouse which has been converted to a 284 seat theater. According to the 2010 Census, there are 6,125 residents in Miller County. It is one of the least populated counties in the region.

Like most counties in the region, it is heavily dependent on agriculture and has a number of industries related to agricultural products. Residents often think of Colquitt, the county seat, as the "Mayhaw Capital of the World".

A mayhaw is a small, red berry often used for jams and jellies. Colquitt is the sites of a 23-foot Red Oak tree that sculptor Peter Toth carved into the head of an Indian brave. Also in memory of Native American Indian culture is the Native American and Early Pioneer Museum that houses more than 100,000 artifacts. Colquitt has become the region's leader in tourism and is heavily invested in cultural activities to attract visitors and increase the tax base.

As far as we can determine at this time, Colquitt, Georgia has one of the largest hand painted murals in the United States. The 27,000 square foot structure is owned by Birdsong Peanut Company and is used to store peanuts. It serves as a gateway of sorts to the City and is breathtakingly beautiful. Miller County like other counties is facing economic issues. Most of

the residents work outside of the County. Nearly 70 % of the population has completed high school or GED; and a 25.2 % level of poverty according to the 2010 Census.

Miller County has capitalized on the arts and the historic city square. Hwy 27 runs through the center of the county which attracts substantial traffic going from Florida to Tennessee and returning. The highway has been designated as a freight highway for Georgia. The Georgia Department of Transportation will expand this highway to four lanes. The 31 million dollar project has been in the making for more than 25 years and included 46 counties at the table. These counties expect to self-generate \$1.8 billion in new revenue dedicated to local transportation improvements.



### TRANSPORTATION

Miller County is approximately fifty miles from Interstate 10, seventy-five miles from Interstate 75, and approximately 75 miles from the Interstate connector 185 in Columbus. These are the closest interstate routes. The County is served by one federal route: U.S. 27. U.S. Highway 27 (GA. 1) ascends through the County from Decatur County moving through the City of Blakely and veering North West toward the City of Blakely in Early County. U.S. 27 is a major artery linking Florida (I-10) and Indiana.

State routes account for a majority of the County's total roadway. Five major state routes provide access to and within Miller County. These include Georgia Highway 91, which runs west to east connecting the Cities of Donalsonville to Colquitt to Newton. Georgia Highway 273 runs east west from Miller County to southern Early County. Georgia Highway 39 connects Donalsonville to the City of Blakely via the south west corner of Miller County. U.S. highway 310 runs from Decatur County through Colquitt to connect with Highway 45 to the City of Arlington.

Maintenance and paving of County roads will be needed throughout the planning period. To this effort, the County will continue to work with the DOT on the Local Maintenance Improvement Grant (LMIG) throughout the planning process. The completion of the four lane extension of U.S. Highway 27 will be an economic catalyst. In the longer term planning period the County is interested in improving it's paved to dirt ratio and will continue to support developmental highway programs.

Colquitt's road system basically conforms to the gridiron pattern, with most roads oriented in a north-south pattern or east-west pattern. All traffic has to take a mini tour of the downtown area by way of its design. The square in Colquitt is a two-lane, one way counter clockwise route with parallel and angle parking on the right hand side. Traffic must yield on all routes before entering square. Traffic control around the courthouse square in Colquitt is necessary to maintain a viable downtown Central Business District and to minimize congestion and traffic hazards. The completion of widening U.S. Highway 27 may increase traffic flow around the square.

Major collectors in Colquitt include Georgia Routes 91, 273 and 45. Minor collector routes, the next classification of thoroughfares, are community feeder routes designed primarily to carry residential traffic and occasional trucks onto the main arterials. These roads are generally city maintained roads which provide access to a specified sector of the community. Minor collector routes in Colquitt include the following streets or portions thereof:

1. First Street

- 2. Main Street
- 3. Milford Road/Philipsburg Road
- 4. College Street
- 5. Twilight Church Road
- 6. Perry Drive

The next category of streets is local collectors, which serve residential and other areas by dispersing traffic from the arterials and conversely, by collecting and channeling traffic from local streets to arterial routes. These local collectors provide for both land access service and local traffic movement within residential neighborhoods, commercial areas or industrial areas. The local collector streets in Colquitt include the following streets or portions of those streets:

- 1. Pine Street
- 2. Cuthbert Street
- 3. Fourth Street
- 4. Second Street
- 5. Third Street
- 6. Dancer Street

All other streets in the City are classified as local streets which primarily provide access to abutting land and to the higher order systems. They are proposed to be purely residential neighborhood streets serving the immediate abutting property.

The majority of the streets in Colquitt are paved; however, there are some streets needing resurfacing.

Parking improvements are desired in the downtown square area but are adequate at the present time. U.S. 27 is the major north-south route through Colquitt and the most heavily traveled route in the urban area. Most truck traffic will continue to utilize U.S. 27. State Route 91 is the major north east-south west route through Colquitt.

#### Average Daily Traffic

The average daily traffic in Colquitt is light to moderate on the majority of the routes. According to the recent DOT Coverage County Report, the most heavily traveled areas include U.S. 27 where it merges into College Street, Hwy. 91 NE of GA 45, GA 91 S of CR 542 and GA 45 S of GA

91. Also, traffic around the square is relatively high. Another traffic problem noted by the stakeholders, are trucks traveling through downtown around the square. Large trucks, such as logging trucks, cannot make the turns around the square and often damage landscape as well as obstruct traffic flows. There are alternative route signs posted and warning tickets issued, but the problem still exists.

Miller County and Colquitt are not served by a public transportation system. Transportation services are provided through a contract with the Southwest Georgia Regional Commission with funding from the Georgia Department of Human Resources (DHR). The program is not an on demand system but meets the transportation needs of the elderly and those persons with disabilities and also the general public. Last year alone nearly 10,000 trips were provided to Miller County and Colquitt, Georgia residents.




Land use for small communities must maintain rural character to strengthen economic potential. Rural Communities need to identify strategies that they are able to implement with their limited resources. Appropriate land use supports the establishment of agricultural activities and non-agriculture activities that encourages sustainable rural development, while respecting the rights of rural community and residents.

The future land use categories are not zoning classifications. Instead, they act to inform leaders on decisions regarding rezoning and development. They will identify the specific use that is proposed for a parcel. The future land use categories are defined below:

Land Use (	Classifications
Residential	The predominant use of land is residential, single-family and multi-family dwelling units
Commercial	Non-industrial business uses, including retail sales, office, service and entertainment facilities, organized in one building or grouped together in a shopping center or office building.
Industrial	Land dedicated to manufacturing facilities, processing plants, factories, warehousing and wholesale trade facilities, mining or mineral extraction activities, or other similar uses.
Public/Institutional	Includes certain state, federal or local government uses, and institutional land uses. Government uses include government building complexes, police and fire stations, libraries, prisons, post offices, schools, military installations, etc.
Transportation/Communication/Utilities	Includes such uses as major transportation routes, public transit stations, power generation plants, railroad facilities, radio towers, telephone switching stations, airports, port facilities or other similar uses.
Parks/Recreation/Conservation	Land dedicated to active or passive recreational uses. These areas may be either publicly or privately owned and may include playgrounds, public parks, nature preserves, wildlife management areas, national forests, golf courses, recreation centers or similar uses.
Agriculture/Forestry	Land dedicated to farming (fields, lots, pastures, farmsteads, specialty farms, livestock production, etc.), agriculture, or commercial timber or pulpwood harvesting.
Undeveloped/Vacant	Lots or tracts of land that are served by typical urban public services (water, sewer, etc.) but have not been developed for a specific use or were developed for a specific use that has since been abandoned.




