Introduction

The 2017 Joint Comprehensive Plan for Jones County and the City of Gray was created in compliance with the 2014 Planning Regulations from the Georgia Department of Community Affairs to serve as an update to the 2007 plan. The plan was adopted on June 6, 2017. It provides a 20-year development guideline for both local governments. The updated plan addresses local concerns for community services, economic development, housing, natural and cultural resources, transportation, education, and capital improvement since capital improvement fees are collected throughout the county. Members of the steering committee addressed each concern with the development of goals, needs and opportunities, and a community work program with action items to successfully address each issue. The steering committee also thoroughly identified the current land use patterns throughout the community and areas to seek improvement to address growth in the coming years.

Planning Process

To begin the process of updating the Joint Comprehensive Plan, the Middle Georgia Regional Commission met with both local governments at regularly scheduled meetings of the Board of Commissioners and City Council to inform the elected officials of the process to update the comprehensive plan. Details were given, including the comprehensive planning requirements, timeline, and required and optional elements to address local concerns.

A list of interested parties was developed to ensure adequate representation of the community, including elected officials, department heads, religious leaders, local advocates, and citizens. A detailed list of involved individuals can be found below.

The planning process began on October 11, 2016, with the initial kickoff meeting to explain requirements of the comprehensive plan and how each member's input will be thoroughly considered throughout the planning process. To address the public hearing requirement, two public hearings were held to inform the community of the plan development process and gain any input beforehand. One public hearing was held on November 1, 2016, at the Jones County Government Center and another was held on November 7, 2016, at the D.V. Childs Civic Center. Steering



committee meetings were held monthly resulting in a total of seven meetings to address all community concerns. Documentation of all steering committee meetings can be found in Appendix D. A list describing each steering committee meeting can be found in the following table.

The Middle Georgia Regional Commission was also requested to explain the importance of the comprehensive plan and opportunities for involvement to the Jones County People Looking Ahead Now (PLAN) group at their March 18, 2017, meeting. Jones County PLAN is comprised of citizens with a desire to see the community grow and flourish. The members were ultimately concerned about the comprehensive plan and gave exceptional input to be incorporated into the plan. Appendix D has documentation from the meeting.

Draft versions of the plan were presented at the March meeting and April draft distribution to incorporate all changes before the second public hearing on April 20, 2017. The public hearings are fully documented in Appendix E. Comments to the plan are incorporated in the final version.

Vision

The steering committee members developed the following vision statement at the October 11 meeting to further elaborate on the future ambition for the community.

"Our vision is to create a growing, fiscally sound community, that nurtures a family lifestyle and promotes a vibrant sense of place. We will enhance our hometown atmosphere be prioritizing academic excellence, a strong law enforcement system, and a high quality of life."

Community Services

Goal

The steering committee created the following goal to address all the needs and opportunities within the Community Service realm:

Ensure the expansion and maintenance of community-provided services and facilities meets the needs of residents and visitors

Needs and Opportunities

1. Extend and repair water, sewer, and stormwater infrastructure.

Numerous areas throughout Jones County and the City of Gray are experiencing poor water pressure and back-ups of sewer lines along with poor movement of rainwater through the stormwater system currently in place. Evaluations are needed to ensure the areas with the most distress are identified and addressed.

There are many properties throughout the unincorporated county still not served by county water or sewer, leaving residents with minimal or poor well and septic tank functioning. Residents are constantly failing at providing their own water and septic system resulting in poor or no water pressure and backups within their home and yard. Water and sewer services need to be incorporated into undeveloped areas before any development occurs that requires significant water usage. Efforts needs to be placed on the forefront instead of thinking about water and sewer infrastructure after neighborhoods are established.

The current stormwater infrastructure inhibits adequate disbursement of rainwater to suitable collection sites. Pipes constantly require attention either due to the accumulation of leaves and debris preventing proper flow, or areas not having an efficient stormwater system in place. Stormwater infrastructure needs to be considered at the forefront of any road improvements. It's much easier to solve the problem in the beginning than reworking improvements that are already in place.

2. Renovate community buildings to further their benefit to the public.

County and city officials, along with community members have thoroughly discussed the issues related to the public buildings not being able to meet the needs of the community. The administrative buildings lack the extensive meeting space and security needed to protect employees. The courthouse dates to an era when minimal crime occurred so less space was needed, but as the county has continued to grow, crime has increased too, and additional space is needed within the courtrooms. All public safety facilities need major upkeep to continue their functionality in the community. Basic county or city service buildings are not the only ones that need improvements. The library and Boys and Girls Club need expansion to further meet the demands throughout the community.

Jones County and the City of Gray, being largely considered bedroom communities, have a high demand for services to the citizens living within the community, but, community needs are unable to be met largely because of the current condition of many of the buildings that are used to serve the community.

3. Ensure all public safety training and tools are available to provide the best protection for the community.

The lives and property throughout Jones County and the City of Gray are thoroughly protected by the fire departments and law enforcement agencies like the police department and sheriff's office. With all the possibilities of hindrance on the citizens, everyone protecting the community must be fully trained and proficient on the tools required to perform their job. To provide the utmost protection, both the county and city recognizes a need to provide further training opportunities, guaranteeing everyone has the efficient tools to complete their duties fully.

4. Improve medical access throughout the community.

Currently, there are very few doctor's offices and no hospital or urgent care facility within Jones County. Because Jones County and the City of Gray are located so close to the many medical facilities in Macon-Bibb County, doctors are hesitant to locate within the area. There is a need to attract doctors to the area so that medical treatment can be provided within the community, decreasing the need to reach outside of the county for care.

Ambulatory care is provided within the city and county by The Medical Center Navicent Health EMS. The Jones County Emergency Medical Service provides a Quick Response Unit for the city and county as an additional line of care. There are five units disbursed throughout the county with firefighters who are trained at the level of an Emergency Medical Technician or higher. Throughout the county and city, response times have decreased from 12 minutes to roughly 6 minutes because of the establishment of part-time employees at the stations. Both entities provide the highest level of care and treatment for the citizens and visitors; however, providing temporary treatment and transportation continues to be a great need within the community.

5. Advance activities to provide a clean community.

Measures taken on by the city and county to provide a clean atmosphere include a variety of activities from recycling to roadway maintenance. There is a great need to encourage recycling to reduce the amount of waste accumulated in the landfill. Many of the items that end up in the landfill could serve another role as being reused or used in the manufacturing of an entirely new product. Every resident in the city and county plays a key role in protecting the ground, water, and air of Jones County and the City of Gray from dangers.

There is also a yearning to protect the right of ways of roads and rail. Clearing must continue within the areas to ensure vegetation is not overtaking the property and a prideful community is maintained. Regular maintenance of the roadways is also needed to guarantee scenic quality continues throughout the community.

All efforts to protect and conserve the scenic character of Jones County and the City of Gray is supported by Keep Jones Beautiful. Regularly scheduled clean-ups and education of environmental concerns have greatly impacted the desire of residents to put in place or continue recycling and understanding the impact of household waste on the environment.

Economic Development

Goal


The steering committee defined two goals to tackle Economic Development needs and opportunities:

Attract new industry throughout the community.

Maintain and develop existing industry.

Needs and Opportunities

6. Promote the establishment of industry within Griswoldville Park.



Both Jones County and the City of Gray are communities rich in cultural, recreational and historic resources. The town of Griswoldville was an important industrial center during the Civil War that was home to manufacturing facilities for cotton gins, soap, candles, and eventually, revolvers. As such, the Development Authority of Jones County markets Griswoldville Park, a 972acre development, as a "historic place for industry." Griswoldville Park is a priority for economic development and will be used as the county's first publicly-owned industrial property. Promotion of industry within Griswoldville Park will result in fiscal benefits and economic stability, including but not limited to increased property value,

new tax revenues, and will further the area's commercial development competitive position in the Middle Georgia region.

Jones County has an educated workforce, a local government committed to progress, and a welcoming community affording a high quality of life. The industrial park's primary asset is a convenient location to establish a business:

- On GA Hwy 57/Fall Line Freeway (5 lane access)
- 8.5 miles from I-16
- 6 miles from Macon, Georgia
- 86 miles from Hartsfield-Jackson International Airport in Atlanta, Georgia
- Norfolk Southern rail service along the northern boundary of the development
- Port of Savannah, Georgia access

This location offers a rural atmosphere with proximity to helpful tools required for successful business. A leading site selection consultant recently named Griswoldville Park as a top site in Middle Georgia for manufacturing and distribution. Available utilities for the industrial park are:

- Water: 2.3-million-gallon capacity in storage 2,100 gallons per minute
- Sewage: 10,000 gallons per day available within 9 months, expansion available
- Electricity: Tri-County EMC, on-site
- Natural Gas: Atlanta Gas Light and El Paso Gas, on-site

The park currently has an abundance of space for potential industrial prospects and partnerships. Continued promotion of the Griswoldville Park site via advertisement and setting marketing goals for new business will greatly enhance economic development in the community.

7. Encourage sufficient growth along the Gray Bypass.

After 20 years of planning, the Gray Bypass opened in December 2016, six months ahead of schedule. The 6-mile bypass begins at State Route 18, west of Gray, and travels north around the city, connecting on the east side at State Route 22. The bypass was designed to provide a safer environment for trucks to operate, facilitate the movement of freight more efficiently, and help motorists have a quicker east-west trip though Middle Georgia to/from popular destinations, such as Athens, Georgia and Interstate 20.

Nearby downtown Gray has a few small businesses which attract local shoppers but as traffic patterns change with increased use of the Gray Bypass, encouragement of controlled business growth will enhance economic development. These reasons are examples of why the steering committee believes the Gray Bypass is a terrific location for promotion of new and expanding businesses. In order to achieve this goal, creation of a strategic plan for development of the Gray Bypass area is recommended.

8. Increase law enforcement protection to reduce crime and ultimately encourage economic development.

Increasing law enforcement in Jones County and the City of Gray will result in economic development through secure budget savings, higher revenues, and personal income and wealth gains. The governments believe investment and spending in the community is more likely to expand following crime reduction since residents, businesses, and visitors will feel safer and desire to build lasting financial connections. Added law enforcement protection from the Jones County Sheriff's Office would uphold the mission to "work in partnership with the community, to protect life and property, solve neighborhood problems, enhance the quality of life in our community and, while striving to provide these services to our citizens, meet or exceed the professional standards established for state certified law enforcement agencies." The City of Gray Police Department currently only has three staff members. Changes in law enforcement here, such as adding more police officers and department enlargement, will encourage economic development through a systematic reduction in crime community-wide which will attract and retain new residents, businesses, and visitors.

Financial assistance is needed to support these law enforcement operations since rural police departments often face challenges paying officer salaries, purchasing new gear, and keeping up with technology to ultimately limit officer safety risks and increase effective policing. Obtaining grant funding and additional external financial assistance will present opportunities to hire and train additional law enforcement to meet this economic development need.

Crimes are costly and impose economic costs on the victims who survive, as well as the families of those who lose their lives, in the loss of earnings and associated physical and emotional expenses. Crimes also impose large costs on communities through lower property values, higher insurance premiums, and reduced investment in high-crime areas. These negative economic development influences also distress taxpayers who must bear the financial burden of maintaining the police personnel and operations, courts, jails, and prisons directed towards crime. The Jones County Sheriff's Office and the City of Gray Police Department provided the Crime Statistics Report data in Table 1:

Successful efforts to reduce crime with increased law enforcement can produce extensive economic benefits for law enforcement and taxpayers over the next 20 years in Jones County and the City of Gray.

Housing

Goal

The steering committee created one simple goal to address all housing concerns:

Advocate for the housing types to meet the needs of the community.

Needs and Opportunities

1. Construct affordable and sustainable homes.

The steering committee identified a great need in ensuring contractors are building affordable and sustainable housing options. Many of the houses are being built at such a fast rate that the quality and sustainability to last for 100+ years is diminishing. A majority of the current housing stock for Jones County and the City of Gray were built between 2000 and 2009. Table 2 below provides more information on the current housing stock of Jones County and the City of Gray.

Not only do the homes need to be well built, they also need to be affordable for the citizens of the county or those looking to move to the area. According to American FactFinder only 26.6 percent of the residents of Jones County live and work in the county, 72.7 percent are commuting outside of the county for work. With so many of the residents traveling to work in places like Macon-Bibb County, there is a constant need to compete with the quality and price of homes in Macon-Bibb County. As a bedroom community, there must be plenty of options for all salary classes.

2. Expound upon the housing resources in the community to provide efficient housing opportunities.

Jones County/Gray was designated a Georgia Initiative for Community Housing community in 2010. The program is a collaborative initiative between the Housing and Demographics Research Center at the University of Georgia and the Department of Community Affairs. It is a 3-year program of collaboration and technical assistance with the objective of helping communities create and launch a



locally based plan to meet the housing needs. The developed plan is still being incorporated into the community. Since the community has now graduated from the program there is still a great deal of expertise available to Jones County and the City of Gray to encourage the appropriate housing opportunities to meet the needs of the area.

The GICH committee members are still very active in the community, meeting every month to fulfill their goals. Funds have been received and are regularly being applied for the Community Home Investment Program (CHIP) to better the housing throughout the community.

Natural and Cultural Resources

Goals

In order to appropriately address all of the natural and cultural resource concerns the steering committee established two goals:

Protect and preserve all natural and cultural resources.

Provide sufficient parks and recreation opportunities.

Needs and Opportunities

1. Encourage tourism efforts.

There are a number of tourism oppportunities throughout Jones County and the City of Gray including Old Clinton, Jarrell Plantation, and Griswoldville Battlefield. The creation of additional historical markers like the one seen in Downtown Gray as a tribute to Otis Redding would be excellent contributions to attract visitors to the area. Further evaluations of other tourism possibilities are needed to put in place throughout the community.

The Ocmulgee River is a prized possession of many communities in Middle Georgia. It provides the opportunity to not only serve as a water trail, it also presents the ability to further tourism possibilities. Even though the Ocmulgee River runs along the county's western border, there is

still a large area for the development of landings and parks to encourage visitors to the community. Landings will promote paddling and fishing, while parks will enable residents and visitors to picnic, bird watch, and camp. The establishment of tourism hotspots will ultimately further the economic development of community businesses like restaurants and shops that are already in place.



2. Promote the conservation of historic resources throughout the community.

Jones County and the City of Gray are rich in historical values with notable homes and sites along the March of the Sea Heritage Trail. Each location provides a step back in time for today's generation to better understand where their ancestors came from. In order to continue the preservation of these sites, the steering committee addressed promoting their conservation as a major concern.

Historical societies are key to furthering preservation and the Old Clinton Historical Society is doing its best to continue the community's efforts. Old Clinton Historical Society was formed in 1974 to preserve, protect, and enhance the unique character of the Old Clinton Historical District. Since its establishment, numerous sites have been preserved and events have occurred to further the rich natural history of the area. One site currently being preserved is the Barron-Blair House seen in Figure 1.

3. Develop and expand recreational and greenspace areas.

As communities continue to grow with the development of new housing opportunities, lots are decreasing in size in order to meet the need. With the decrease in lot size, residents are longing for recreational opportunities within the community. Jones County and the City of Gray are aware of the need and are doing all that's possible to increase and expand greenspace.

Numerous activities have been completed to expand the recreational complexes and purchase properties to develop more greenspace. The steering committee noticed that there are still areas

for improvement and saw the importance of addressing the need for additional recreation and greenspace property. Figure 2 provides an example of the types of greenspace needed in Jones County.

Along with the expansion of recreational and greenspace opportunities in the community, there is also a desire to equally publicize its existence with directional signage. Directional signage can be seen throughout Jones County

and the City of Gray but there needs to be some consistence among both local governments for tourists and residents to discover all there is to offer.

Transportation

Goal

The steering committee addressed all transportation issues within one main goal:

Increase mobility and connectivity throughout the community.

Needs and Opportunities

Jones County's closeness to Macon-Bibb County permits its involvement in the long-range transportation planning with the Macon Area Transportation Study (MATS). Because of its participation, greater emphasize has been placed on bridge replacement and road widening to continue the development of Middle Georgia. The introduction to the 2040 Long Range Transportation Plan found in Appendix C provides insight into the planning set forth for future development requirements.

1. Enhance bicycle and pedestrian infrastructure.

Over the past five years, the bicycle community throughout Middle Georgia has grown dramatically. Jones County and the City of Gray are not exempt from the need for a bicycle trail system. With the increase in activity, there is a desire to improve the routes throughout the community. An undesignated route has already been established by the bicyclists within the community along safer roads like Highway 11, which have less truck traffic and easier-to-maneuver terrain.



Some of the paths taken by bicyclists are major travel roads for semi-trucks and speeding vehicles, which puts their lives at risk. The addition of bicycle lanes or the identification of shared roads are greatly needed to protect everyone. Steering committee members have identified major dangers along Highway 49 to not allow bicycle traffic. There is also a great need to include bicycle trails to encourage youth to become proficient bicyclists and provide an additional safe place for bicyclists, like that presented in the planning stages of a Central Georgia Rails to Trails system.

There is also a growing responsibility to provide a connection network for pedestrians throughout downtown and the surrounding neighborhoods. Downtown Gray has adequate sidewalks but there is a need to extend sidewalks to the neighborhoods and schools. There are also a number of residents longing for safer areas to exercise constituting a greater need for sidewalks all throughout the county. Sidewalks are needed for recreation, leisure, and commuting to work.

2. Improve the accessibility of public transportation.

The transit system within Jones County is thoroughly used by residents throughout the unincorporated county and the City of Gray. In order to reach their destination, whether it be the doctor's office or grocery store, the vans are constantly in use. At the moment, there are three vans in use performing over 6,500 trips a year. Table 3 identifies how the trips have fluctuated from 2011 to 2015. The constant use has presented the need to evaluate the effectiveness of adding another van or bus to the route to further meet the needs of the community. There are also only two handicap accessible vans to easily transport residents in wheelchairs. A thorough evaluation is needed to improve the excellent transit systems operation.

Education

Goal

The following goal was found to be sufficient to fulfil all Education needs and opportunities by the steering committee:

Invest in the development of a well-rounded school system.

Needs and Opportunities

1. Continue the efforts creating higher-education courses along with developing skilled trade programs.

Jones County has a premiere public school system known throughout the State of Georgia for its tradition of educational excellence for all students. Using the theme of "Success for All" (see Figure 3 below) is an opportunity for the Jones County Board of Education to continue to make the community a great place to learn and prepare tomorrow's workforce today.

Education is strongly connected to the economic development of the county and city. Therefore, investment in education should focus on the development of not only college preparation material, but the growing skilled trades industry, especially during high school years. Pursuing the following opportunities will help meet this need:

 An annual Chamber of Commerce presentation addressing community involvement to Jones County High School students can introduce students to new industries and current workforce trend skills

- Requesting outreach from the Development Authority of Jones County can help the School System create youth skill development goals to meet both education and industry needs
- Incorporating suggestions from local businesses focused on attracting new industries using land in Jones County (e.g. Griswoldville Park tenants) can be added as a useful component of high school curriculum

2. Establish counseling centers to support the mental health of students.

Local schools should serve as counseling centers for career options, as well as provide youth mental health services. The 2016-2017 school year expanded a partnership with River Edge Behavioral Health's APEX program. Currently, there is a counselor from River Edge Behavioral Health at Gray Station Middle School who can treat students as River Edge Behavioral Health patients. The goal of this program expansion is to place more River Edge Behavioral Health personnel in the Jones County School District so that all students and their families can utilize the services. The Family Counseling Center of Central Georgia opened an office in the City of Gray in 2016 which students and their families can visit. Counseling centers which provide these services as well as place increased focus on adult learning, particularly for post high school residents, are needed in the community. Working with nearby colleges and universities who offer night courses and career training is another opportunity. U.S. Census Bureau, 2011-2015 American Community Survey 5-Year population demographics and Educational Attainment estimates are shown below in Table 4.

3. Build partnerships with local industries to encourage a better understanding of professional requirements.

Jones County High School participates in the Move on When Ready (MOWR, formally called Dual Enrollment) program with Central Georgia Technical College, Middle Georgia State University, and Georgia Military College which allows students to take college courses on or off campus. MOWR program partnerships will help develop, implement, and continually execute a unified plan based on the needs and buy-in of surrounding industries. Forming mentorship and apprenticeship programs is another opportunity for further partnerships between the Jones County school system and local industries, especially healthcare, to meet this need.

The responsible parties for partnership progress over the next 20 years include the Jones County Board of Education, Development Authority of Jones County, Jones County Chamber of Commerce, City of Gray, and Jones County. Providing skills related to the current and upcoming job markets through these partnerships to high school students in this manner will provide a better understanding of professional requirements and make the community more likely to retain a capable workforce in the future.

4. College and Career Academy

A College and Career Academy is defined as a specialized school established by a partnership which demonstrates a collaboration between business, industry, and community stakeholders to advance workforce development between one or more local boards of education, a private individual, a private organization, or a state or local public entity in cooperation with one or more postsecondary institutions. Jones County is in the final stages of planning curriculum for the opening of their College and Career Academy, which is planned as a "school within a school" model. This model will serve to provide a qualified workforce within Jones County and the Middle Georgia region. The academy is scheduled to begin instruction in August 2019. Programs offered will include high levels of collaboration with business and industry regarding both curriculum and Work-Based Learning/Apprenticeship opportunities, a strong presence of the post-secondary partner, Central Georgia Technical College (CGTC), as well as other post-secondary partners of the University System of Georgia. The facility will also be used for adult learning programs in the evening as facilitated by CGTC. A College and Career Academy will offer prospective businesses the opportunity to identify a skilled workforce with potentially high levels of retention, thus stimulating economic development within Jones County. The Jones County Board of Education in collaboration with Jones County Family Education will be applying for grant funding to support the College and Career Academy beginning in 2017.

Intergovernmental Cooperation

Goal

Jones County and the City of Gray have devised one goal to address intergovernmental cooperation needs and opportunities:

Increase cooperation and build trust between the two governments.

Needs and Opportunities

1. Develop a comprehensive policy that emphasizes careful, systematic community planning

Acknowledging the current and future planning needs to recruit industries that can fit effectively into the local economy and redevelop downtown City of Gray as a focal point for people to gather for shopping, dining, socializing, and entertainment requires intergovernmental cooperation. Quarterly meetings between city and county governments are an opportunity to produce a comprehensive policy focused on related community planning benefits for both Jones County and the City of Gray.

2. Preservation of the outlying mini-bedroom communities

As downtown Gray develops, supporting the preservation of mini-bedroom communities is a marketing opportunity to show the connections between rural and urban lifestyles to attract new businesses and residents. Preservation of the outlying mini-bedroom communities, including but not limited to Haddock and the Old Clinton Historic District, is essential to maintaining the overall character of the region. These types of communities have played an important part in Jones County's history, but are currently in need of redevelopment. Mini-bedroom communities located along a major highway coupled with areas containing features, landmarks, civic, or cultural uses of historic interest, are substantial opportunities for infrastructure and design improvements not only for Jones County but for the City of Gray as well.



Capital Improvements Element

Jones County is a local government eligible to charge impact fees. Due to this practice, the county is required to satisfy the Capital Improvements Element (CIE) to remain in compliance with Development Impact Fee Compliance Requirements. Jones County developed their impact fee program to assist in paying for the high costs of expanding public facilities and services to meet the needs of projected growth and to ensure new community development pays a reasonable share of these costs. CIE categories for assessment of impact fees include libraries, parks, and public safety facilities (Emergency Management Agency and Sheriff's Office). The complete CIE Annual Financial Report for Fiscal Year 2016 can be found in Appendix A.

Land Use




Figure 4: Jones County Current Land Use Map with Proposed Changes

Jones County and the City of Gray have zoning regulations in place to assist the communities with protecting character areas and to ensure orderly growth and development. Due to this practice, the county is required to satisfy the land use element. The jurisdictions opted to create a future land use map to serve as a visual guide to future planning. The future land use maps build upon the character areas in the 2006 Joint Comprehensive Plan. Existing land use maps were updated after an analysis of data was obtained from the Jones County Tax Assessor, and a review of each parcel within the county was conducted. After this process was complete, a stakeholder meeting was held to discuss the county's future land use. Individuals present learned about the importance of land use planning and were given the opportunity to note desired changes on the county's and city's land use maps. Photos from the meeting can be seen below in figures 4 and 5.

Following this stakeholder meeting, additional input from the Jones County Planning and Zoning department was used to form the updated existing and future land use maps found in Appendix F and Appendix G.

Over the next 20 years, major changes desired by the steering committee and public include:

- Industrial use of Griswoldville Park
- Mixed Use development in downtown Gray
- Commercial land uses off Gray Bypass
- Road improvements including paving, resurfacing, and sidewalk installation

The categories used to develop the existing and future land use maps are as follows:

• Agriculture/Forestry – fields, lots, pastures, farmsteads, specialty farms, livestock production, agriculture, or commercial timber or pulpwood harvesting. Almost all of the current land found in the eastern half of the county is classified as agriculture/forestry use that includes owners which either themselves or through a lease agreement perform some type of farming and/or silviculture activity. Fewer locations are expected for this type of land use as industry and residences spread throughout the county in the future. The City of Gray currently only has a few tracts of land classified as agriculture/forestry near the downtown area and does expect this to change in the future.

• Commercial – land dedicated to non-industrial business uses, including retail sales, office, service and entertainment facilities, organized into general categories of intensities. Jones County is currently limited to numerous convenience/highway commercial developments and a salvage yard. The City of Gray has a small central business area downtown with several retail and service businesses and offices. Strip commercial development can be found along with heavy commercial along the US-129 corridor west of the downtown area. The steering committee noted potential for new commercial growth on GA-11 between the historic town center and the Jones County Government Center. The expansion of commercial land use to improve economic

development has been considered by the steering committee and has been incorporated into the future land use maps. This is noted with 500-foot commercial buffers along major city thoroughfares, including the Gray Bypass.




Figure 8: Highway 18 Central Recreation Complex Layout

• Park/Recreational/Conservation – land dedicated to active or passive recreation uses. These areas may be either publicly or privately owned and may include playgrounds, public parks, nature preserves, wildlife management areas, national forests, golf courses, recreation centers, or similar uses. The City of Gray currently has one park and the Jones County High School Athletics Department facilities. Current uses in unincorporated Jones County include public and private recreation facilities, golf courses, a private riding stable, a private hunting club, Oconee National Forest, the Cedar Creek Wildlife Management Area, the Piedmont National Wildlife Refuge, the Brender-Hitchiti Experimental Forest and Jarrell Plantation. Figure 8 displays a layout of the Jones County Parks & Recreation Highway 18 Central Recreation Complex where most events are held. Constructing a playground for disabled children will be a Jones County future land use.

• Industrial — manufacturing facilities, processing plants, factories, warehousing and wholesale trade facilities, mining or mineral extraction activities, or other similar uses. There is a vacant warehouse complex located south of the Jones County Government Center on Industrial Boulevard in the City of Gray currently. Existing industrial areas include construction offices and heavy equipment dealers, rock quarry operations, and an Atlanta Gas Light storage area. As mentioned earlier, Griswoldville Park in Jones County is currently being developed with hopes to attract new industry and businesses to the community in the future. A layout of the park can be found below in Figure 9.

• **Public/Institutional** — state, federal or local government uses, and institutional land uses. Schools operated by the Jones County Board of Education that are in the unincorporated area and the Jones County fire stations and solid waste convenience centers are existing land uses. The City of Gray currently has numerous government buildings and complexes, schools, and institutional land uses scattered throughout the city. Both current and future government uses include government building complexes, police and fire stations, libraries, prisons, post offices, schools, military installations, colleges, churches, cemeteries, and hospitals.

• Rural Residential – single-family homes found in rural land use areas. In Jones County, there are scattered single-family site-built residential homes along with manufactured home residential developments. These rural residential areas are found on the outskirts of the city and county near agriculture/forestry lots. Rural residential neighborhoods are more likely to include homes which are older, found on large acreage lots, and on average are valued at \$91,247.

• **Suburban Residential** – *single-family and multi-family dwelling units found in suburban land use areas*. Most of the current suburban residential land use is reflected by a pattern of subdivisions, which generally contain only one, or a limited number of access points. Suburban residential neighborhoods are composed of homes that are newly constructed, have similar building styles, and on average are valued at \$107,003. Future land use within suburban residential areas is expected to grow as industrial and commercial development occurs in the City of Gray.

• **Urban Residential** — single-family and multi-family dwelling units found in urban land use areas. Urban residential homes are found closer to the center of Gray to provide ease of mobility for all of the residents' needs including shopping, entertainment, and work commute. Urban residential neighborhoods have homes found in relatively small acreage lots and on average are valued at \$63,092. The City of Gray has several multifamily unit apartment complexes, including low-income based housing options for residents. In unincorporated Jones County, multi-use family dwellings are not found currently. The steering committee felt Jones County should embrace multi-family

dwelling units in the future to meet the needs of the growing, younger professional residents hoping to live and work in the community.

 Transportation/Communication/Utilities – major transportation routes, public transit stations, power generation plants, railroad facilities, radio towers, telephone switching stations, or other similar uses. The land use of major transportation and communication corridors are identified in the existing and future land use maps. Javors Lucas Lake Reservoir on Town Creek can be found in Jones County but is owned and managed by the Macon Water Authority along with the road, railroad, and utility rights-of-way.

 Undeveloped/Vacant – lots or tracts of land that are served by typical urban public services (water, sewer, etc.) but have not been developed for a specific use or were developed for a specific use that has since been abandoned. The area surrounding downtown Gray is where the largest concentration of vacant lots can be found in Jones County currently. Future land use maps show these undeveloped areas are prime locations for both suburban residential and mixed-use growth. These current sites also provide opportunities for infill development which can stimulate the local economy more efficiently than new greenfield development.

• Mixed-Use – areas of residential and commercial uses on the same land. Presently, there are no mixed-use properties in Jones County or the City of Gray. There is a future land use interest to encourage a more age-friendly and walkable community with the establishment of mixed use development in the heart of downtown Gray. Ideas include converting downtown buildings with second levels into apartments or lofts, or constructing new mixed-use buildings on vacant lots near downtown. A challenge for Jones County and the City of Gray will be finding developers willing to incorporate these types of new development into the downtown area.

Community Work Programs and Reports of Accomplishments

General Policies

The following general policies were initially developed in previous work programs as action items; however, they have all been determined to be too general to warrant inclusion as a specific work program item. Nonetheless, these policies remain important objectives of the communities, and have consequently been listed as general policies for their respective local governments.

Jones County Policy Items

- Maintain membership in Central Georgia Joint Development Authority and partnerships with Georgia Power, Tri-County EMC, Middle Georgia Economic Alliance, and other regional and state economic development support organizations and institutions.
- Offer specific training and education programs targeted to the special needs population to make them marketable for new jobs that are created.
- Promote the best management practices for agricultural and forestry activities benefiting soil
 management through an education program for and dissemination of information to those
 involved in agricultural/forestry practices.
- Participate in the Macon Area Transportation Study.
- Coordinate and cooperate with Norfolk Southern Railroad in the areas of vegetation control and appearance of railroad properties along the scenic byway.

City of Gray Policy Items

- Enforce the City of Gray's policy to provide sound enforcement of erosion and sedimentation laws where development may cause adverse efforts to wetlands, floodplains, and streams
- Coordinate with GDOT and the Jones County Commission on the maintenance of the roads and rights-of-way along the scenic byway corridor, and reducing the impact of any future road improvement on the scenic quality of the byway.
- Coordinate and cooperate with Norfolk Southern Railroad in the areas of vegetation control and appearance of railroad properties along the scenic byway.
- Work with the county to provide zoning and land use planning.
- Determine sites with existing structure for commercial and/or industrial development, which are/or could be served by public services.
- Enforce land development regulations that will encourage: 1) Traditional neighborhood design; and 2) Residential infill development.
- Continue enforcement of existing land development regulations to maintain development patterns in the Suburban Neighborhood Build-out Character Area.
- Enforce land development regulation to eliminate incompatible uses in the neighborhoods within the Traditional Neighborhood Declining Character Area, to properly buffer and screen the borders of these neighborhoods and to reduce and eliminate vehicles parked in the front yards.
- Participate in the Annual Boundary and Annexation Survey to reconcile difference in boundary map.
- Enforce the existing Part V Environmental Criteria ordinances (wetlands, ground water recharge areas, water supply watersheds and river corridor), which include coordination with local, state, and federal agencies.





WHEREAS, it is the objective of the Macon Area Transportation Study (MATS) to maintain a continuing, cooperative and comprehensive transportation planning process which results in plans and programs consistent with comprehensively planned development of the urbanized area; and

WHEREAS, In 2004, the Environmental Protection Agency designated Bibb County and a portion of Monroe County as a non-attainment area for ozone based on the new eight-hour ground level ozone standards and for particulate matter based on the new fine particulate matter standards;

WHEREAS, As a result of the air quality regulations, MATS was required to prepare an air quality conformity determination analysis for its 2040 Long Range Transportation Plan and FY 2014-2017 Transportation Improvement Program.

WHEREAS, The FY 2014-2017 Transportation Improvement Program is a subset of the 2040 Long Range Transportation Plan and therefore satisfies Transportation Conformity requirements for eight-hour ozone and fine particulate matter non-attainment areas; and

NOW, THEREFORE, BE IT RESOLVED that the Conformity Determination Report for the Macon Area Transportation Study is hereby adopted by the MATS Policy Committee.

BE IT FURTHER RESOLVED That the MATS Policy Committee finds that the conformity analysis for the MPO's 2040 Long Range Transportation Plan and FY 2014-2017 Transportation Improvement Program meets all applicable Transportation Conformity guidance allowing for a positive conformity for Ozone and PM 2.5 based on the eight-hour and fine particulate matter standards;

BE IT FURTHER RESOLVED That the MATS Policy Committee, the forum for cooperative transportation decision-making by locally elected officials in the Macon urban area, does hereby approve the final FY 2014-2017 Transportation Improvement Program and 2040 Long Range Transportation Plan.



Chapter 1

Introduction

The Macon Area Transportation Study (MATS) is responsible for conducting the metropolitan transportation planning process for the study area. MATS is comprised of local elected officials and representatives from significant transportation providers and stakeholders, such as the Georgia Department of Transportation, Macon-Bibb County Transit Authority, the Macon-Bibb County Water Authority and interested citizens. Staff from the Macon-Bibb County Planning and Zoning Commission provides the ongoing support needed to execute and coordinate transportation planning in the Macon area. The study area covered by MATS is shown in Figure 1.1. It includes the City of Macon, Payne City, Bibb County and the southern portion of Jones County.

Under previous authorizing legislation, the *Intermodal Surface Transportation Efficiency Act* of 1991 (ISTEA) and the Transportation Equity Act for the 21st Century of 1998 (TEA-21), Congress showed support for metropolitan and statewide transportation planning by emphasizing seven distinct areas which metropolitan planning organizations (MPO's) and states should consider when developing their plans. two transportation acts provided new focus areas or planning factors that were to be incorporated into the transportation planning process. In 2005, the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), added emphasis in two areas: security and the environment. Transportation security is now a stand alone factor, signaling an increase in importance from prior legislation. The factor relating to the environment is expanded, to promote consistency of the long-range transportation plan with planned growth and development. SAFETEA-LU has made these changes to assist in making the transportation planning process more comprehensive and to help ensure that the process better addresses future needs. Since 2005, a number of extensions to SAFETEA-LU were passed. A new surface transportation act MAP-21, a two year bill, has been passed in 2012. MAP-21 basically keeps the provisions of SAFETEA-LU in place but spells out certain modifications. Finalizing the rule making for legislation frequently takes 1 1/2 to 2 years. The MATS 2040 LRTP Update needs final approval by June of 2013.



The MATS Planning Process

MATS was established on February 21, 1964, in response to the Federal Aid Highway Act of 1962. As a result of this act, all urban areas with populations exceeding 50,000 people were required to maintain a "continuing, cooperative, and comprehensive" transportation planning process. The City of Macon, Payne City, Bibb County and the Georgia State Highway Department (now the Georgia Department of Transportation), and the Macon-Bibb County Planning and Zoning Department entered into an agreement to establish the Macon Area Transportation Study in response to the legislation. Over the years, the study area has expanded to include the southern portion of Jones County as a result of the region's growth and the Middle Georgia Regional Commission as an active participant in the planning process.

While the Transportation Improvement Program (TIP) and Long Range Transportation Plan (LRTP) are the best known documents derived from the transportation planning process, the process includes many other activities. Intermittently, transportation studies are done by local governments or transportation providers like Bibb County, the City of Macon, Macon-Bibb County Transit Authority and the Georgia Department of Transportation. Results from these studies become part of the process. Another major planning initiative, the regional land use plan prepared by the Middle Georgia RDC, is coordinated with the metropolitan MATS planning process

Participation from the general public, major stakeholders and elected officials in the transportation planning process is a very important element. This is reflected in the committee structure. From the inception, MATS has always had a Citizens Advisory Committee (CAC), Technical Coordinating Committee (TCC) and a Policy Committee (PC). The CAC is used to gauge community values and public attitudes in the planning process. The TCC brings its technical knowledge to bear in the planning process while the PC is the decision making body that adopts long range transportation plans and transportation improvement programs, as well as policies that help guide their development.

MATS and Federal Transportation Objectives

Goals, Objective, Performance Measures & Strategies

Map 21 requires that each Metropolitan Planning Organization (Macon Area Transportation Study) along with the State Department of Transportation shall work to carry out a statewide transportation planning



process that provides for consideration and implementation of projects and strategies and services that will:

- Support the economic vitality of the United States, the States, non-metropolitan areas and metropolitan
 areas, especially by enabling global competitiveness, productivity, and efficiency;
- Increase the safety of the transportation system for motorized and non-motorized users; Increase the security of the transportation system for motorized and non-motorized users;
- Increase the accessibility and mobility of people and for freight;
- Protect and enhance the environment, promote energy conservation, improve the quality of life, and promote consistency between transportation improvements and State and local planned growth and economic development patterns;
- Enhance the integration and connectivity of the transportation system, across and between modes throughout the State, for people and freight;
- Promote efficient system management and operation; and Emphasize these same planning factors with public transportation.

SAFETEA-LU revised the previous Planning Factors in four specific ways; namely:

- by promoting consistency between transportation improvements with planned growth and development;
- by providing more emphasis upon environmental issues;
- by placing new emphasis upon transportation security; now making it a stand alone factor.; and
- By more strongly emphasizing safety and making it a stand alone planning factor.

Future Changes to MATS

The current Memorandum of Understanding will have to be redone and approved during fiscal year 2014. The newly consolidated government for the City of Macon, Bibb County, & Payne City and the changes to the Bibb County urbanized area boundary which now includes a small portion of Monroe County make this necessary. This will require, also, revision of the by-laws that will change the representation on the MATS committees and deal with other issues that may result from these changes.






