
**WHEREAS**, the update and the adoption of this new Short Term Work Program will insure that the City of Norman Park maintains its Qualified Local Government Status; and,

**WHEREAS**, the Georgia Department of Community Affairs has found the Short Term Work Program to meet the Local Planning Requirements; and,


**WHEREAS**, the City of Norman Park will use the new Short Term Work Program to guide public expenditures and public programs;
