WHEREAS, an Update to the Short Term Work Program component is required in 2012; and

WHEREAS, Pike County and all its municipalities have prepared an Update to the Short Term Work Program, according to *Requirements for a Partial Update to the Local Government Comprehensive Plan March 2007*, as promulgated by the Georgia Department of Community Affairs, Office of Planning and Quality Growth; and

WHEREAS, requirements for a Short Term Work Program Update specify that the Update be submitted for regional and state review; and

WHEREAS, to authorize such review, Resolutions by the Pike County Board of Commissioners and the City Councils of Concord, Meansville, Molena, Williamson and Zebulon are required; and

WHEREAS, the Pike County Planning Commission held an advertised public hearing during its scheduled meeting on July 12, 2012.

WHEREAS, the Pike County Board of Commissioners held an advertised public hearing during its regular meeting on July 31, 2012, and approved the Transmittal Resolution; and

WHEREAS, on August 1, 2012, the 2012 Short Term Work Program Update was submitted to the Three Rivers Regional Commission for review and approval; and

WHEREAS, on August 13, 2012, the Three Rivers Regional Commission determined that the 2012 Short Term Work Program Update met the standards for completeness and advised that the 2012 Update would be forwarded electronically to the Georgia Department of Community Affairs for review and approval; and

WHEREAS, on August 27, 2012, the Georgia Department of Community Affairs found that the 2012 Short Term Work Program Update adequately addresses applicable requirements.
