White County public participation in the STWP update to the comprehensive plan

August 30, 2010 County Commission Work Session announced and discussed the initiation of the County Short Term Work Program Update. The Planning Commission was appointed hold a public hearing and review the STWP update on behalf of the public.

September-November - Planning staff worked with county department updating the STWP.

November 10, 2010 – The White County Chamber of Commerce and the White County Community and Economic Development Department (Planning) held a Visioning Session with over 60 invited community leaders. The STWP update was discussed and input was sought on items, programs and policies to placed in the update. Staff from the Carl Vinson Institute of Government conducted the visioning session.

The draft STWP was completed made available for public review and comment beginning November 29, 2010. The STWP was presented and discussed with the County Commission at the November 29, 2010 work session.

An add was placed in the White County news announcing the draft STWP and inviting the public to reviewing the document and also announced a public hearing for December 6, 2010 at the White County Planning Commission Meeting. The public hearing was held December 6, 2010. The White County Commission adopted a submittal resolution, transmitting the STWP update to the Georgia Mountains Regional Commission and Georgia DCA for review.
