# Requirements for a Partial Update To the Local Government Comprehensive Plan

## March 2007

## Purpose

The purpose of the Partial Update to the Comprehensive Plan is to provide a document for use as a policy guide for local governments in the interim period between Comprehensive Plan Updates. Partial Updates should:

- generate local pride and enthusiasm about the future of the community;
- engage the interest of citizens in implementing the plan; and
- Provide a guide to everyday decision-making for use by local government officials and other community leaders.

When implemented, the resulting plan will help the community address critical issues and opportunities during the interim, transitional period between Comprehensive Plan Updates resulting from a shift in the statewide Comprehensive Plan Recertification Schedule.

### **Required Components**

For local governments updating comprehensive plans prepared under the 2004 and prior Minimum Planning Standards apartial update will require:

- 1. A Quality Community Objectives (QCO) assessment
  - a. Evaluate the communitys current policies, activities, and development patterns for consistency with the Quality Community Objectives (see section 110-12-1-.06(3) of the Local Planning Requirements). An assessment tool useful for this purpose is provided on the Departments website. Use this analysis to identify issues and opportunities for adapting local activities, development patterns and implementation practices to the Quality Community Objectives applicable to your community.

### 2. An analysis of Areas Requiring Special Attention

- b. Evaluate the existing land use patterns and trends within the jurisdiction of the local government (including areas that are likely to be annexed within the planning period) to identify any areas requiring special attention, including:
  - i. Areas of significant natural or cultural resources, particularly where these are likely to be intruded upon or otherwise impacted by development
  - ii. Areas where rapid development or change of land uses is likely to occur

- iii. Areas where the pace of development has and/or may outpace the availability of community facilities and services, including transportation
- iv. Areas in need of redevelopment and/or significant improvements to aesthetics or attractiveness (including strip commercial corridors)
- v. Large abandoned structures or sites, including those that may be environmentally contaminated
- vi. Areas with significant infill development opportunities (scattered vacant sites)
- vii. Areas of significant disinvestment, levels of poverty, and/or unemployment substantially higher than average levels for the community as a whole.
- b. Indicate the identified Areas Requiring Special Attention on a map of the community.
- **3.** Identification of Issues and Opportunities resulting from the QCO assessment and analysis of Areas Requiring Special Attention. Each of these issues or opportunities must be followed up with corresponding implementation measures in the Implementation Program.
- 4. **An updated Implementation Program** with revisions as necessary to address the additional Issues and Opportunities identified above. The updated Implementation Program should include:
  - a. A Short Term Work Program (required) that identifies specific implementation actions the local government, or other entities, intends to take during the interim planning period. This program should include any ordinances, administrative systems (such as site plan review, design review, etc.), community improvements or investments, financing arrangements, or other programs or initiatives to be put in place to implement the plan. The Short Term Work Program must include the following information for each listed activity:
    - i. Brief description of the activity
    - ii. Timeframe for undertaking the activity
    - iii. Responsible party for implementing the activity
    - iv. Estimated cost (if any) of implementing the activity
    - v. Funding source(s), if applicable
  - b. Long-Term and Ongoing Activities (optional): Identify specific longterm or

ongoing implementation activities to be undertaken beyond the interim planning period.

- c. Policies (required): Include any policies the local government will adopt to provide ongoing guidance and direction to local government officials for making decisions consistent with addressing the identified Issues and Opportunities. Refer to recommended policies listed in the State Planning Recommendations for suggestions.
- d. **A Report of Accomplishments (required)** that must identify the current status of each activity in the previous STWP. At a minimum, local governments must indicate activities that:
  - Have been completed;
  - Are currently underway (including a projected completion date);
  - Have been postponed (explaining why); or
  - Have not been accomplished and are no longer activities the local government intends to undertake (explaining why).

### For local governments updating comprehensive plans prepared under the 2005 Local Planning Requirements (current requirements) a partial update will require:

- An evaluation of the plan and the governments progress with implementation of its plan (a Report of Accomplishments)
- An updated QCO Assessment indicating the local government's progress toward achieving the Quality Community Objectives identified as "pursued" in each character area in the Community Agenda
- An updated STWP with revisions as necessary to address issues and opportunities identified above.
- A Report of Accomplishments that must identify the current status of each activity in the previous STWP. At a minimum, local governments must indicate activities that:
  - $\Box$  Have been completed;
  - Are currently underway (including a projected completion date);
  - □ Have been postponed (explaining why); or
  - □ Have not been accomplished and are no longer activities the local government intends to undertake (explaining why).

### **Procedural Requirements**

- 1. **Transmittal and Review of the Partial Update.** Upon completion, the local government must submit its Partial Update to the regional development center for review. The update must be completed well in advance of the local governments recertification date, in order to allow adequate time for review prior to adoption.
  - a. **Required Public Hearing.** The required public hearing must be held once

the draft Partial Update has been made available for public review, but prior to its transmittal to the regional development center. The purpose of this hearing is to brief the community on the identified issues and opportunities (based on the QCO analysis and the identified Areas Requiring Special Attention) that will be addressed through the updated Implementation Program, allow the community an opportunity to comment, and notify the community of when these plan components will be transmitted to the regional development center. Once public comments have been addressed, the Partial Update must be transmitted to the regional development center by resolution of the governing body.

- b. **Completeness Check.** The regional development center shall determine whether the Partial Update is complete, within seven days of receipt. A Partial Update that does not meet the standard for completeness (as determined by the Department) shall be deemed incomplete and shall not be accepted for further review by the regional development center or be forwarded to the Department for review. The regional development center shall notify the local government of its findings regarding the completeness of the submittal and identify items that must be submitted, if any, prior to further processing. The regional development center shall forward a complete submittal to the Department immediately upon making the completeness finding.
- c. **Notification of Interested Parties.** Once the regional development center has determined that the Partial Update is complete, it shall immediately notify any interested parties of the availability of the submittal for review and comment, providing the name of the local government, the general nature of the submittal and a deadline by which comments must be received. At a minimum, interested parties shall include:
  - i. Local governments inside or outside the regional development centers region that are contiguous to the submitting local government, and other local governments that are likely to be affected by the Partial Update
  - ii. Any local authorities, special districts, or other entities identified in evaluating intergovernmental coordination mechanisms and processes (if applicable)
  - iii. Regional development centers that are contiguous to the local government or that are likely to be affected by the Partial Update
  - iv. Affected state agencies (including the Department of Transportation, the Georgia Environmental Facilities Authority, etc.) and the Department.
- d. **Regional Hearing:** Within 25 days after certification of the completeness of the Partial Update the regional development center may (at its sole discretion) conduct a hearing at which any local government, regional development center or other local, regional, or state agency may present its views on the Community Agenda. The rules for conducting such hearings must be adopted by the board of directors of the regional development center and approved by the Department.
- e. **Regional Development Center Review:** The regional development center shall review the Partial Update for potential conflicts with plans of neighboring jurisdictions, opportunities for inter-jurisdictional/regional solutions to common issues, and consistency with the adopted Regional

Agenda for the regional development centers region.

- f. **Department Review:** The Department shall review the Partial Update for compliance with the planning requirements. This review may result in identification of deficiencies that must be satisfactorily resolved by the community in order for the Community Agenda to be found "in compliance with the planning requirements. The Department may also offer advisory comments for improving the Partial Update for consideration by the local government. The Departments findings and recommendations resulting from its review, including advisory comments, shall be transmitted to the regional development center for inclusion in the final report within 35 days after certification of the completeness of the Partial Update.
- g. **Final Report of Findings and Recommendations:** Within 40 days after certification of the completeness of the Partial Update, the regional development center must transmit a final report of its findings and recommendations to the local government and to the Department. The report must include:
  - i. Comments submitted by interested parties that reviewed the Partial Update and (if applicable) a summary of the regional review hearing, detailing any significant issues raised at the hearing
  - ii. The regional development centers findings from its Intergovernmental and Consistency review of the Partial Update and its recommendations for addressing such findings
  - iii. A copy of the Departments findings and recommendations resulting from its review of the Partial Update.
- h. **Petition for Reconsideration:** Within ten days after the regional development centers findings and recommendations are made public, a submitting local government that disagrees with the recommendations may petition the regional development center for a "reconsideration hearing." This hearing shall be scheduled and held by the regional development center within 15 days after receipt of such a request. Within 10 days after the reconsideration hearing, the Department and the regional development center shall either continue or modify the original findings and recommendations and provide written notice of the decision to the submitting local government.
- i. **Conflict Mediation:** Informal or formal mediation of conflicts relating to the Partial Update may be initiated in accordance with the Rules for Mediation of Inter-jurisdictional Conflicts adopted by the Board of Community Affairs.
- j. Adoption of the Partial Update. Once the Partial Update has been found by the Department to be in compliance with the planning requirements, the governing body may adopt the Partial Update with or without any recommendations for improvement included in the Final Report of Findings and Recommendations. However, in no event shall a local government take any official action to adopt a Partial Update prepared in accordance with the planning requirements until 60 days after the Partial Update has been certified by the regional development center as complete. If the local government has petitioned for reconsideration, this mandatory review period shall be 90 days. In order to maintain Qualified Local Government certification, the local government must adopt the approved Partial Update prior to its recertification date, but in no case later than one year after completion of the mandatory review period for the Partial Update.

- k. **Notification of Local Adoption:** Within seven days of local adoption of a Partial Update that has been found by the Department to comply with planning requirements, the local government shall notify the regional development center in writing. Within seven days of receipt of this written notice, the regional development center shall notify the Department that the Partial Update found in compliance with planning requirements has been adopted by the local government.
- I. Qualified Local Government Certification: Once the Department has been notified by the regional development center that a local government has adopted a Partial Update that complies with the planning requirements, the Department may issue a letter certifying this local government as a Qualified Local Government. Qualified Local Government certification shall automatically expire approximately five years from the previous recertification date, unless otherwise specified. To retain Qualified Local Government certification, a local government must remain in compliance with the requirements outlined in these planning requirements and O.C.G.A. 50-8-2(a)(18).
- m. **Publicizing the Partial Update.** Once adopted by the local government, the availability of the Partial Update must be publicized by the local government for public information. This requirement may be met by providing notice in a local newspaper of general circulation identifying where a complete copy of the Partial Update may be reviewed.

#### PURPOSE

The Sumter County Joint Comprehensive Plan Update is a partial update of the current adopted joint comprehensive plan for Sumter County and the Cities of Americus, Andersonville, Desoto, Leslie and Plains Comprehensive Plan 2004-2025. This partial update is prepared under DCA's "Requirements for a Partial Update to the Local Comprehensive Plan: adopted in March, 2007.

As stated in the requirements, the purpose of a partial update is to provide a document for use as a policy guide in the interim period between Comprehensive Plan Updates. The was deemed necessary because of shifts in the Statewide Comprehensive Plan Re-certification Schedule by DCA to first accommodate Census data, and then a more general change of focus in Standards and Procedures for Local Comprehensive Planning adopted in 2005.

This partial update includes a Quality Community Objectives assessment, an analysis of Areas Requiring Special Attention, Identification of Issues and Opportunities, an updated Implementation Program, Short Term Work Programs for each Local Government, and a Report of Accomplishments from each government.

#### INTRODUCTION

Sumter County is strategically located in southwest Georgia and is easily accessible to major southern cities via a splendid highway system. I-75 is located 25 miles east and U.S. Highways 19 & 280 intersect the city. Atlanta, the state capital, is 134 miles north, Columbus is 60 miles northwest, Macon is 70 miles northeast, ands Albany is 35 miles south. The mountains of north Georgia and the beaches of the Atlantic Ocean and Gulf of Mexico are about equal distance from Sumter County.

Recognizing the benefits that would come from a shared vision for their future, Sumter County and the Cities of Americus, Andersonville, Desoto, Leslie and Plains prepared the joint comprehensive plan in compliance with the Georgia Planning Act of 1989. The Sumter County Joint Comprehensive Plan 2004-2024 is intended to serve as a guide for elected officials to control and guide growth and development through the year 2024.

Findings and Analysis in the Stated Issues and Opportunities

*Traditional Neighborhoods:* The Cities of Andersonville, Desoto and Leslie are small cities; however, they are analyzing the necessity of land use ordinances. Sumter County, Americus and Plains prefer to stay with the variance regulations currently in place.

In-fill Development: The Cities and County encourage in-fill development through the support of the Sumter County Chamber of Commerce.

Sense of Place: Sumter County and the Cites within have a strong sense of place. We have much to promote and do so through tourism. Habitat for Humanity headquarters is located here and the Global Village, President Jimmy Carter is from Plains, located in Sumter County. Andersonville is famous for the Andersonville civil war prison. SAM Shortline excursion train runs from Cordele, Ga to Jimmy Carter's Boyhood home in Plains, making stops in Leslie and Americus. Steps have been taken to protect and promote these areas. Sumter County and the Cities will continue to provide new activities to attract tourists to the area.

*Transportation:* City of Americus has public transportation. Americus also has a good system of sidewalks that connect residential areas with commercial areas. All other cities are small towns with many commercial facilities within walking distance from residential areas. Sidewalks and partial sidewalks are provided to reach these commercial destinations in our smaller cities.

Regional Identity: Sumter County and the Cities promote and preserve regional identity.

Heritage Preservation: Sumter County and the Cities within work very hard and are very successful at preserving their Heritage.

*Open Space Preservation:* While green space plans are not in place, all local jurisdictions promote green space areas to prospective developers. The City of Americus has adopted a landscape ordinance which requires that a certain percentage of the parking lots must be landscaped. This was made retroactive and existing shopping center were made to adhere to this ordinance.

Environmental Protection: Sumter county and the cities within make all efforts to protect and preserve their environments

*Growth Patterns:* Sumter County and the City of Americus have hired the Archway Partnership which has successfully assisted other communities in implementing and adhering to their comprehensive plan and community objectives which include land use maps that show designated areas where the local governments would like to see growth and where it is prohibited due to environmental protection activities.

*Appropriate Businesses:* The local governments are currently working with the Archway Partnership to assess Sumter County's strengths to attract the appropriate businesses to the area. Currently, the government knows that a weakness is low education levels. This area is also currently being addressed with the Archway Partnership to improve education levels to be able to compete for better job opportunities.

*Employment Options:* As stated above, employment options are limited due to low education attainment levels in the community. Again, the Archway Partnership is attempting to help turn the community around and increase education levels to create more diverse and better job opportunities. The tornado of 2006 assisted in stiffeling the economy due to the path of destruction it took. In June of 2009, it became common knowledge that the hospital will be rebuilding a new facility in conjunction with Phoebe Putney Medical Center. This facility will be constructed on 45 acres of land and will include doctors offices. Thereby re-creating professional jobs were lost due to the tornado.

*Housing Choices:* All communities are very diverse in the type of housing available. Habitat for Humanity is Based in Americus Georgia which provides lower income families with decent, safe & sanitary (standard) housing purchase options, Koinonia Farms, located in Sumter County also provides lower income standard housing purchase opportunities. Smaller homes are also available throughout the County for lower income and first-time home buyers.

*Educational Opportunities:* Ga Southwestern College and So Ga Tech are located in Sumter County. However, due to the lack of professional and managerial job opportunities, college graduates do not stay in the area. Again, the Archway Partnership is attempting to help turn the community around and increase education levels.

*Governmental Relations:* Sumter County and the Cities within currently work well together to strive toward greater efficiency and less cost to the taxpayer. *For example:* Recreation facilities and activities are provided through Sumter County for both the incorporated and unincorporated areas of the county. Regionally, Sumter County participates in E-911 system that serves Macon, Sumter and Schley Counties.

*Regional Cooperation:* Sumter County works well with the cities within the county. Sumter County works in collaboration with Crisp County protecting the Lake Blackshear area and in collaboration with Macon County preserve the Flint River area.

### NATURAL AND CULTURAL RESOURCES

Specifically, this section will address the following:

- 1. Water Supply Watersheds
  - a. Groundwater Recharge Areas
  - b. Wetlands

- 2. Protected River Corridors

### WATER SUPPLY WATERSHEDS

Water Supply watersheds are defined by DNR as the areas of land upstream of a governmentally owned public drinking water intake. No water supply watersheds are located in Sumter County. Neither is the county located in a water supply watershed.

Approximately 13,000 square miles or 23% of Georgia's land surface have been identified as area where the most significant recharge to aquifers occur. Aquifers are soils or rocks which will yield water to drilled wells. Recharge is the process by which precipitation, primarily in the form of rain, infiltrates soil and rock to add to the amount of water stored in pores and other openings within these pores. With the exception of approximately 9,600 acres near the City of Andersonville, approximately 90% of Sumter County is a significant recharge area. The natural hydrology of the 9,600 acres is that precipitation flows into a nearby creek, thereby not assisting in the recharge of the aquifer.

*Assessment:* While the Cities of Americus, Andersonville, Desoto, Leslie and Plains provide water to their residents via City-wide water systems, persons residing in the unincorporated area of Sumter County install individual drilled wells. As with the City wells, these smaller individual wells are drilled into the aquifer systems. The aquifer systems utilized by Sumter County and the Cities within the county are the Clairborne, Clayton, Cretaceous and the Floridan/Jacksonian.

### **GROUNDWATER RECHARGE AREAS**

A groundwater recharge area is the land where rainfall that infiltrates an aquifer first seeps through the ground. Groundwater recharge areas are among those regions most susceptible to pollution of groundwater due to surface and near surface activities of man.

In addition, groundwater pollution susceptibility mapping is a composite of several factors. These factors include depth of water, net recharge, aquifer media, soils, slopes and hydraulic conductivity. With this in mind, areas in Sumter County likely to have a higher susceptibility to pollution of groundwater due to denser population and activities of man are the Cities of Americus, Andersonville, Desoto, Leslie and Plains.

### (SEE MAPS ON PAGE 24)

*Assessment:* Since residents residing in the unincorporated areas of Sumter County and the Cities of Desoto and leslie rely on individual septic systems, it seems that these tanks would be the single

most potential threat of contamination to the aquifer system. This potential threat, plus the fact that 90% of the county is a significant groundwater recharge area, compliance with chapter 391-3-16-.02, Rules for Environmental Planning Criteria of the Georgia Department of Natural resources are enforced by the Sumter County Health Department. The criteria includes minimum lot sizes for installation of septic tank/drain field systems serving new homes and mobile home parks. Minimum lot sizes are based on the site's pollution susceptibility.

Since agriculture is the county's predominant use, underground fuel storage tanks are regulated by the Georgia Underground Storage Act.

Irrigation systems which draw 100,000 gallons of water or more a day are already regulated to prevent negative system pressure from introducing agriculture chemicals into the aquifer.

There are no industrial wastewater generators in the unincorporated areas of the county. The only known wastewater flow is classified as domestic and is treated by septic tank system. Any industrial wastewater generators locating in the unincorporated areas of Sumter County will be regulated by Environmental Planning Criteria.

### WETLANDS

Wetlands are defined as areas that are inundated or saturated by surface and/or groundwater at a frequency and duration sufficient to support, and under normal circumstances do in fact support, a prevalence of vegetation typically adapted for life in saturated soil conditions. Wetlands range from lakes, ponds, streams, rivers, creeks, swamps, marshes and water bodies that are flooded year round; to those occasionally throughout a year, such as intermittent springs, bogs, springs, bottomland forests, pine flatwoods, wet meadows and sinkholes.

**Sumter County**: Wetlands are common along the Flint and Kinchafoonee rivers. Through the National Wetland Inventory maps and mean sea level elevations, it has been determined that approximately 14 miles or 56% of the river corridors are considered wetlands on the Flint River while 7.5 miles on the Kinchafoonee Creek are considered to be wetlands. (SEE MAP ON PAGE 31)

**Americus**: The National Wetlands Inventory maps were used to prepare the map showing areas to be considered wetland within the City of Americus. This map located in the exhibit section should be considered a general guide to wetland location. (SEE MAP ON PAGE 32)

**Andersonville**: The only identified wetland in the city is on industrial property. The largest portion consisting of 7+ acres is part of an 8 acre industrial waste pond which is located on the southeast city limit. (SEE MAP ON PAGE 33)

**Desoto**: Approximately 10% of the city's total area meets the federal definition of wetland. While most of these areas are concentrated near the incorporated boundaries, several medium to small size patches are located to the west side of the center of town. (SEE MAP ON PAGE 34)

**Leslie**: Approximately 11% or 125 acres of the City of Leslie's total area meets the federal definition of wetland, most of which is seasonally flooded land supporting broad-leaved, deciduous vegetation. Most of the local wetland is located along the bank of Chokee Creek near the northern

and northeastern incorporated limits. There is also an unnamed smaller creek with wetland that branches off Chokee Creek and runs southwest through the city. (SEE MAP ON PAGE 34)

**Plains**: Currently, wetlands identified by the National Wetlands Inventory are located partially within the Martin Luther King Subdivision. The subdivision is developed and the housing units are owned primarily by low & moderate income families. While no structures are located in the wetland, one housing unit adjacent to the wetland has reported drainage problems during heavy rainfalls. There are no additional plans to build near the wetland. (SEE MAP ON PAGE 35)

*Assessment:* Development in wetlands is strictly regulated by federal law. Sumter County and the participating cities of this plan along with the State of Georgia and the federal government have determined that wetlands play a vital role in maintaining water quality as well as providing habitat for plants and animals. Section 404 of the Federal Clean Water Act prohibits the discharge of dredged or fill materials into the waters of the United States, including wetlands, without a permit. In order for anyone interested in dredging and/or filling any wetlands, a permit must be secured for the proposed action from the U.S. Army Corps of Engineers.

### FLOODPLAINS

According to the Flood Insurance Rate Map, while no base elevations have been determined, floodplains have been officially designated and are located adjacent along the Flint River to Lake Blackshear on the eastern border of Sumter County.

*Assessment:* Sumter County and all the cities within the county have been mapped for floodplains. Floodplains are located and protected within the in the city limits of Americus, Andersonville and Leslie. No floodplains are recognized within the city limits of Desoto and Plains. All of Sumter County and the Cities within the county participate in the National Flood Insurance Program. In order to participate, all of the local governments have adopted and enforce a flood protection ordinance in conformance with federal standards.

### PROTECTED RIVER CORRIDORS

There are 25 miles of protected river corridors along Sumter County's corporate boundary. A 14 mile segment of the Flint river runs along Sumter County's northeast side. Along Sumter County's southwest boundary, there is an 11 mile segment of Kinchafoonee Creek. Under the current state definition, there are approximately 300 acres of river corridor in Sumter County; of which 170 acres is adjacent to the Flint River and 130 acres are adjacent to the Kinchafoonee Creek. These protected areas are exclusive to the area between the water's edge and the uppermost part of the river bank. (SEE MAP ON PAGE 41)

*Assessment:* In accordance with the Georgia Mountain and River Corridor Protection Act of 1991, Sumter County has adopted and enforces the minimum protective criteria as set forth by the Act for buffer areas located along the 25 miles of protected river corridors. There are no protected river corridors within any incorporated areas of the county.

#### An Analysis of Areas Requiring Special Attention

#### Existing Land Use Patterns and Trends Likely to be Intruded Upon or Impacted by Development

Sumter County is experiencing the widening to four lanes of Hwy 19 by DOT. An impact on the surrounding land abutting the newly constructed road is anticipated. Once complete, rapid development or changes in land use are likely to occur. One area likely to experience rapid growth is the Hwy 19 and 280 intersection. This intersection is located at the southern tip of the City of Americus and Sumter County. Perry Brothers has started construction of a truck fuel stop that will include an Arby's restaurant on the Southwest corner of this intersection. Also, Sumter Regional Hopital has partnered with Phoebe Putney Regional Medical Center. Together they have purchased 45 acres of land on the northwest corner of Hwy 19 and 280. As of June 2009 the City of Americus is in the process of annexing this property. Water and sewer are currently available at this site. Highway 280 West, which is the responsibility of the Georgia Department of Transportation, is a 4 lane highway with a center turn lane. De-cell lanes will be added as part of the construction process. It is anticipated that doctors offices will also be located at this site. Due to the annexation, the City of Americus will be providing all necessary activities, such as code enforcement, building inspections and traffic control going forward. Due to the rapid growth that is currently taking place at this intersection it is anticipated that there will be future commercial development on Hwy 280 West. As growth occurs on 280 West, the City of Americus will continue to annex and provide all necessary services. It is not anticipated that commercial growth will occur along Hwy 19 North and 19 South due to the proximity of existing residential houseing. However additional residential growth is anticipated in these two areas. Since Community facilities, and services are readily available on Hwy 19, also known as Martin Luther King Jr. Blvd. within the city limits of the City of Americus. Outpacing the availability of community facilities and services is not anticipated. It is likely that the City of Americus will annex around both the above stated areas within the next five years. The Cities of Andersonville, Desoto, Leslie and Plains do not anticipate any rapid growth within the next five years.

#### Areas in Need of Redevelopment and/or Significant Improvements to Aesthetics or Attractiveness

Sumter County: Sumter County does not have any significant abandoned structures or sites.

City of Americus: There are several large abandoned buildings in the City of Americus. Most notably is the vacant Manhatten Shirt Company Building located on Tripp Street. This structure is privately owned and for sale by the owner. Colins-Aikmen is a closed industry that is located in one of the city's industrial parks. This facility is also privately owned.

Harveys Grocery Store combined the two grocery stores located in the City limits of Americus. The Grocery Store Chain rehabilitated a vacant grocery store facility. Thus leaving two vacant large buildings.



City of Andersonville:City of Andersonville does not have any significant abandoned structures or sites. The downtown is mainly geared toward Tourism due to Andersonville State Prison Site and the Prisoners of War Museum located adjacent to the city in Macon County. The city does have individual residences located throughout the city that are in deteriorated and in some cases dilapidated condition. The city should reaffirm and provide stricter building code enforcement. The City should also consider utilizing federal and state funds to assist in providing decent, safe & sanitary standard housing for their low/mod income population that can not afford to make costly repairs themselves.

# Areas in Need of Redevelopment and/or Significant Improvements to Aesthetics or Attractiveness (Continued)

City of Desoto: The downtown area of the City of Desoto is in need of redevelopment. Most of the downtown buildings are abandoned and dilapidated. The City is attempting to clean up the downtown area by removing the dilapidated vacant structures. The City has been very successful in reducing blight in the residential sections of the City. The City has received two separate Block grants to assist low/mod income families to improve living conditions and remove blight. The city is also very proactive in cleaning up vacant lots throughout the city.



- City of Leslie: There are no concentrated area of blight located within the City of Leslie. Much of the original central business district remains vacant. Collectively, the buildings appearances are not offensive from the stand point of structural collapse. The City takes great care in the aesthetics of their downtown due to Sam Shortline excursion train stopping and bringing in tourists. There are blighted lots at scattered locations throughout the city, however. Perhaps the most offensive are residential lots fronting West Wilson Street nearest North Bailey Avenue. The city needs to correct such conditions; however in the absence of any building code enforcement activities and annual budget constraints, the city can not afford the high cost of condemnation and demolition of vacant structures.
- City of Plains: The City of Plains does not have any significant abandoned structures or sites. The City of Plains has a thriving downtown. This is due in part to the Sam Shortline Excursion Train stopping at the rehabilitated depot also known as the Jimmy Carter Campaign Headquarters.

# Areas in Need of Redevelopment and/or Significant Improvements to Aesthetics or Attractiveness (Continued)

Sumter County, and the Cities of Americus have very active code enforcement activities. These activities assist in the elimination of blight in the communities. This includes residential neighborhoods. Sumter County and the Cities of Americus are well aware of the financial constraints on the low/mod income families that generally reside in the deteriorated neighborhoods, therefore Sumter County, and the Cities of Americus have been very active in securing federal and state funds to assist these blighted areas with housing improvement needs. These federal and state funds come in the way of grants, low interest and no interest loans.

The City of Plains contracts with Sumter County to provide building code enforcement. As such, Plains has also been very active in eliminating blight throughout the community. Plains also is very active in providing low/mod income families with housing improvement activities through securing federal and state funds to assist in the blighted areas. These federal and state funds also come in the way of grants, low interest and no interest loans.

Sumter County, the City of Americus and the City of Plains currently have state funds available for low/mod income families. These funds are in the form of Community HOME Investment Program Grant funds through the Georgia Department of Community Affairs. These three communities have made a commitment to continue to seek and receive state and federal funds until substandard housing conditions are eradicated from the communities.

#### Areas of Significant Infill Development Opportunities

The City of Americus encourages in-fill development and actively participates in the restoration of CBD structures. As such, the City enjoys a high level of occupied retail buildings. Vacant areas of opportunities are located mainly in the industrial park area and in the Eastern and Southern sections of the City. The City of Americus does have scattered vacant lots in the residential areas that can be used to construct housing.

The City of Desoto can accommodate and promotes infill development at the underdeveloped sites due to the fact that the City has available water services. There is an abundance of acreage in the community that can be developed for residential and commercial, without disturbing any environmentally sensitive areas.

#### Areas of Significant Infill Development Opportunities (Continued)

Leslie has undeveloped acreage which fronts existing municipal water services, existing infrastructure would support any infill development. There is an abundance of acreage in the community that can be developed, without disturbing any environmentally sensitive areas. Leslie has both an abundance of residential and commercial vacant lots available.



Areas with Significant Infill Development Opportunities

The City of Plains enjoys very little undeveloped acreage within the City limits. The City does have undeveloped vacant lots that has both water and sanitary sewer services available. These vacant lots would be used primarily for residential and are located within the residential areas of the city. None of which are in environmentally sensitive areas in the community.



Several vacant lots are present in the residential areas of the City; however no large sections of vacant property exist.

The City of Andersonville can accommodate and promotes infill development at the underdeveloped sites due to the fact that the City has available water, sanitary sewer services and natural gas services. There is an abundance of acreage in the community that can be developed, without disturbing any environmentally sensitive areas. Andersonville has both an abundance of residential and commercial vacant lots available.

2000 Census data shows us that Sumter County and the all of the Cities within have a disproportionately large segment of households concentrated in the lowest of household income levels. Sumter County as a whole shows that 17.5% of the households make less than \$10,000 annually. Americus has the highest number of households that make less than \$10,000 annually with 22%. The City of Leslie data shows that 20% of the households make an annual income of less than \$10,000. The Cities of Desoto and Plains have 18% making less than \$10,000 annually.

According to county data, as of 2006, Sumter County's drop out rate has decreased to 8.6% in 2006 from 13.1% in 2002. The state dropout percentage rate as of 5/2006 was 5.0. According to the Georgia Department of Education, Sumter County High School North and South did not meet the 2008 Annual Adequate Yearly Progress, nor did the Sumter County Elementary or Middle Schools. The county is experiencing difficulty in retaining quality teachers.
