WHEREAS, the City of Atlanta has prepared a draft of its annual update of the Capital Improvements Program (CIP) and Short Term Work Program (STWP); and

WHEREAS, the draft of the annual update of the Capital Improvements Program (CIP) and Short Term Work Program (STWP), a single planning document entitled 2012-2016 CIP-STWP, has been prepared in accordance with the Development Impact Fee Compliance Requirements and the Minimum Planning Standards and Procedures for Local Comprehensive Planning established by the Georgia Planning Act of 1989; and

WHEREAS, a public hearing for the City of Atlanta's 2012-2016 CIP-STWP and the Community Agenda of the 2011 CDP is scheduled for June 13, 2011 to solicit input for the development of the CIP-STWP and to solicit comments and to present the information in the Community Agenda of the 2011 CDP; and

WHEREAS, the Georgia Department of Community Affairs adopted the Standards and Procedures for Local Comprehensive (Local Planning Requirements) in May 2005; these standards call for the development of a Community Agenda by the City of Atlanta and then require the transmittal of the document to the Atlanta Regional Commission and the Department of Community Affairs for review and comment prior to the adoption of the 2011 Comprehensive Development Plan; and

WHEREAS, the Georgia Department of Community Affairs has mandated that the City of Atlanta adopt a Comprehensive Plan that meets the Standards and Procedures for Local Comprehensive Planning by October 31, 2011; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES:

SECTION 1: That the draft 2012-2016 CIP-STWP, attached hereto as Exhibit "A" and incorporated herein by reference, and that the document entitled City of Atlanta 2011 Comprehensive Development Plan – Community Agenda attached hereto as Exhibit "B" is hereby submitted to the Atlanta Regional Commission and the Georgia Department of Community Affairs for review, as per the requirements of the Georgia Planning Act of 1989.

SECTION 2: That all resolutions and parts of resolution in conflict herewith are hereby repealed to the extent of the conflict.

PLAN REVIEW COMMENTS FROM THE DEPARTMENT OF COMMUNITY AFFAIRS**Advisory Comments on the Community Agenda**

The Community Agenda is an important tool for your community, because it includes the community's vision for the future and its implementation program for achieving this vision and addressing identified issues and opportunities. DCA is vitally interested in insuring that your Community Agenda is a useful tool and guide for achieving your community's desired future. Please consider the following advisory comments prior to adopting your update:

- ▶ The defining narrative for the Parks, Conservation, and Greenspace character area indicates that it includes linear greenspace (e.g. the Beltline parks) but they are not immediately apparent on the detail map of that character area. This may be an issue of map scale (perhaps much of the linear greenspace is too narrow to be readily rendered on the map). Please check to confirm that the GIS layer representing linear greenspace is "turned on" and revise your Community Agenda, if necessary.
- ▶ The Lenox Road corridor, approximately from its intersection with I-85 to around the Lenox MARTA station is mapped as belonging to the "Suburban" character area. That corridor is largely characterized by multi-family residential and single-family/attached residential with some intermittent commercial uses and occasional single-family residential. However, the narrative for that area seems primarily focused upon traditional suburban-style patterns of single-family/detached residential subdivisions. Please reexamine the narrative for this character area and consider revising it to more appropriately address the existing development patterns along the Lenox Road corridor.
- ▶ The Transit Oriented Development character area, unlike other character areas, is not supplemented with a map specifically detailing the locations of those areas. Please consider adding a map of the TOD character areas.

City of Atlanta – Community Agenda Review

Conflicts with neighboring jurisdictions:

There are no apparent conflicts with neighboring jurisdictions.

Potential interjurisdictional/regional solutions:

- The City of Atlanta has two large scale developments that abut and impact these jurisdictions. Fort McPherson and Hartsfield-Jackson International Airport present numerous opportunities and challenges for the region. The City should work with its neighbors to ensure that future planning and development is coordinated in and around these regional assets, and potential impacts are addressed cooperatively.

Internal consistency of planning elements:

The Community Agenda in general appears to be internally consistent.

Consistency with the Regional Development Plan:

The Community Agenda is generally supportive of PLAN 2040 policies & the Unified Growth Policy Map. However, the City should consider well the Community Agenda addresses the PLAN 2040 Local Government Plan Implementation section. ARC staff is available to meet with City staff to discuss the further.


Other Comments:

- The Population section of Issues and Opportunities is not broken into issues and opportunities. To make clear what is being said, this section should be revised to show which category each statement falls under.
- Hartsfield-Jackson International Airport (H-JAIA) is a major asset for the region that has both positive and negative effects. Under the Intergovernmental Coordination section of the Issues and Opportunities, a bullet should be added relating to the coordination needed around the airport between the City of Atlanta, the jurisdictions surrounding the airport, and other state agencies.
- The city limits of Atlanta include a small “island” at H-JAIA. In the character areas map and narrative, this island has not been given a character area designation. Given the character of this small area, it could be designated as industrial or other.
- It is not clear what character area Oakland cemetery and Westview cemetery included in. The Conservation character area states that it includes large cemeteries, but Oakland and Westview are not included on the map and the Historic Areas character area does include Oakland, but it is not clear why Westview is not included.
- The Community Agenda includes several references to the Connect Atlanta Plan as well as other relevant plan. The City should consider including relevant text and/or maps or, if this plan will be available digitally, then links to these documents could be included. This will help the reader understand what is being discussed.
- The character areas section includes Industrial areas and identifies plans that should be considered. ARC’s Freight Mobility Plan and ASTROMaP should be included.

The City is encouraged to revise the Community Agenda to address these recommendations. ARC staff is available to discuss these findings with City of Atlanta staff at their request. To schedule a meeting or for further assistance, please contact Jon Tuley at 404-463-3307.




Existing Land Use Map Northwest


STUDY AREA #1 - NORTHWEST
