The Plan has been approved by each government for submittal to the Georgia Depanment of Community Affairs and is currently under review for meeting the State's Minimum Planning Standards and Procedures. The Plan consists of agreed upon land use objectives and policies and a single Future Land Use Map for the entire county, which reflects the desires of each governing authority.
