For information, the Cities of Dalton, and Varnell and Whitfield County have adopted a Unified Zoning Ordinance. Whitfield County and the Cities of Dalton, Tunnel Hill, and Varnell jointly prepared a new Joint Comprehensive Plan for the years 2018 - 2022. The Plan has been approved by each government for submittal to the Georgia Department of Community Affairs and is currently under review for meeting the State's Minimum Planning Standards and Procedures. The Plan consists of agreed upon land use objectives and policies and a single Future Land Use Map for the entire county, which reflects the desires of each governing authority.
