

# IBC Task Force Meeting Minutes 12/14/2017

MEETING BEGINS 10:00 Am

## WELCOME

- Ted Miltiades, DCA Director of Codes and Research welcomed everyone and introductions were made around the room of task force members, DCA staff, interested parties and guests.

## CHARGE TO THE TASK GROUP

- Ted Miltiades administered the CHARGE to the Task Force.

## DISCUSSION OF SCOPE OF WORK

- There was one proposed code amendment to the 2012 and 2018 IBC which was received by the DCA deadline of December 15th which is assigned to be reviewed by the task force regarding IBC Chapter 18, Section 1810.3.1.5 'Helical piles'.
- The deadline for any proposed code amendments from outside proponents was set as January 11, 2018. All proposed amendments must be submitted on a DCA code amendment form.

## PRESENTATION

- Tom Allen, ICC regional representative made a presentation on the "Significant Changes between the 2012 and the 2018 IBC".

## CHAPTER REVIEW ASSIGNMENTS

- Three member teams were assigned to review the 36 chapters and 14 appendices. Each team leader is responsible for reporting back their findings and recommendations to the main body.
- Preliminary review of Chapters 1 through 10 was started and the significant changes to each of the individual chapters were reviewed and discussed by the task force. No action was taken.
- The task force will pick up the chapter review where it left off at the next task force meeting.
- Lunch was provided for the task force members and DCA staff.
