2018 International Fuel Gas Code Task Force First Meeting January 23, 2019 Minutes

MEETING BEGINS – 10:00 AM

WELCOME

- Ted Miltiades, DCA Director of Codes and Industrialized Buildings welcomed everyone and introductions were made around the room of task force members, DCA staff, interested parties, and guests.
- Ted Miltiades administered the CHARGE to the Task Force
- Ted Miltiades asked the Task Force members to read and sign a Disclosure Statement
- Ted Miltiades turned the meeting over to Chairman Windell Peters

DISCUSSION OF SCOPE OF WORK

- Windell Peters explained the scope of the work to the Task Force which included the meeting schedule, review of the new code editions and any proposed new and existing amendments. The task force will meet for a total of 3 planned meetings with a 4th meeting scheduled should the task force deem it necessary. A preliminary task force report will be made at the February SCAC meeting. A final task force report with recommendations will be made at the July SCAC meeting. (see attached Meeting Schedule)
- Each of the 2018 IFGC chapters were assigned to a team leader with a supporting team member. Each team will review the significant code changes, any proposed new code amendments, and any existing 2014 and 2015 Georgia amendments which may be carried forward. (see 2018 IFGC Proposed Amendment Report in 2018 International Fuel Gas Code Folder)
- Windell Peters set the deadline for amendments from outside proponents to be February 4, 2019

PRESENTATION

- Jim Cika, ICC Director of Government Relations, made a presentation on the highlights of the significant changes in the 2012 to 2015 to 2018 IFGC code editions. He answered any technical code questions regarding the changes from the task force members and audience.
- Jonathan Sargeant, Manager of Codes and Standards at Omega Flex, Inc. made a presentation for his proposed amendment to the 2018 IFGC. Mr. Sargeant's amendment proposes that the Department of Community Affairs change the reference standard "LC 1/CSA 6.26—2013" in Chapter 8 of the IFGC to the current standard "LC 1/CSA 6.26—2018". Mr. Sargeant explains that LC 1/6.26—2013 does not address arc-resistant CSST which has been added to the 2018 IFGC. Following the presentation, the chairman invited the task force to make a motion on the proposed amendment.
 - o The proposed amendment was approved unanimously (see attached chart)

AMENDMENT REVIEW (see attached amendment report)

The task force began chapter review by reviewing the Georgia amendments to the 2012 IFGC.

- Chapter 1 'Scope and Administration' Jerry Wainright, Team 1 Leader
 - Item 1 was recommended to be carried forward as written
- Chapter 2 'Definitions' Jerry Wainright, Team 1 Leader
 - o Item 2 was recommended to be carried forward as written
- Chapter 3 'General Regulations' Joel Rodriguez, Team 2 Leader
 - o Item 3 was recommended to be carried forward with the following revisions:
 - Change the reference in '300.1.2 Piping systems' from Section 402.6 of the IFGC to Section 402.7 to reflect a change in the section number of the 2018 edition
 - Item 4 was not recommended to be carried forward
 - Reasoning: It was the recommendation of the task force to not exclude the provisions of the IFGC and references to the IBC regarding the mitigation of damage by floods. The failure of the State of Georgia to enforce these provisions of the national code may affect disaster relief funds that would be disbursed to Georgia communities affected by flooding.
 - Item 5 was not recommended to be carried forward
 - Reasoning: The creation of the Section 307.6 'Condensate pumps' in the 2018
 IFGC includes the language from the Georgia amendment and makes the Georgia amendment redundant.
 - Item 6 was not recommended to be carried forward
 - Reasoning: The language in amendment to the 2012 IFGC is now included in the 2018 IFGC
- Chapter 4 'Piping Installations' Andrea Papageorge, Team 3 Leader
 - Item 7 was not recommended to be carried forward
 - Reasoning: The language in amendment to the 2012 IFGC is now included in the 2018 IFGC
 - Item 8 was not recommended to be carried forward
 - Reasoning: The language in amendment to the 2012 IFGC is now included in the 2018 IFGC
 - Item 9 was recommended to be carried forward
 - Item 10 was not recommended to be carried forward
 - Reasoning: The language in amendment to the 2012 IFGC is now included in the 2018 IFGC
 - A motion was made by Andrea Papageorge to delete Section 404.11.1
 'Galvanizing' and renumber subsequent sections. Paul Laney 2nd. Passes unanimously
 - o Item 11 was recommended to be carried forward
 - o Item 12 was recommended to be carried forward
 - o Item 13 was not recommended to be carried forward
 - o Item 14 was recommended to be carried forward with the following revisions:
 - Add the language 'as amended and adopted' before 'of the Georgia Safety Fire Commissioner's Office'
 - Item 15 was recommended to be carried forward with the following revisions:
 - Add the language 'as amended and adopted' before 'of the Georgia Safety Fire Commissioner's Office'

 - Reasoning: The language in amendment to the 2012 IFGC is now included in the 2018 IFGC
