Minutes

MEETING BEGINS – 10:00 AM

WELCOME

- Billy Guinade, Chairman of the Task Force welcomed everyone and introductions were made around the room of task force members, DCA staff, interested parties, and guests.
- Billy Guinade asked the task force members to review the minutes from the previous meeting held on January 8, 2019.
 - Jake Hill pointed out a mistake on Item 44 should be reversed. Jake didn't make the motion on Item 44. Motion was made by Josh Roth (first) and Ron Anderson (second) to approve the minutes as revised. The motion was approved unanimously.

2018 IPC PROPOSED AMENDMENTS - ITEMS TO BE REVISTED (see attached amendment report)

- Item 35, Section 401.10 'Small Occupancies' was recommended to be revised change the occupant load from 15 to 25 or fewer to correspond with the current GA Amendments.
- Item 46, Table 506 'Minimum Capacities for Residential Occupancies' was recommended to be approved as revised by Ron Anderson.
- Item 80, Section 1003.4 Oil separators required was revisited. DCA staff confirmed with SFM the previous amendment is now covered by the 2018 IPC and does not need to be carried forward.

PRESENTATION: 2018 ISPSC Significant Code Changes by Jim Sika, ICC Plumbing and Mechanical Staff

2018 ISPSC REVIEW – CHAPTER ASSIGNMENTS (see attached amendment report)

Chapter 1, 'Scope and Administration'

- Item 1, 'Scope'. The scope in preface of the current 2014 GA amendments was recommended to be carry forward as written.
- Item 2, Chapter 1 was recommended to be deleted and remain in the code as a reference and guide for local governments in development of their own administrative procedures.

Chapter 2 'Definitions'

- No changes were proposed for Chapter 2. Motion was made by Josh Roth (first) and Ron Anderson (second) to recommended Chapter 2 for approval as written. The motion passed.

Chapter 3, 'General Compliance'

- Item 3, Section 101.2 'Scope' and all of Section 102 'Applicability' was recommended to be included in a new Section 300 'Scope' which was approved.
- Item 4, Section 304 'Flood Hazard Areas' was recommended not to be carried forward.
- Section 314.5 Equalizers on skimmers was discussed and it was initially decided to delete this section, but the decision was later reversed to leave Section 3104.5 as written in the code.
- Motion was made by Josh Roth (first) and Jake Hill (second) to approve Chapter 3 as amended. The motion passed

Chapter 4, 'Public Swimming Pools'

- Maurice Redmond made a report on Chapter 4 and the GA Department of Health Rules and Regulations which are required for Public Pools. He also explained the State County Map of those local jurisdictions which have their own public pool regulations effective as of December 31, 2000. Blue counties are bound by the State rules and White counties have their own local regulations for Public Swimming Pools.
- There were no changes recommended to Chapter 4. Motion was made by Maurice Redmond (first) and Jake Hill (second) to approve Chapter 4 as written. The motion passed unanimously.

Chapter 5, 'Public Spas and Public Exercise Spas.'

- There were no recommended changes to Chapter 5. Motion was made by Maurice Redmond (first) and Jake Hill (second) to approve Chapter 4 as written. The motion passed unanimously.

Chapter 6, 'Aquatic Recreation Facilities.' was recommended to be approved as written.

- There were no recommended changes to Chapter 5. Motion was made by Maurice Redmond (first) and Jake Hill (second) to approve Chapter 4 as written. The motion passed unanimously.

Chapter 7, 'Onground Storable Residential Swimming Pools'

- Item 5 'Figure 702.2' for Type A and Type B Ladders was recommended to carry forward as written.
- There were no other changes recommended for Chapter 7. Motion was made by Shawn Still (first) and Jake Hill (second) to approve Chapter 7 amended. The motion passed unanimously.

Chapter 8, 'Permanent Inground Residential Swimming Pools.'

- There were no changes recommended for Chapter 8. Motion was made by Shawn Still (first) and Jake Hill (second) to approve Chapter 8 as written. The motion passed unanimously.

Chapter 9, 'Permanent Residential Spas and Permanent Residential Exercise Spas.'

- There were no changes recommend for Chapter 9. Motion was made by Shawn Still (first) and Jake Hill (second) to approve Chapter 9 as written. The motion passed unanimously.

Chapter 10, 'Portable Residential Spas and Portable Residential Exercise Spas'

- There were no changes recommend for Chapter 10. Motion was made by Shawn Still (first) and Jake Hill (second) to approve Chapter 10 as written. The motion passed unanimously.

Chapter 11 'Referenced Standards.'

- There were no changes recommend for Chapter 11. Motion was made by Shawn Still (first) and Jake Hill (second) to approve Chapter 11 as written. The motion passed unanimously.

Appendices A-D

- Item 6, Corresponding Amendment to 2012 IRC Section AG 105.2 'Outdoor Swimming pool chain link fence was recommended to not be carried forward.
- Item 7, Corresponding Amendment to 2012 IBC Section 3109.4.1.5 'Chain link Dimensions' was recommended to not be carried forward.
- Motion was made by Josh Roth (first) and Shawn Still (second) to approve Appendices A-D as written. The motion passed unanimously.

- Motion was made by Josh Roth (first) and Shawn Still (second) to approve the 2018 ISPSC as amended. The motion passed unanimously.
