2018 International Residential Code Task Force

First Meeting January 10, 2018 10:30 A.M.

WELCOME

Ted Miltiades, DCA Director of Codes and Industrialized Buildings, called the meeting to order at 10:30 a.m. by welcoming and introducing Chairman, Vice Chairman, Task Force members, Department of Community Affairs (DCA) staff and all guests.

- It was announced that the deadline for proposed amendments submitted by parties outside the task force is January 30th, 2018 as noted on the meeting agenda.

• Recommendations were made to bring forward and delete amendments to Chapter 3 and Chapter 5 in the current Georgia State Amendments. All recommendations will be presented to the task force in an amendment report available at the third meeting.

- A motion was made by Josh Roth and seconded by Ryan Taylor to delete the Exception to R311.7.11 Alternating tread devices. Motion Carried Unanimously.
- A motion was made by Neal Davis and seconded by Josh Roth to bring forward the amendment to delete R312.2 'Window fall protection' in the current Georgia State Amendments. Motion Carried Unanimously.
- A motion was made by Neal Davis and seconded by Tim Williams to strike any reference to "NFPA 72" from R314.1 'General' and R314.7.1 'General'. Motion Carried Unanimously.
- A motion was made by Josh Roth and seconded by Ryan Taylor to revise R315.2.1 'New Construction' to read "For new construction, carbon monoxide alarms shall be provided in dwelling units." and delete both conditions listed. Motion Carried Unanimously.

PROPOSED AMENDMENT TESTIMONY

• Andrew Carter with Cantsink provided testimony and handed out material in support of his amendment submitted to R404.6 regarding helical piles. No vote was taken by the committee and copies of the handouts are available upon request.
