Renewing PSH & PH project applications were scored & ranked using the same scoring criteria. Projects were then grouped and ranked in the following order: Group 1 -Renewing PSH & PH projects currently housing people without significant capacity or performance issues, HMIS, Coord Assessment projects, & operational renewal projects transferred in the last 12-months; Group 2 - New RRH and PSH awarded in 2019 competition (not operational for a year); Group 3 - New projects designated to utilize reallocated funds; Group 4 - Renewal PSH and RRH determined to be significantly underperforming or operating under capacity; Group 5 - New CoC PH Bonus; Group 6 - New DV Bonus housing projects; & Group 7 - New DV Bonus SSO-CE. Higher scoring projects were placed in the CoC's Tier 1 representing the top 100% of the Annual Renewal Amount (ARA) minus the reallocated amount. Group 3 and Group 4 projects that scored lower fell into the bottom of the of the BoS CoC's ARA (a/k/a Annual Renewal Demand or ARD).
